# FRINGE DEMS **WANT BLOOD**

## 55% of left-leaning Americans think political violence is acceptable

(The American Spectator) - Several House Democrats are warning that the Democrat base has become increasingly radicalized in its resistance to the Trump administration. Democrat politicians are frightened by many of their leftist constituents whose growing anger has "morphed into a disregard for American institutions, political traditions and even the rule of law," according to a new report from Axios.

In the eyes of some liberal voters, Democrats aren't doing enough to counter the president's agenda. One House representative said, "Our own base is telling us that what we're doing is not good enough .. [that] there needs to be blood to grab the attention of the press and the public." Some have suggested that they need to "be willing to get shot" visiting ICE facilities or federal agencies.



Data confirms that the Left has become increasingly warm to the idea of violence. One recent report found that 55 percent of left-leaning Americans thought political violence could be acceptable, responding

that "it would be at least somewhat justified" to murder Trump.







#### **Executive Director's Report**

#### How our PICA gun ban challenge will likely be decided by next summer

Obviously we aren't having much success legislatively in the Land of Lincoln. The radicals in Springfield continue to legislate poor public policy and have singled out gun owners for new exceptions to the due process provisions the Constitution demands. But when state and federal courts employ "interest balancing tests" so common in recent history to legitimize those unconstitutional laws, there's not a lot we can do about it.

Fortunately, it seems like the US Supreme Court has begun taking some of these judicial insurrectionists to task, slapping down their bad decisions and their ability to issue national injunctions to benefit their pet causes.

The Supreme Court's actions have tempered some federal court judges, but not all. But it's progress.

Not only that, as they say, elections have consequences.

There's a new sheriff in town and his name is Donald Trump.

President Trump has appointed some solid people to key posts in his administration. People like Harmeet Dhillon, the new head of the US Department of Justice's Civil Rights Division.

When she laid down the law and told the attorneys there that they would enforce the rule of law, not their pet "woke" causes, most of them lost their marbles and ultimately resigned. A few tried malicious compliance and were fired or sent to the bureaucratic equivalent of a post to Siberia where they could answer phone calls.

In their place, Dhillon hired a whole new crop of freedom-loving, American patriots to carry out the rule of law on civil rights.

One of the new Civil Rights Division's first high-profile acts was to submit a "friend of the court" brief in our challenge to Pritzker's beloved "Protect Illinois Communities Act" gun and magazine ban. The US Government, through the Department of Justice, came down firmly on our side with the Seventh Circuit Court of Appeals, saying the PICA gun ban was patently unconstitutional. The DOJ urged the Seventh Circuit not to screw up their decision.

I'm fairly certain we will win at the three-judge panel

Kwame Raoul will then ask for an en banc review where all of the active judges on the Seventh Circuit will look at the case and see if they want to second-guess the three-judge panel's deci-

Before this bunker-busting brief hit, I was equally certain we would lose that en banc review by a vote or two. Now, with the DOJ's involvement, I think we stand a fair chance of winning by a vote or two. That would mark the end of the gun ban.

Then, almost like a Biblical prophesy or miracle, hundreds of thousands of guns will wash up on the beaches and shores of all those bodies of water where tragic boating accidents happened upon the law's passage.

Man still faces charges for carrying while intoxicated & DUI

#### Murder charges declined; SA cites self-defense in Springfield road rage homicide case

Springfield, IL (State Journal-Register) — First-degree murder charges will not be pursued against a Rochester man who was initially arrested for the crime after an April 1 shooting.

Sangamon County State's Attorney John Milhiser said no criminal charges will be filed for the shooting death of Jerald P. Fahey, 51, of Springfield, because Nicholas J. Kammueller, 46, of Rochester, was defending himself.

The shooting happened after Fahey entered Kammueller's vehicle, started beating him and threatened to kill him, Milhiser said, which took place near the drive thru area of the McDonald's at 2100 N. Dirksen Parkway.

Milhiser cited evidence including video surveillance.

Officers arrested Kammueller at the time for first-degree murder, driving under the influence, carrying a concealed firearm while intoxicated, and aggravated discharge of a firearm.

But Kammueller acted in self-defense. Milhiser said, citing Illinois law that says a person can defend themselves and can use deadly force if they reasonably believe that deadly force will be used against them - or during the course of a forcible felony.

On the concealed carry charge, Milhiser said Kammueller had a valid Firearm Owners Identification card, but Illinois law does not allow for carrying a firearm while intoxicated.

Charges are pending for Kammueller for driving under the influence and for carrying a firearm with a concealed carry license while intoxicated.

Kammueller's next court date is scheduled for Aug. 18.

Milhiser spoke with family members of Fahey and explained why he would not be filing criminal charges, he said.

"This is a tragic case where someone lost their life," Milhiser said about the case.

What led to the shooting? A traffic collision ultimately led to the shooting.

An officer arrived

at a traffic collision where people were hurt in the 2000 block of North Dirksen Parkway around 9:15 p.m., said Springfield Police Deputy Chief Sara Pickford in a news release on April 2.

Upon arrival, police heard several gunshots, and witnesses told officers that a man had just been shot near the drivethrough area of the nearby McDonald's.

Officers found Fahey on the ground who was shot multiple times. He was taken to HSHS St. John's Hospital but did not

## Oral Arguments set for September 22 in PICA gun and mag ban case

(GSL) – The Seventh Circuit US Court of Appeals set oral arguments in the consolidated *Barnett* challenge to the PICA gun and mag ban for September 22nd. The public will be able to watch the hearing via live-stream.

The three judge panel will decide the case following the oral arguments they will likely decide in our favor. Illinois Attorney General will then ask the court for an en banc review. That's where all of the active judges (roughly 13) take a look at the case and see if they

Given the "friend of the court" brief filed by the US Department of Justice's Civil Rights Division, GSL's Executive Director John Boch

believes that the en banc review will either be denied or come down in the favor of gun owners and freedom. At that point, the PICA law will be dead.

There's no way Illinois AG Kwame Raoul appeals it to the US Supreme Court. If he lost there it would stand as nationwide precedent.

What's the timeline? Probably about this time next summer give or take a couple of months. Just in time for the midterm election campaigns at that.



#### Chicago defending it's 'Murder City USA' title

(GSL) - Over the Fourth of July weekend, Chicago has continued to keep its title of "World's Largest Shooting Gallery" well-padded with murders and shootings. As of this morning (Monday) ABC News and the Chicago Police stats for the July 4th weekend currently shows 55 humans were shot and 8 killed in that 72-hour window.

Temperatures were hot and the shooters were hotter. It should have been a patriotic holiday, not an ER room triage event. The violence spanned multiple neighborhoods and included several mass shootings, with victims ranging in age from teenagers to those in their 50s.

The biggest event occurred late Wednesday night in the River North neighborhood (outside the July 4th stats), where a drive-by shooting outside Artis Restaurant and Lounge claimed four lives and injured 14 others. The attack took place during an album release party for local rapper Mello Buckzz. Two men walked up and started shooting into a crowd. Unsurprisingly, no

one is in custody.

It's the second "mass" shooting at that establishment in three years.

Elsewhere in the city, shootings erupted in neighborhoods like Back of the Yards, Little Village, and West Englewood. In one case, seven people were shot in a single incident on South Justine Street, including both men and women between the ages of 21 and 42.

Another shooting near the Cook County Courthouse left four men hospitalized, three of them in critical condition. These incidents just highlight the widespread violence prevalent in the city despite what the Mayor may say about "Crime is down in 2025."

Our heroes at Hey Jackass.com show the first 6 days of July has 74 wounded, 14 killed and 88 total people shot. Seems like a lot if you ask me, and hard to argue it is "less."

#### Pritzker signs bill to lengthen Prisoner Review Board Member terms to eight years

(The Center Square) – Changes are coming to the Illinois Prisoner Review Board that some Republicans say shields members appointed by the governor from oversight.

The PRB conducts parole and release revocation hearings, imposes release conditions, manages good conduct credits, and makes recommendations regarding executive clemency. Members of the board are appointed by the governor and approved by the Senate.

Senate Bill 19 was signed by Gov. J.B. Pritzker Friday...

Before it passed in the Senate, state Sen. Steve McClure, R-Springfield, said SB 19 extending the PRB members' terms from six to eight years has the governor's fingerprints on it...

Last year, in the wake of an early parolee who was arrested for allegedly stabbing his ex-girlfriend and killing an 11-year-old boy the day after his release, Republicans called for changes to the PRB.

In a murder that garnered national attention, Crosetti Brand is accused of attacking his exgirlfriend and her son with a knife, killing the 11-year-old just a day after being set free. The attack occurred just hours before an order of protection hearing against Brand was to be held. PRB Chairman Donald Shelter and board member LeAnn Miller stepped down in the wake of the deadly attack.

After SB 19 was signed by Pritzker Friday, McClure and state Sen. Jason Plummer, R-Edwardsville, released a joint statement saying the enactment of the bill is driven by the governor to keep activists happy rather than prioritize the safety of constituents.

Firearm suppressors used to be regulated under the 1934 National Firearms Act (NFA) and the Gun Control Act (GCA) of 1968, enforced by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF). The provision in the new law would remove them from the NFA but keep them under the GCA.

Illinois currently bans ownership of firearm suppressors, one of only a handful of states to do so. A federal lawsuit, Anderson v. Raoul, challenges the ban as unconstitutional, and is awaiting a ruling after being delayed pending a related case.

#### **US patriotism among Dems crashes** as Marxist demands grow louder

These news findings are from a June 2-19 Gallup poll that shows a recordlow 58% of U.S. adults are "Extremely/Very proud", 41% "Extremely proud," and 17% "Very proud" to be an American.

The drop in national pride has been led mainly by Democrats, with only 36% now saying they are extremely or very proud to be American, down from 62% a year ago. Pride among independents has also fallen to a new low of 53%, a seven-point decline from

last year. In contrast, Republicans' national pride has increased, with 92% expressing strong pride last month.

The broader picture of the Democratic Party's mindset can be summed up by leftist political commentator Elie Mystal, who openly despises America and, earlier this week. called for the international community to sanction the country. It's worth noting that Mystal has deep connections to the Democratic Party's NGO network... go figure.

While other Democrats are openly promoting communism, and this is an actual quote: "The end goal is seizing the means of production.

And yet, many of the Democrats who vocally denounce America have no intention of leaving. Why? Because their goal isn't to leave-it's to dismantle the capitalist system. They aim to collapse capitalism and replace it with a socialist reconstruction of the nation, consolidating control over land and power.

#### "So you're telling me there's a chance?"

They are POWs and MIAs: Prisoners of War and Missing in Action. In the United States, Prisoners of War are our brothers and sisters, who were captured by the enemy - pretty straight forward. Missing in action, on the other hand, may be the most misunderstood casualty classification, as it can mean several different things. A soldier initially listed MIA, may have been killed, or captured by the enemy, or deserted. It can be transitory; a soldier may at first be declared MIA, but later the enemy announces that they have the soldier as a POW, and that could take a long time, or never come at all. It can even occur when a wounded, unconscious soldier, who has lost his dog tags, is evacuated to an American medical facility. His identity is temporarily unknown, and if his unit does not know what happened to him, they report him as MIA, even though he really isn't.

At the end of World War II, 79,000 Americans remained unaccounted for; the bulk MIA. Many MIA had, in fact, been killed, but their remains never recovered. Knowing that each family must come to closure, after the war, the US military waited one year after the soldier was first declared missing in action, and, if remains still had not been found, the War Department declared that he was deceased, in part because both Germany and Japan were occupied and their POW camps no longer existed. Many families disagreed and spent decades hoping their loved one would someday walk through their door.

The War Department is now the Department of Defense. Within DoD, the Defense Prisoner of War/Missing Personnel Office (DPMO) was established to manage prisoner of war/missing in action personnel affairs. In 2015, DPMO, and the Joint POW/MIA Accounting Command, merged into the new Defense POW/MIA Accounting Agency (DPAA) to streamline accounting for missing US personnel from World War II, Korea, Vietnam, Cold War, Gulf Wars, to recent conflicts.

They do an outstanding job identifying remains of US military personnel around the world, using DNA and other cutting-edge forensic technology, so that many families can finally reach closure. Part of the reason for that great work is that concerning actual identification of remains, politics takes a back seat. However, coming to grips concerning US military personnel, captured by America's enemies, but who have never returned home and may still be alive, is riddled with inertia and political roadblocks. In fact, the way that America has dealt with her recent POWs is enough to make George Patton, Omar Bradley, Hap Arnold, and Bull Halsey wanna puke.

We talk a good game – speeches on National POW/MIA Recognition Days – pontificating "former foes that have become friends," but let's get real; Germany and Japan do not have any American POWs and haven't since 1945. The bad guys, Russia (formerly

the USSR), North Korea, Vietnam, and the People's Republic of China) have never been tight friends of America. How did they get our folks? In World War II, some US air crew flew "shuttle" missions into the USSR – then our ally against the Nazis – refueled, and flew back to England. But not all of them returned, so what happened to them? According to the Veterans' Administration, we had 7,140 POW's during the Korean War. Of these, 4,418 returned to the US, some 2,701 died in the camps, and 21 refused repatriation. How do we know 2,701 actually perished? We don't.

DPAA lists that 684 POWs returned home alive from the Vietnam War. But a 1979 Defense Intelligence Agency account stated that a former North Vietnamese intelligence officer reported that about 700 Americans still remained in Vietnam as a "strategic asset." That's six years after the war ended. We can argue till the cows come home which of the thirteen US Presidents - Republican and Democrat – knew how many of our soldiers were clinging to life in hellholes in Russia (Vorkuta), North Korea (The Death Valley Camp), Vietnam (Briarpatch) and the PRC (Air Pirate Prison). Or didn't want to know. Maybe they thought that the "greater good" for America was to say, "I know nothing; nothing personal – just wouldn't be prudent.

How many POWs are still alive? How many angels can dance on the head of a pin? People I trust, including physicians - who understand prolonged malnutrition, exposure to the elements, disease, etc. - offer that given their ages and situation, it is likely none are alive, unless they later assimilated into the area and made new lives. But I have seen an official report, that a repatriated American, "reported that, etched into the wall of Krasnaya Presnya Prison in Moscow, he saw the name of a Major Roberts or Robbins, with his American address and the inscription, "I am sick and don't expect to live through this.... To borrow a famous line: "So you're telling me there's a chance?" Yes, I am. It may just be one POW, but that's not the point.

The way I figure it, we have one last chance to maybe set things right - even if only one American POW remains alive to come home. Whether you love President Donald Trump or hate him, there are a set of facts that are demonstrably true. He is the most unconventional President the US has ever had. Many of his ideas are not just out of the box they are light-years outside. He's a dealer. What better time for the "art of the deal" than for the President to privately meet with these leaders to return all living POWs to us right now. We aren't interested in assigning blame, or reparations, or shown where they are buried with some cock-and-bull story of how they died. It's really simple, those still alive and held against their will - we want them home, now! So here's the deal...

## To Hell with the NFA: The full auto Crosman M1 carbine air gun

(Shooting News Weekly) - We don't typically talk a whole lot about airguns at Shooting News Weekly, but this is one I had to mention. For Father's Day this year, my wife and kids snagged me a Crosman CFAM1, also known as a Crosman M1 carbine imitation that shoots standard 4.5mm BBs. Best yet is that it's a select-fire BB gun. I didn't know much about airguns, and I certainly didn't know they make them in full-auto configurations.

I swapped canisters, reloaded, and my boys and I flipped the switch to full auto. That's a blast. It fires extremely fast. It's tough to fire short bursts of three to four rounds. This thing just emits a a stream of BBs. The Crosman M1 Carbine is an absolute blast to shoot on full-auto. I have two sons, aged 13 and seven, and they both had no problems controlling the BB gun on full auto.



Imagine my surprise when I read that on the box. The pedantic gun nerd in me thought they should have called it an M2 carbine, but I didn't let that thought make it from my brain to my lips. I quickly cut through the tape holding it all together and opened my new treasure.

Overall, it looks and feels nice. It's not the same as a real M1 Carbine, but it's impressive for a BB gun, especially one that costs about \$120.

This was one of those things I couldn't, and didn't want to wait to shoot. Luckily, they provided me everything I needed to go out to the range, which amounts to a box of 12-gram CO2 containers and a ton of BBs...

The selector switch is located on the trigger guard, just like an M1 Carbine. It has safe, semi, and auto positions.



#### One Awesome BB Gun

If I haven't made it clear, the Crosman M1 Carbine is just a ton of fun, and it's cheap fun. I expect my berm will be full of BBs sooner rather than later. The kids love it as much as I do, and it's fun and quiet for the whole family. While eye pro is needed, ear pro is not. Plus, I don't need to go to my range to shoot it. I can sit in the backyard and turn Chek strawberry soda cans into water strainers.

I'm eyeing a full-auto BB pistol next because I have a machine pistol need that can't be legally satisfied. I'm impressed by the Crosman M1 Carbine, and it scores an 11 out of 10 on the fun factor scale.

## NGOs: What are they?

#### A Visit to the CMP North Sales Store

by Mike Keleher (GSL) - A week ago I made a special point to drive over to the Camp Perry facility while I was in Ohio to visit the Civilian Marksmanship Program (CMP) North Sales Store. I have heard of both sales stores in Ohio and Alabama but have never visited either.

The CMP concept goes all the way back to Teddy Roosevelt who was behind the idea of promoting marksmanship among American civilians and the program allows sales of retired government rifles and ammo in addition to sponsoring iconic shoots across the nation.

Located in the CMP headquarters building, the north store is more than just a retail outlet— more of a pilgrimage for me. I did not quite know what to expect, but it was small, like the inside of a 7-11 store! But it smelled much different than a 7-11. Stepping through the doors you are presented with racks of bolt action 1903 Springfield 30-06's and M-1 Garands and that inherent smell! Wood, oil and steel.

This store offers a handson connection to the firearms which helped shape the 20th century from pre-WWI through the Korean war. All are for sale if you are eligible via the CMP program, and they are in all different conditions and beg to be picked up and hand rubbed. Some are suitable only for wall hangers and others look brand new. I had to pick up and feel markings, stencils and dings on those wooden stocks which are traces from life in government service. What stories they could tell.

I held off looking up individual serial numbers in the store lest I present as a gun nerd... (I have a couple CMP guns one built in 1945 and another in 1944. Both could have been used during WW II. Pieces of American history in Walnut stocks.)

The store draws a unique crowd of shooters who love those old Garands and Springfields: collectors, veterans, competitive shooters, and history buffs alike. Some come in search of a specific serial number that might match a family heirloom or service date range, while others are simply captivated by

The IH guns are not as rare as an M-1 Carbine made by Rockola, but you don't see them very often in the open market. My friend's father carried a Garand through WWII and then was a farmer using International Harvester equipment his whole life. I helped his son and



the craftsmanship of a bygone era.

The staff, many of whom are veterans themselves, are of course experts on these rifles. Each rifle is inspected and measured and graded before being offered for public sale. Old guy conversations often drift into tales of boot camp, battlefield memories, or bullseye shooting on the Camp Perry range.



I did not see any ammo for sale, but they had quite a batch of chrome plated M-1 Bayonets for cheap if you needed one for your next backyard parade.

Of note, were a couple of racks of M-1's with the receivers made by International Harvester- yes the tractor and farm implement people. There were about 25 on the floor and may represent the largest collection of International Harvester guns all in one spot! Between WWII and the beginning of the Korean War International got a government contract to make 100,000 rifles beginning in 1952.

grandsons get access to some IH's of their own and they are proud to have and display them.

Beyond the rifles, the CMP North Sales Store is also a hub for education and community. It hosts marksmanship clinics, safety courses, and youth programs designed to instill discipline and responsibility in the next generation of shooters. The store is part of a broader mission: to promote firearms safety and training while preserving the traditions of civilian marksmanship. I wrote a story recently about CMP acknowledging they are running out of the old Garands and have partnered with an outside agency to re-barrel and add parts to make "new" Garands.

There were lots of shooting related small items hanging on the walls as well as logo, cups, water bottles, clothing and hats. I was sorely tempted to buy something with that CMP logo but held off with the satisfaction I would take away memories of the place and that made me happy.

The grounds outside the store are home to a number of tanks and a couple of helos permanently on display, and yeah, I had to go see them and touch them too.

## It's legal, it works, and now CPD's gun-stop tactic faces possible ban

Chicago (CWB Chicago) - The Community Commission for Public Safety and Accountability (CCPSA), the civilian panel responsible for overseeing the Chicago Police Department, is wrapping up a public comment period as it weighs major restrictions on the types of traffic stops CPD officers are allowed to make.

The group is taking public input through Monday but has already outlined a list of restrictions most of its members support. Among them: barring traffic stops for plates expired less than a year, improperly displayed or missing front license plates, improper rear license plate lighting, having a single non-functioning head-, tail-, or brake lights during daylight hours, and driving with a loud sound system.

A minority of CCPSA commissioners also support banning stops for failure to wear seat belts or failure to signal turns or lane changes. Some community members are pushing to go even further — calling for a ban on stops for tinted windows, among other minor violations.

Why? Because they believe traffic stops are disproportionately used against Black and Brown drivers, often as a pretext to look for guns or other contraband.

Chicago's deadliest single shooting ever? Gang violence, not gun violence...

#### 18 shot, four dead, no arrests

Chicago (CWB Chicago) -Thursday's mass shooting outside a River North lounge, which claimed 18 victims, including four fatalities, marks Chicago's deadliest shooting in at least 12 years and it may be the city's worst ever.

Drive-by gunmen opened

fire on a crowd standing outside Artis Lounge, 311 West Chicago Avenue, as a record release party for rapper Mello Buckzz concluded around 11 p.m., officials said. The rapper, whose Facebook page includes references to a South Side street gang faction, claimed that her

boyfriend was one of the four people killed. No arrests have been made.

Conversations with veteran and retired first responders, along with searches of historical news reports, failed to identify any shooting in Chicago's history that claimed 18 victims.

## Brandon's Bodies #49: Man found dead after dozen shots unreported

Chicago (CWB Chicago) - A man was found fatally shot on a Near West Side street this week—the latest gunshot victim to go unnoticed until it was too late in a neighborhood that could once rely on ShotSpotter to detect gunfire.

Officers responded to a call of an unresponsive person in the 2600 block of West Wilcox around 9:13 p.m., according to a Chicago police statement. They found a 44-year-old man on the ground with a gunshot wound to the head.

Paramedics took the man to Mount Sinai Hospital, where he was pronounced dead.



No one reported hearing gunfire in the area; however, officers at the scene reportedly found 12 shell casings near the man's body, raising questions about how quickly first responders could have located the victim if the city's ShotSpotter technology had still been active.

- A reputed Two-Six gang member was wearing an electronic monitoring bracelet for a pending gun case when he gunned down a man in Little Village last weekend, prosecutors said Friday.

Daniel Alvarado, 20, was arrested in March after Chicago police said they saw him crash a car and

## Don't talk to the police!

#### Attacked and stabbed 19 times in his own front yard, then arrested by Normal PD

ISP slow-walks FOID & CCW reinstatement even after charges dropped...

(GSL) - Imagine getting stabbed 19 times in of about six months the tide turned. James your front yard, and when police arrive, they arrest you - the homeowner on your own property! At our Mattoon meeting, GSL member Chad Berck described just such an incident May 2022.

It all started over a dog and a drunk neighbor named James. It escalated and despite multiple police reports, the problems grew. Ultimately, it culminated in a late night attack on Mr. Berck in his own front yard by a drunk James wielding a knife. The neighbor not only has a felony history, but he also reported stabbed two black ISU students. The students identified this James fellow as their attacker and said the attack stemmed from one of them dating a pretty white woman who was with them. See, James apparently really doesn't like interracial dating.

On the night of Chad's near-deadly interaction with James, the two fought for control of the knife. After a ten-minute life-anddeath wrestling match as Chad tried to defend himself from serious body stab wounds, police arrived and cuffed up Chad. They claimed Chad should have retreated from a knife-wielding attacker in his front yard. Apparently Normal's "finest" were ignorant of People v. Hammond, an Illinois Supreme Court case that established that Illinois is a "Stand Your Ground" state via Illinois Supreme Court precedent.

Mr. Berck described the long and arduous process to clear his name, and then to get his gun rights restored by the State of Illinois. He also shared lessons learned the hard way - including don't talk to the police, have legal insurance and to have your gun on you when you're taking your dog out to

As a subscriber to US Concealed Carry Association, Berck said they were great. They paid for the attorney and over the course

the neighbor didn't take it well, cussing the judge and getting thrown out of court more than once for contempt. At the same time, countless neighbors testified in court to the problems and threats from James.

Eventually the special prosecutor dismissed the charges. Ultimately the judge apologized for the legal system failing to protect the real victim in this incident.

Now Berck has the order of protection against the neighbor - just renewed - and his aun rights restored even though they should never have been revoked without due process. He also has his carry license again. He thanked GSL for our help and John Boch for his assistance, guidance and contacts which proved very helpful. "John didn't even believe me at first, but I won him over with evidence and persistence. It is a very crazy story."

In Chad's case, like with many, video evidence proved crucial to his defense.

Lessons learned: Never, ever give a statement to police without an attorney present, even if you were attacked on your own property or in your own home. Have self-defense legal insurance. It's priceless. And find someone who will keep their mouth shut to talk with about your situation and your frustrations.



Stab wound went to bone.

Looking back, Chad sincerely believes his attacker is an evil man. "He was giggling as he stabbed me that night," he said. What's more, Berck later learned that James had a hand axe in his backpack.

Berck knew he had to win that fight that night because his front door was unlocked and his family were asleep inside. Now that it's over, Berck wonders if DeWitt had plans for the rest of his family that night.

#### Nearby gun-free zones contribute to 31% increase in car break-ins (and firearm thefts)

(Shooting News Weekly) - A new report from the Council on Criminal Justice revealing an increase in firearms thefts from parked cars over a five-year study period (2018-2022) overlooks one major component of the problem: the necessity for legallyarmed citizens to leave their firearms before entering so-called "gun-free zones," the Citizens Committee for the Right to Keep and Bear Arms



"While the report raises alarms about a 31 percent increase of gun thefts from vehicles," said CCRKBA Chairman Alan Gottlieb, "it fails to mention a major reason people must leave their firearms in their cars, and that's the proliferation of 'gun-free zones' and 'sensitive areas,' all promoted by the same social justice extremists who complain about guns falling into the wrong hands.

"A legally-owned firearm is safest when it is in the possession of its owner," Gottlieb explained. "Armed private citizens should never be expected to leave their firearms just to have lunch, attend a meeting or public hearing, handle personal business in a government building, enter churches, synagogues or mosques, or merely to go shopping at a mall or market.

"Research indicates that mass shootings occur more frequently in socalled 'gun-free zones' than any other venue," he continued. "Legally-armed citizens have successfully intervened in such situations and prevented tragedies, such as the incident at Indiana's Greenwood Park Mall, where a young man neutralized a would-be mass shooter after he had opened fire in the food court area. Armed volunteers have stopped killers in places of worship in Texas and Michigan.

"Establishing laws that disarm honest citizens while creating risk-free environments for criminals and crazy people is not simply ineffective," Gottlieb stated, "it's insane. Such restrictions not only make it impossible for victims to defend themselves, they provide unparalleled opportunities for thieves, especially during the holiday



#### Trained and Prepared: CrossPoint Church members had taken USCCA Church Security course days before attack

By Rob Chadwick (Shooting News Weekly) -A tragedy at CrossPointe Church in Wayne, Michigan, was narrowly averted two weeks ago thanks to the swift, courageous actions of ordinary citizens who chose to take responsibility for their own security and that of their community. Last week, I had the privilege of visiting with several members of the security team, hearing firsthand about their experience and actions. This incident, involving a potential mass shooter who was thwarted before entering the sanctuary, vividly demonstrates the profound value of preparedness and proactive defense.

Remarkably, none of the heroes who acted decisively at CrossPointe had any law enforcement or military experience. Instead, they were everyday people who had simply taken the initiative to educate themselves and prepare for an unthinkable scenario. Three of these brave individuals had attended the USCCA training event, "Protecting Your Church," just days earlier. That session, held the previous Thursday, helped equip these volunteers with essential knowledge and skills that proved crucial in real-time.

The event at CrossPointe Church reminds us that a strong safety team does not need members with military or law enforcement backgrounds to be effective. Commitment, education, and a willingness to act decisively are often enough. The safety team's rapid and coordinated response, informed by their training, undoubtedly saved lives, particularly considering that the sanctuary was filled with children who had just joyfully completed Vacation Bible School and were performing the songs they had learned for the congregation.

Additionally, the heroism displayed by the church's Deacon deserves special acknowledgment. Despite running late to church that day and initially encountering the would-be gunman alone, the Deacon immediately recognized something was amiss. Although he was unarmed and had no formal security training, he bravely confronted the threat head-on, utilizing the only effective weapon he

had. Realizing he needed to prevent the attacker from entering the church, he used his truck to attempt to disable the shooter before he could reach the congregation.

This extraordinary courage, combined with the preparedness of the safety team, showcases the power of ordinary individuals who step up to protect others. It also highlights an essential truth: effective defense relies not only on equipment or experience but most significantly on awareness, preparation, and decisive action.

The CrossPointe Church incident should serve as a powerful reminder for all congregations and community groups across the nation. Comprehensive and accessible training, such as that provided by the USCCA's "Protecting Your Church" program, empowers everyday citizens to act confidently and competently in critical moments.

Let's honor the courage displayed at CrossPointe Church by committing ourselves anew to being prepared, aware, and ready to act to safeguard our communities. Their bravery sets a powerful example of what is possible when ordinary citizens choose to stand prepared, united, and vigilant.

Contrast CrossPointe Church's safety team with a KY church that had none...

## Suspect kills 2 women in Kentucky church after shooting state trooper, police say

Lexington, KY (AP) - Two women died Sunday at a church in Lexington, Kentucky, in a shooting rampage that began when a state trooper was wounded after making a traffic stop, police said. The suspect in both shootings was also killed.

The suspect carjacked a vehicle after the traffic stop near Lexington's airport and fled to Richmond Road Baptist Church, where he opened fire, city Police Chief Lawrence Weathers said. Killed in the shootings at the church were a 72-year-old woman and a 32-year-old woman, the local coroner said.

# THE JIG IS UP: Everytown has just figured out that eliminating the \$200 Transfer Tax is just the latest step toward eliminating the NFA completely

(The Smoking Gun - An 'Everytown' Publication) - For over 90 years, the NFA has required that anyone interested in buying or building one of these weapons first submit an application to the ATF along with their fingerprints, a passport-style photo, and a \$200 tax stamp before undergoing an enhanced background check. As the ATF notes, the \$200 tax was "considered quite severe" in 1934 "to carry out Congress' purpose to discourage or eliminate transactions in these firearms," though it was never raised or adjusted to account for inflation. In today's dollars, the figure would be well over \$4,700.



But after January 1, 2026, those taxes will no longer be required for silencers, short-barreled firearms, or AOWs, making them significantly easier to obtain — jeopardizing public safety and resulting in an estimated \$1.7 billion loss in tax revenue over the next decade.

The move is the latest attempt by the

gun industry to chip away at the NFA. While NFA applicants previously had to be approved by the ATF and the chief law enforcement officers (CLEOs) in their areas, in 2016 — after lobbying from the National Shooting Sports Foundation (NSSF), the gun industry's trade association — the ATF ruled that applicants only had to provide copies of their forms to CLEOs. The NSSF also lobbied for the ATF's revamped "eForms" application system, which has led to dramatically faster approval times. ...

Repealing the tax provisions may have been a backdoor attempt to invalidate he NFA. After the House passed the udget bill, GOA immediately anounced that they were filing a lawsuit — dubbed the "One Big Beautiful Lawuit" — along with the Silencer Shop, SilencerCo, Palmetto State Armory, and others to remove silencers and shortarreled firearms from the NFA, arguing hat "once the tax is reduced to \$0, the onstitutional justification for the law collapses."The NRA, ASA, Firearms Policy Coalition, and Second Amendment Foundation announced that they would file their own lawsuit challenging the constitutionality of the NFA. In a joint statement, the groups applauded Trump's budget bill, which "serve[s] as a critical step towards our ultimate goal of dismantling the NFA once and

Investigators say Glastetter tried to warn Fisher that he was armed and to leave, but Fisher reportedly answered by saying, "You'll have to kill me."

## Florida burgler shot during July 4 fireworks

(WKMG) - A man arrested on the Fourth of July in Osceola County is accused of burglarizing a woman's house before being shot by the homeowner's son, according to the sheriff's office.

Deputies responded around 8:30 p.m. to the home along Deer Run Road, where the homeowner's son was holding the alleged burglar — Mitchell Platt, 37 — at gunpoint after shooting him in the leg.

The homeowner's son had noticed a rear door was left open and armed himself with a revolver after then entering the home and reportedly hearing strange noises, the Osceola County Sheriff's Office said in a news release.

After the man called out to see if anyone else was in the home, Platt allegedly emerged from a hallway and charged toward him, prompting the man to fire a single shot into Platt's leg, the release states.

## Drunken intruder shot with pistol that works

Elkhorn City, Ky. (WOWK) - According to Kentucky State Police, troopers were called to the scene just before midnight after an intruder was shot by a homeowner. KSP says the man had entered a home on West 5th Street in Elkhorn City and started threatening the homeowner and their family.

Troopers say the suspect, later identified as George Standifur, had a firearm and allegedly attempted to discharge it in the home, but it didn't go off. During that time, the homeowner had grabbed their own firearm and shot Standifur in the leg, according to KSP. The homeowner then forced Standifur out of the home and called 911...

KSP says it took several hours to get Standifur into custody and says he resisted arrest. He was then taken to Pikeville Medical Center to be treated for his injury. Little Red Riding Hood had a gun

## Woman shoots, kills alleged intruder in Skyway

Bryn Mawr-Skyway, WA (King5) — A woman reportedly shot an alleged intruder in front of her Skyway home early Monday morning.

confirm what experience has clearly revealed. From BLM's 2020 protests to two assassination attempts on President Donald Trump to Luigi Mangione becoming a viral "social media folk hero," political violence has become increasingly mainstreamed on the left. In a similar vein, several leftists responded to last week's devastating floods in Texas by focusing on the fact that many of the victims were white or saying that those who were MAGA supporters got "what they voted for ... "

Responding to the radical demands of their base, numerous Democrat representatives have recently tried attention-grabbing antics. For example, Democrat Sen. Alex Padilla attempted to storm a Homeland Security press conference and got himself forcibly removed on camera, Likewise, Rep. LaMonica McIver was federally charged after she allegedly "forcibly impeded and interfered with federal officers" outside an immigration facility in New Jersey. By forcing incidents like these, Democrats may simply be trying to satisfy the demands of their base. As it turns out, he who pays the piper calls the tune. Flected Democrats feel the need to be seen fighting on the frontlines of the resistance to the Trump administration to keep their offices secure

As Democrats frantically try to appease their constituents with feckless publicity stunts, the base is unenthused by lawmakers' efforts to defuse their militancy. A House Democrat told Axios, "I actually said in a meeting, 'When they light a fire, my thought is to grab an extinguisher.' And someone at the table said, 'Have you tried gasoline?"

These developments may be concerning, even to staunch Democrat representatives, but they are

hardly surprising. The Left's radicalism is the obvious consequence of these very same representatives' disingenuous and irresponsible rhetoric. All through election season (and for years before), Democrats ran on the claim that Trump and those who support him are fascist Nazis. And Democrats even resumed their attacks that Trump is a Hitlerian "threat to democracy" just days after the assasination attempt in Butler, Pennsylvania.

Now that Trump has won, they're surprised that their base considers themselves the resistance to the Nazis?

It may be the case that cynical politicians don't actually believe the things they say about Trump, but voters on the left were told that Trump is Hitler, and now they want their representatives to act as if they actually believe it. They envision themselves as the heroes of the resistance to Nazism who will take an honored place in history. If Hitler's reincarnation is actually in power, they reason, violent resistance is absolutely necessary.

Aside from the obvious conclusion that the "anti-Trump resistance" has embraced violence, another takeaway is simply how privileged the Democrats' real base has become. As the Democrat Party becomes increasingly the party of the college-credentialed urbanite, "many lawmakers," according to Axios, said the constituents who demand more radicalism "tend to be white, well-educated and live in upscale suburban or urban neighborhoods.

Another lawmaker recounted, "What I have seen is a demand that we get ourselves arrested intentionally or allow ourselves to be victims of violence, and ... a lot of times that's coming from economically very secure white people."

Increasingly, the Left's real base, and especially those who are going to show up to town halls and other events, are privileged elites. As the blue-collar Democrat is a rapidly declining demographic, the remaining Democrat base is simultaneously more radical and more trivial.

Simply put, pretending to resist the Nazis is not a working-class issue, because those with real problems are too busy to amuse themselves with play-acting. Working-class Americans are more likely to be concerned with issues like real wages than harrowing calls to "save our democracy." The view that elected representatives need to prepare for "violence ... to fight to protect our democracy" is a luxury belief.

Democrat lawmakers can lament their radical base all they want, but they, alongside the media, are the ones who created that hysteria. People often complain about "increasing political polarization, frequently with the implication that both sides need to meet in the middle. But the fact that Democrat lawmakers struggle to deal with the extremism of their base shows why Americans shouldn't take the bait.

At the beginning of the new administration, Trump referred to his presidency as "a revolution in common sense." As conservatives continue to critique the ineptitude of previous administrations, they ought to remember that the side of common sense cannot reasonably split the difference between sanity and insanity.

#### Death penalty: Each execution saves eight to eighteen lives; criminals fear death penalty more than life in prison

by John Lott, Jr. (Town Hall) - Some people support the death penalty to deliver justice, while others argue it deters future murders and saves lives. But a simple proof shows the death penalty deters more than life without parole: look at the choices murderers make when facing trial.

Time and again, mass murderers plead for life without parole to avoid execution. Without the threat of the death penalty, they would have no reason to negotiate.

This week, Bryan Kohberger, accused of brutally murdering four Idaho college students in 2022, became the latest to want life in prison over the death penalty—just weeks before his August trial.

Prominent killers frequently take similar plea deals. Patrick Crusius, who murdered 23 people in a racially motivated 2019 Walmart shooting in El Paso, accepted a plea deal in March 2025. James Holmes, who killed 12 and injured 70 in the 2012 Aurora, Colorado, theater shooting, pleaded guilty in 2015 to avoid execution.

Others who also struck plea deals to avoid the death penalty include: Jared Lee Loughner, Dylann Roof, Eric Rudolph, Nikolas Cruz, [and others.]

Some killers, like Nidal Hasan (who killed 13 at Fort Hood in 2009), sought plea deals but couldn't get them. Military law blocked Hasan's deal.

While Democrats oppose the death penalty, Americans support it by a 3-to-2 margin. And their support would

rise to more than 2-to-1 if death sentences were carried out on a more timely basis. Those with the lowest incomes—who often face the most crime—back it most strongly.

These cases show that murderers fear death more than life in prison. But there is other research supporting its deterrent effect. Indeed, most peer-reviewed studies estimate that each execution prevents eight to eighteen murders. What is saving at least eight lives worth?

Some point to the National Research Council's 2012 report that could reach a conclusion on the death penalty deterring crime, but they fail to acknowledge that the National Research Council virtually never comes to a conclusion on any topic except for claiming that more research is needed.

Some claim the death penalty is racially biased. But data suggests otherwise. From 1977 to 2011, whites made up 64.7% of executions despite committing only 47% of murders. In 2020, 64% of those executed were still white.

Concerns about executing the innocent are unfounded. Between 1989 and 2014, DNA evidence was available in about 12,000 murder cases. The Innocence Project identified 34 people wrongly convicted, 18 of whom were on death row—none were executed

DNA exonerations remain extremely rare.

On his first day in office, President Trump signed a sweeping executive order reinstating the federal death penalty. He directed the attorney general to "take all necessary and lawful action" to ensure states had sufficient lethal injection drugs to carry out executions. Trump defended the order, stating: "Capital punishment is an essential tool for deterring and punishing those who would commit the most heinous crimes."

The murderers' own actions confirm Trump's point—deterrence works.

That is quite a switch from Biden who recently commuted death sentences to life sentences for 37 of the 40 men who are on the federal government's death row. Those spared included child killers and mass murderers, and many showed no remorse and horribly tortured their victims.

The death penalty saves lives and taxpayer dollars. When used strategically, it delivers justice, deters crime, and secures plea deals that spare victims' families from prolonged trials.


There's no requirement to display valid driver's license to purchase fuel (yet), but we must show a FOID to buy food for our firearms? That irritates me.

# RACIST GUN CONTROL: New Jersey officials deny black CCW applications for 'subjective' reasons at twice the rate of white applicants

(New Jersey Monitor) - Paterson police denied Mahmoud "Mo" Ramadan's request for a gun carry permit after he hounded them — and the mayor — about their poky pace in processing his application. Sharon Palombi got denied in South Toms River because of her past police involvement as a crime victim. And Leonard Mirabal's extensive — but non-criminal — driving infractions prompted Carlstadt cops to refuse his carry request.



New Jersey law lays out several documentable reasons why police can deny carry permits, including if applicants have criminal convictions, histories of addiction or mental health disorders, or active restraining orders. But it also allows officers to make subjective judgments and reject applicants they deem lack "the essential character of temperament necessary to be entrusted with a firearm."

Consequently, a growing, disgruntled group of applicants — including Ramadan, Palombi, and Mirabal — have successfully challenged denials, which two recent studies found have disproportionately impacted people of color in New Jersey.

Now, a Republican state lawmaker wants

police to answer to the Legislature and the public on the issue, by mandating monthly reporting on permit denials. Municipalities would have to publicly detail their reasons for denying firearm purchaser identification cards and gun carry permits under a bill Assemblywoman Dawn Fantasia (R-Sussex) introduced Monday. The measure also would require reporting on the age, race, gender identity, and ethnicity of denied applicants.

"There are barriers to exercising your Second Amendment — prior felonies, mental health concerns — that are valid concerns. But the color of your skin is not a valid concern," Fantasia said. "There should be no subjective measures. When you allow subjective measures into the conversation, that leaves it up to people, to personalities, to preconceived notions, and to bias, and that's what we want to remove. There should never be bias associated with your ability to exercise a constitutional right."

The attorney general's office already publicly reports applicant demographics but does no analysis of denials and attributes more than two thirds of them to unspecified "public health, safety and welfare" concerns or just "other disapproval reasons."

John Petrolino, a firearms instructor and freelance writer who focuses on Second Amendment issues, dove into the data last year and found that Black applicants were denied permits for subjective reasons at twice the rate of whites.





# Can you articulate?

by John Boch (GSL) - Self-defense is legal in America. Even in Chicago, believe it or not.

But prosecutors may employ very antagonistic tactics in an effort to turn a righteous use of force into a conviction. Civil attorneys may do the same to score a big payday.

Remember the jury pool won't be a drawn from a regional Guns Save Life meeting's attendees. It'll contain a cross-section of the community including those who viscerally dislike guns and gun owners.

Hence why it's best to practice situational awareness. By doing so, you can avoid victimization and second-guessing by investigators, prosecutors and plaintiff's attorneys.

If you interrupt that bad guy's OODA Loop (Observe, Orient, Decide, Act) by doing the unexpected to thwart his plan for you, that's a win - without all of the nasty by-products of the use of force in self-defense.

If situational awareness fails you and you have to use force, you MUST act to the standard by which you will be judged.

You must also be able to articulate that threat and explain your actions while meeting the Reasonable Man standard:

Whether an objectively reasonable and prudent person, possessing similar skills, training, and knowledge, and in the same or similar circumstances, would have shared that subjective perception.

Here's the good news: the law does not require to people to make perfect use-of-force decisions, but we're required to make reasonable use-of-force decisions. Thank you Graham v. Connor.

If you, with the help of your attorney, can articulate the threat you will probably be fine. You and your attorney might even convince a prosecutor not to pursue charges.

On the other hand, if you can't articulate a threat, then you're on track to pick up a felony conviction and maybe even some prison time.

"But John, what do you mean exactly? This is kind of complicated!"

You must be able to articulate why you did what you did. Why did you carry hollow points, extra magazines or why your gun had a lighter-than-factory trigger. If you had a decent carry class or have been reading *Gun-News* for a few years, you know the answers to these traps.

You may face similar questioning about why you shot your attacker in the chest, face, head or groin. You better have an explanation that's reasonable and makes sense to others.

This also includes why you may have brandished a gun without firing. You didn't pull a gun on someone because they committed a trivial crime. You put them at gunpoint because they threatened to kill you if you didn't let them get away and wouldn't show you their hands after suggesting that they had a gun.

Good answers will make all the difference in more nuanced uses of force. For example:

You're on video in a defensive gun use. Bad guy has knife about 10 feet away, but you manage to distract him. When he looks away, you move off the axis of his attack, draw and fire six shots, give or take, until Mr. Knife crumples to ground.

But there's a problem: the high definition video clearly shows the knife guy drops his knife after the second or third shot struck his body. Yet you continued shooting and struck him a couple more times.



You darn sure better have good answers for these likely questions:

- Why did you shoot him? He only had a knife!
- Why did you keep shooting after he dropped his knife? Were you intent upon killing this man? You said you shot to save your life yet he was no longer a threat once he lost control of the knife and you continued firing.

Do you have answers in your comfy chair all relaxed and stress free? If you don't know them now, do you think you're going to dream something up under an interrogation by cops even with your attorney present? Or on the stand in a trial where your freedom is at stake? If so, you're delusional.

But alas, we won't leave you hanging.

So why did you shoot after the suspect lost control of the blade? Because it takes about six- to eight-tenths of a second to observe something, to process what's happening and to decide to act accordingly - and then for that command to stop to reach fingers. You stopped shooting as appropriate but it took several tenths of a second to implement the decision to stop shooting.

The same goes for a suspect who turns away after you began shooting. Shots to the back never look good to a jury, but if you and experts can attest those rounds were fired at the end before you could react to the stimulus of a suspect turning away, you'll probably gain an acquittal.

Of course nothing is written in stone. Which is why the best way to win a gun battle is to not be there in the first place.

While self-defense is legal, you better act to the standard by which you will be judged and be prepared to articulate the threat you faced.

You carry a gun so you're harder to kill. You know the law and how to articulate the threat so you're harder to convict.

## German police target insulting Internet posts instead of 'immigrant' criminals

(RMX News) - On Wednesday morning at 6 a.m., a large-scale police operation was launched across Germany, targeting hundreds of individuals suspected of insulting politicians or spreading "hate and incitement" online.



The massive crackdown saw police launch morning raids against 170 individuals, which saw police seize computers, cell phones, and tablets, and conduct searches in multiple locations across the country.

The action, which was conducted by the Federal Criminal Police Office (BKA), uses the new Criminal Code Paragraph 188 to target individuals accused of racism and hate speech.

North Rhine-Westphalia's Interior Minister, Herbert Reul (CDU), who has overseen a massive increase in crime in his state in recent years — including violent crimes and knife crimes committed by foreigners — celebrated the police raids.

"Digital arsonists must not be able to hide be-

hind their cell phones or computers," he said.

His state conducted 14 of the approximately 130 nationwide cases in a "day of action" against so-called hate postings.

In fact, even as the number of such raids has exploded in recent years, violent crime has also reached record highs in Germany, in large part due to mass immigration, which is a statistical fact. However, police resources have shifted towards targeting hate speech violations, including those complaining about rising crime in relation to mass immigration, with even politicians, such as Alternative for Germany's (AfD) Marie-Thérèse Kaiser, being targeted in such cases.

## 10 suspects charged in July 4 attack on Texas ICE detention facility

Alvarado, TX (ICE) — Nearly a dozen violent assailants equipped with tactical gear and weapons attacked U.S. Immigration and Customs Enforcement's Prairieland Detention Facility in Alvarado, Texas, on July 4, shooting a local law enforcement officer in the process. The officer is expected to recover.

The attack, which occurred just days before an armed activist shot a U.S. Border Patrol official in McAllen, Texas, was coordinated to vandalize the facility and disrupt operations there.

The FBI has arrested 10 of the 11 suspects, and the Johnson County Sheriff has confirmed that each



## Queens mugging suspect, 15, on e-bike fleeing NYPD cops fatally struck by hit-run Lexus driver

A 15-year-old Queens armed mugging suspect on an e-bike fleeing NYPD cops was fatally struck by an unlicensed hit-and-run Lexus driver with an atrocious driving record after crossing into Long Island, police said Sunday.

Cops responding to a 911 call about a knifepoint robbery in progress outside a corner pharmacy in Floral Park came across the suspect fleeing on the e-bike about 8 p.m. Saturday, police said. Officers pursued the teen for a little over a

mile from Hillside Ave. and 257th St. into New Hyde Park in Nassau County, just over the Queens border, an NYPD spokesman said.

The teen was headed east on his e-bike on Bryant Ave. when a 2015 Lexus GX 460 driven by 28-year-old Ruyan Ali slammed into him while going south on Lakeville Road, Nassau County police said. Ali, who had a suspended license and whose car registration had expired, crossed into opposing traffic to pass a car that was slowing to a stop

in front of him, according to a criminal complaint.

The teen died at the scene, and Ali tried to flee but was arrested nearby, Nassau County cops said.
