

Oglesby, world-renowned for his exceptional gunsmithing skills, took a nice Taurus Single-Action and turned it into a modern masterpiece by pretty much reworking or upgrading the internals, accuratizing it and more.

Oglesby described it as a gun that "started" as a Taurus which has a good reputation for single-action revolvers and after extensive customization and improvements has become a one-of-a-kind that will outshoot 99% of shooters.

What's more, when asked about the ability to make it shoot all five rounds (it's a six-shot, but the sixth chamber is usually left empty for safety considerations) with a single report, Oglesby said yes, single-action revolvers can shoot as fast as a minigun... in the right hands.

What are the improvements you ask? Here's the list all noted on the certificate of authenticity that accompanies the gun.

Fitted oversized Colt base pin, hand-fitted bolt, custom Oglesby springs through-

out, "duo" tone finish (high polished hard chrome), long firing pin with soft action return, internal overtravel, polished bore, zero cylinder shake, fitted hardened bushing, numbered charge holes, size and polished chambers, frosted cylinder face, hard chromed screws, action & trigger job, "Rugerized" hand and spring.

He also wrote in his certificate that the silver "finish" on the gun is hard chrome, not nickel, which allows the parts to remain within spec even after hard use over time. The process is easily twice the price but "You expect the best from the best and that's what you receive."





Executive Director's Report

We win. Next year.

First off, apologies as I'm in the early stages of untying the knot with my bride. Packing, moving, unpacking and assembling furniture at a frenzied pace have kept me sidelined from my usual poop stirring. That's the good news. The bad news is that it's getting ugly fast. So I'm on parttime duty.

Sydney Sweeney.

Either way, I'll be available soon if anyone has Sydney Sweeney's contact info. Why do I mention her after her much-talked-about ad for jeans? Well, the American-made beauty shoots too. She shoots better than 98% of men, in fact. I've seen the video. After watching her do her thing on a range, I'm pretty sure she's John Wick's daughter. So yes, I might be available in time for Christmas. Tell her to call.

SB-8 signed.

What else? JB Pritzker has signed SB-8, the "Lock up your safety" bill. Remember going forward that all your guns have to be locked up or carried on your person both at home and in your vehicle if anyone without a FOID has access to them. This would include guests, maintenance and repair folks, and arguably burglars as well. So if you have an extra carry piece in your console and go to Walmart or Jiffy Lube, you better lock up your console or you might get more than your oil changed if you gun turns up missing and it's used in a crime.

LITIGATION!

On the litigation front, we're still on for September 22 oral arguments in our lawsuit challenging the PICA gun and magazine ban. The "Protect Illinois Criminals Act" is a dead man walking. I predict we win at the three-judge panel. Kwame will ask for an "en banc" review where the entire panel of active 7th Circuit judges look at the case and decide if they want to second-guess the three-judge panel. I predict that we win the en banc by one, maybe two votes thanks to the US Department of Justice's amicus curiae brief supporting our position.

"What's the timeline?" you ask... Well, my crystal ball is in the shop getting polished, but I'd say around this time next year (give

or take a couple of months) we should have a final resolution.

WHAT YOU NEED TO KNOW: CCW Safe absorbs Armed Citizen's Legal Defense Network

Consider this a tentative endorsement

Marty and Gila Hayes have retired from the Armed Citizens Legal Defense Network they formed way back when, and have handed the baton off to CCW Safe. If you're an ALCDN member as I was, you're now a CCW Safe member.

While I'm not privy to all the details, on the surface it still seems like a good deal for subscribers. I called and spoke with one of their senior people in early August and he answered a lot of my questions.

They'll pay for your preferred law firm to defend you in a post-use of force incident. (Cough, is your preferred attorney David McDermott? You know, the guy from Homewood, IL who does self-defense cases nationwide and hasn't lost one yet?) Or they can recommend law firms elsewhere across the nation.



In terms of reputation, I've heard more than a few horror stories about most companies, but have heard nothing about CCW Safe. Either they're doing everything well or they're sweeping mistakes under the rug with great skill.

What's the price? While they have multiple plans (similar to USCCA), it'll run you about \$200 per year for coverage similar to ALCDN's. If you don't have a carry license it's about \$95 more for (each?) of their plans.

I asked what seemed like the obvious question... "Riddle me this: What about the folks in about 30 states with Constitutional Carry? Are they required to cough up another hundred bucks if they skip the carry license?"

They are. He said they were working on that. Meanwhile I thought, "Why haven't you 'worked on this' for the past five years as the number of Constitutional Carry states roughly doubled (or tripled)?"

All-in-all, while I'm not fan of the "second class" status for those without government issued "permits." At the same time, CCW Safe seems like they're the most cost effective option for those who have their own attorney like the McDermott Law Group.

I asked about a discount for GSL members or those mentioning GSL and he shot me back a proposal to get a 20% commission on sales. I politely declined, telling him that our endorsements weren't for sale.

We'll see if they get back to us on a way for our family to save a few bucks when initially signing up and if so we'll let you know

UPDATE YOUR CONTACT INFO(!)

Meanwhile, update your emergency contact number for CCW Safe.

Don't count on the ACLDN emergency number rolling over to CCW Safe.

And double-check you didn't fat-finger it when saving it. You don't want to be like our member who got arrested in Missouri. He spent six nights in the county jail after he had put the wrong number for US Law Shield into his phone. Whoops.

The Toxic Combination Of Illinois' Sanctuary Status And The SAFE-T Act

(ZeroHedge) - It's hard to believe he's been walking freely for months. A woman overdosed in his home. He concealed her death and dumped her body in a bleachfilled trash can in his back yard - where it remained for more than two months. His alleged crimes were heinous. Abuse of a corpse. Concealing a death and obstruction of justice. Class 4 felonies.



Meet Mr. Mendoza-Gonzalez

Yet after Jose Luis Mendoza-Gonzalez was finally arrested, he couldn't be held in jail. His alleged crimes didn't qualify for pretrial detention under the SAFE-T Act, a law passed in 2021 that makes it more difficult to detain alleged criminals for certain crimes. The Act also made Illinois the first state in the country to ban cash bail altogether.

Incredibly, authorities had yet another opportunity to put Mendoza-Gonzalez behind bars. He's an illegal immigrant and could have been handed over to federal authorities. But Illinois' sanctuary status meant, again, he was allowed to walk free while awaiting trial.

It's an infuriating example of how criminals in Illinois are prioritized over victims and their families. And how two laws - Illinois' sanctuary status and the SAFE-T Act - can combine to wreak havoc on Illinoisans.

How many offenders in Illinois have been let out before trial due to an undetainable crime and then committed yet more offenses? It's hard to know, but CWB Chicago in their "not horrible" series has at least compiled a list of individuals accused of killing, shooting, or trying to kill or shoot others while on pretrial release for a felony allegation. All of them crimes that likely could have been prevented.

And how many illegal immigrants have had the opportunity to commit more crimes after being released?

The good news is that Mendoza-Gonzalez has just been arrested and detained by federal immigration agents in Chicago, according to CWB Chicago. The bad news, of course, is that it took federal action to get Mendoza-Gonzalez off the street - something that only happened because of his illegal immigration status.

From CWB Chicago:

"We have lost all common sense when it comes to enforcing law and order," Antioch Mayor Scott Gartner said after Mendoza-Gonzalez was released in April. "When the SAFE-T Act was being debated, there were voices sounding the alarm about what could happen if it were to become law "

"There's other extenuating circumstances in this case. Not only the type of crime, how long the crime was concealed, the fact that the person that was arrested for this is not a U.S. citizen and you know, can maybe flee from the country."

Gov. Bruce Rauner's 2017 signing of IIlinois' sanctuary status opened the door to people like Mendoza-Gonzalez. And Gov. Pritzker's signing of the SAFE-T Act allows alleged criminals like him to roam the streets freely while awaiting trial. Pritzker's further creation of a Welcoming Illinois Office - and the spending of billions on illegal immigrants - has also helped create more chaos for everyday Illinoisans.

It's all become a toxic combination of laws that needs renewed debate and reform immediately.

Washington, DC (Life-Zette) - President Donald Trump on Monday

criticized Illinois Governor J.B. Pritzker, calling him incompetent, and said he may deploy the National Guard to Chicago to address crime.

He also pledged to reverse Illinois' elimination of cash bail.

Speaking in Washington, D.C., while announcing new federal law enforcement measures for the capital, Trump said the same approach could be used in other cities with high crime rates.

Many in most affected communities support any move to reduce violent crime...

Trump calls out crime in Chicago; threatens

"And if we need to, we're going to do the same thing in Chicago, which is a

disaster," Trump said.

"We have a mayor there who's totally incompetent. He's an incompetent man. And we have an incompetent governor. That Pritzker's an incompetent. His family threw him out of the business, and he ran for governor.

State Police still looking for Gibson City man, but there's no 'active threat to the public'

Gibson City, IL (WGLT) -Authorities said Thursday they're still looking for a 70-year-old man who allegedly shot two police officers in Gibson City, but that there was no "active threat to the public."

David D. Jordan is wanted in connection with Saturday's shooting in Gibson City, about 30 miles east of Bloomington-Normal. Police responding to a report of a naked man made contact with Jordan at his home. He allegedly shot both officers, police

said. Jordan's house then caught fire and he disappeared — still without clothes.

Both officers have since been released from the hospital. One was struck in the left knee and left arm. The other was shot in the hip. Neither officer returned fire during the incident, police said. They are both on paid administrative leave.

Anybody who has any information about Jordan's whereabouts is asked to

call their local police or submit a tip on State Police's Crime Tip website. Jordan may be seen with a red bicycle.

"By taking action against those businesses, it's our hope that we can disrupt the system that allows these mass shootings to continue," co-founder Daniel Perlman said.

Democrats plan to rig the system

(PJ Media) - Democrats have dropped all pretense—they're openly plotting to seize and rig the system the instant they claw back power. This isn't quiet maneuvering in smoke-filled rooms. It's a bold, almost taunting declaration that the rules no longer apply to them, and that the very foundations of fair governance are expendable.

In Texas, Democrats staged one of their most brazen stunts yet, fleeing the state in a calculated bid to break quorum and derail a Republican redistricting plan aimed at reflecting Texas's actual political makeup.

And at a rally in Fort Worth, former Congressman Beto

O'Rourke didn't just cheer them on—he glorified their stunt as the new standard for political resistance, cementing defiance and chaos as the left's playbook.

O'Rourke's rally was less a call for democracy and more a manifesto for raw political power. He openly labeled Republican lawmakers "fascists" and boasted about preemptive strikes, declaring, "We don't await the punch thrown by these would-be fascists to land. We punch first and we punch harder... There are no refs in this game," O'Rourke said flatly. "F*** the rules. We are gonna win, whatever it takes."

Perhaps most revealing was O'Rourke's vow for the future: "The next time we win power, we're gonna drive that car like we stole it..."

The reality is Democrats no longer merely seek electoral wins—they aggressively seek to rig the game itself, and they're not even trying to hide it anymore. We can't ignore what Beto and Carville said as just rogue voices in the party. They revealed exactly what the party wants to do the moment they return to power.

The future of our republic hinges on resisting these brazen attempts to dismantle the system rather than playing by its rules.

Mary Miller: 'It's dangerous in DC'

At our GSL Mattoon meeting, Congresswoman Mary Miller joined us (along with her husband State Rep. Chris Miller). She gave a quick report on what she's seeing in our nation's capitol and it's not pretty.

She began with cheering Trump's effort to clean up the out-of-control crime in DC. "There's always someone armed with me," she said. "It's very dangerous there despite what the media says." Staffers have gotten robbed, stabbed, shot and even murdered, even in the District's nicer areas

Mary also cheered the efforts to remove the criminal illegal aliens, including some in Illinois that are suspected of killing people. One in particular was released by an Illinois judge because he "wasn't a danger to the community." Mary called her friends at ICE and they swooped in with 15 agents and picked him up the next day. She's now in custody.

She's also introduced legislation to block the Chinese from buying American farm-

land and homes - and it would require them to divest current holdings within a year. That met with cheers from the audience, as did her legislation to require schools to have students "opt in" to sexed programs and mental health exams. Of course, Democrats will block both bills in the Senate.



"JB Pritzker's mental health exams will probably be done by people who don't know the difference between a man and a woman," she only half-joked. The opportunities for abuse of this program against those who don't aren't the politically favored in Illinois are almost endless.

So you live in Iran and want a gun?

Iran has been in the news a bit lately, but no one is addressing a significant issue over there: how easy is it to own a firearm in Iran? Bottom line is that you can legally own a gun in Iran, but the process to obtain one is strictly regulated by the government and that government is HARD-ASS. Iranian citizens must meet specific criteria and follow a lengthy application process to obtain a license, which permits them to own and carry firearms. But it's rare. Iran has an extremely low rate of firearm ownership per capita, perhaps 3.5 firearms per 100 residents in Iran. By comparison, we have about 120 firearms per 100 residents. 3.5 per 100 ain't many; because it's intentional.

The primary legislation governing firearms in Iran is the "Islamic Penal Code and the Law on Firearms, Ammunition, and Explosives." And you don't want anything to do with "Islamic Penal Code." Trust me. These boys are *really* into the death penalty. At least 901 executions in 2024, including 40 people in one week; the year before, Iran was responsible for 74% of all recorded executions worldwide. You would expect to get hammered for murder, rape or child molesting. But how about: consumption of alcohol, homosexuality, armed robbery, burglary, incest, fornication, adultery, sodomy, sexual misconduct, prostitution, political dissidence, blasphemy, extortion, counterfeiting, smuggling, recidivist consumption of alcohol, producing and publishing pornography, or "recidivist theft"? What's recidivist? Doing something 100 times or just twice? Is blasphemy profane speech concerning God or a sacred entity, or just an irreverent action? Like flipping the bird.

But don't worry. Consumption of alcohol (one glass) is only punishable by 80 lashes; you have to really be hitting the sauce to actually get whacked. And how would you "get whacked" in "Good Old Iran"? Lethal injection? No. Hanging (sometimes from a crane); firing squads (not bad if they're accurate); stoning (No Way! Iranian law mandates that stones used must be small enough to not kill instantly, so most victims are hanging on almost two hours after the first stone hit!), or falling from heights off of a cliff or tall building; but remember, it isn't the fall that kills you, it's the abrupt stop.)

So how would you go about getting permission? Some steps are familiar, because bureaucracies are bureaucracies. Go over to your local police station. Submit a background check, including criminal records and military service status. Take a firearm safety course and pass a written and practical exam. Pay the required fees. Wait for approval from the authorities, which may take several months. Well, heck, are we in Tehran, Iran or Tinley Park, Illinois? But wait; I forgot – you also have to complete a comprehensive psychological evaluation to ensure mental stability. What I do not know

is if you are hooked up to electrodes during that evaluation, because they use electrodes a lot over there.

Does anybody have guns in downtown "T-Ran"? Sure, lots of folks. Just not you. Back in the Shah's day, the old Bureau for Intelligence and Security of the State, known as SAVAK, were all packing 9mm. They were some nasty dudes; in fact, so bad that the Iranians preferred to be run by the Ayatollahs, instead of SAVAK and the Shah. But old Grand Ayatollah Ruhollah Musavi Khomeini - you remember him; he was behind the 1979 seizure of the American Embassy in Tehran, and the 1983 murder of 241 US military personnel at the Beirut barracks bombings - needed his own security guys, and started The Ministry of Intelligence of the Islamic Republic of Iran. It was first called SAVAMA, but maybe that was too close to the old name for comfort, so the Ayatollah changed that to VEVAK. You say SAVAK; I say VEVAK!

Then there's the wonderful Islamic Revolutionary Guard Corps (IRGC). They have lots of guns and are a lot like the old Waffen-SS of World War II infamy. The IRGC has three major missions: prevent foreign interference in Iran; thwart coups by the traditional Iranian military; and crush all "deviant movements" that may harm the ideological legacy of the Islamic Revolution. That puts them at odds with the regular Iranian military; Iranian civilians are really afraid of them, too. Its big, with almost 125,000 personnel.

And lo and behold, three years ago, the vaunted IRGC got the no-nonsense mission to take the "Nuclear Corps Command" under its wing in the "Command for the Protection and Security of Nuclear Centres" to safeguard Iran's nuclear program. Those boys had a *really* bad night June 21-22, 2025, so who knows who's still around, above ground.

Major General Hossein Salami, the IRGC Commander-in-chief, got "salami-sliced" in an Israeli attack. As did Brigadier General Amir Ali Hajizadeh, head of the Revolutionary Guards' Aerospace Force. So did Brigadier General Gholamreza Mehrabi, Deputy Head for Intelligence. So if you're a colonel in the IRGC and you're offered a sweet promotion to general, get a slip from your doctor saying that you're dying. Because if you accept, you will be.

If the Iranians had a vibrant Second Amendment, they wouldn't still be ruled by these jagoffs. But they don't, so it could get bloody when the Ayatollahs are finally shown the door, or even better, get hanged, stoned, or tossed off Tehran's Milad Tower – for a sweet drop of 1,427 feet!

Let me get this straight. You want a gun?


What's behind the steep decline in mass shootings in America?

by Kostas Moros (Shooting News Weekly) - I hate to discuss any apparent "pause" in mass shootings, because it feels like that's


discuss any apparent "pause" in mass shootings, because it feels like that's tempting fate. However, it's hard not to notice that, for unexplained reasons, both mass shooting attempts and mass shooting deaths are way down since the start of last year.

I don't know what explains this. Maybe it's just random chance. While there has been a steep reduction in overall homicide lately, usually that sort of crime is uncorrelated with mass shootings, which makes sense, given the very different root causes of each.

It's important not to pop the champagne too early here. 2014 was a similarly good year, as was 2020 (with lockdowns, schools closed), but both reductions were fleeting. Still, here's hoping something fundamental has shifted and the era of frequent mass shootings comes to a close.



Most Chicago PD Officers carrying Sig P320s have switched to other guns

Chicago (Sun-Times) Most of the roughly 1,450
Chicago police officers who
carried Sig Sauer P320
handguns have replaced
them following safety concerns raised this year about
the weapon, the Chicago
Sun-Times has learned.

Fraternal Order of Police President John Catanzara wrote to police Supt. Larry Snelling in April and urged him to ban the model, claiming the gun can accidentally fire without a trigger pull, which could lead to an officer or member of the public being wounded or killed.

"Current recruits at the Chicago Police Academy already have been advised that the Sig Sauer P320 is no longer a prescribed weapon for them to purchase or utilize," Catanzara wrote

On Monday, department spokesperson Maggie Huyhn said officers using the P320 were given a July 14 deadline to submit proof of buying a new approved weapon. The Chicago Police Department has about 11.600 sworn officers.



"More than 1,350 affected officers are now in compli-

ance with the phase-out process, with about 100 members not in compliance," said Huyhn, who declined to address the safety concerns about the P320.

The department's firearms training section had scheduled 20 days for those officers who owned P320s to meet with vendors to buy other department-approved guns and equipment, Huyhn said

"Additionally, CPD worked with Acme Sports, a regional Sig Sauer distributor, to secure a 'trade-in' option that allowed affected members to pay \$95 to trade in their Sig Sauer P320 for another department-approved Sig Sauer model," she said in a statement.

(Shooting News Weekly) - While the Chicago Police Department "gun turn-in program" website states that "all guns are destroyed and never returned to the streets," that wasn't the case for Twanda Willingham. Ms. Willingham recently filed suit against the City of Chicago and others after she was shot with a GLOCK 21 .45 caliber handgun that had been relinquished to Chicago police at a gun turn-in event in December 2023. The same firearm that was used to shoot Ms. Willingham was then used in at least two other shootings before being discovered on a 16-year old boy months later, as we reported back in April of this year.

Chicago carjacking student brings machine gun to school, released after 17 months in jail

(Center Square) - A former Chicago Public Schools student has been sentenced to five years in prison for bringing a loaded machine gun to school, but he is not expected to spend additional time behind bars

CWB Chicago reports that Marquis Terry, 20, pleaded guilty to possession of a machine gun last year, but he received sentencing credits after spending 17 months in the county jail.

At the time, Terry was on juvenile probation for aggravated vehicular hijacking.

Man on pre-trial release wearing TWO ankle monitors gets ten years for an armed carjacking of a third victim

Chicago (CWB Chicago) - A Chicago man who carjacked a woman at gunpoint while wearing two electronic monitoring devices has been sentenced to ten years in prison.

Prosecutors said 32-year-old Keyruni Buford and another man ambushed a 47-year-old woman in the 7600 block of South Champlain Avenue around 2 a.m. on September 16, 2023. The woman was sitting inside her 2021 Nissan Sentra when the pair climbed in and forced her out of the driver's seat at gunpoint.

Arrested & freed Sunday, then arrested next day for home invasions

Chicago (CWB Chicago) - A 34-year-old Wisconsin man who was arrested for allegedly breaking into a vehicle in Lincoln Park was back in custody less than 30 hours later, this time accused of terrorizing two families in the neighborhood during back-to-back attempted home invasions and burglaries, prosecutors said.

Chicago police first arrested Akram Akbar, of Beloit, Wisconsin, around 9:35 a.m. Sunday, August 3, in the 2100 block of North Stockton Drive. He was charged with criminal trespass to a vehicle and released from the Near North (18th) District police station less than eight hours later.

Cops: Thugs murdered father in front of his children during North Side home invasion

Chicago (CWB Chicago) - Two men with violent criminal histories have been charged with murdering a 32-year-old father during a home invasion in West Rogers Park earlier this year. One of the accused men was on parole for armed robberies, and the other was on felony pretrial release when the killing occurred.

Months after life sentence was reduced to 20 years, murderer is accused of shooting guard during an armed robbery

Chicago (CWB Chicago) - Less than a year after walking free from a life sentence for a 2003 double murder — a release that came after a scandal-plagued prosecutor championed his resentencing — Dante Brown is back in jail, accused of shooting a security guard in the neck last weekend during a Near West Side.





Gun Nation: The Rise of 'Child Gun Influencers'

(UK Independent) - Fred Thrasher doesn't see his children as social media content creators, even if they run in those circles. "They're not influencers," he says, firmly. "We're a foundation."

The Survival Sisters Foundation is a nonprofit organization that takes families out in rural Georgia and allows them to learn about firearms while using expensive gear they wouldn't otherwise be able to access. It's targeted in particular toward girls and women, and runs a campaign called "Don't Be A Victim" that focuses on preventing domestic violence, child abuse, human trafficking and — perhaps counterintuitively school shootings.



Still, child gun influencers have been becoming more common over the past five years..

Thrasher says that he has to take a more careful approach, balancing his enthusiasm for the space with how he knows American society views black

people. He takes care to make sure that the content the family puts out on social media is positive, that it could never be mistaken for gang content.

That's one of the reasons, he says, why the logo of the Survival Sisters is still a little girl with a ponytail and a flower, even though his girls are teens and young adults now, with the oldest two heading off to college and the youngest in high school. "Countering the narrative" is always top of mind.

Thrasher didn't start shooting with his daughters to get clicks, anyway, he adds. He did it because, after he and his wife divorced, he realized he needed a way to bond with his children, and he was raised as a "country boy," hunting, shooting, fishing and simulating river rescues. Traditionally, he'd been told that that was the purview of little boys. But why shouldn't it be a way for a father to bond with his four little girls?

Trump's Department of Justice proposes rule for reformed felons to regain their gun rights

(US DOJ) - President Trump directed the Department of Justice to address the ongoing infringements of the Second Amendment rights of our citizens-all of them. Federal law disables the firearms rights of many citizens who have been convicted of crimes without regard to whether they actually pose a threat of violence. But federal law also empowers the Attorney General to restore Second Amendment rights to individuals who are not "likely to act in a manner dangerous to public safety." Today, the Department of Justice submitted to the Office of the Federal Register a proposed rule regarding the exercise of the Attorney General's authority under 18 U.S.C. 925(c) to grant relief to individuals who are otherwise precluded from possessing firearms.

"For too long, countless Americans with criminal histories have been permanently disenfranchised from exercising

the right to keep and bear arms—a right every bit as constitutionally enshrined as the right to vote, the right to free speech, and the right to free exercise of religion-irrespective of whether they actually pose a threat," said Attorney General Pamela Bondi. "No longer."



The proposed rule will provide citizens whose firearm rights are currently under legal disability with an avenue to restore those rights, while keeping firearms out of the hands of dangerous criminals and illegal aliens. Ultimate discretion to grant relief will remain with the Attorney General, and she will exercise that discretion on a case-by-case basis in light of all available facts and evidence that bear on an individual's application. But absent extraordinary circumstances, violent felons, registered sex offenders, and illegal aliens, in particular, will remain presumptively ineligible for

The Justice Department welcomes comments from communities that could be affected by a final rule including law enforcement, victims' advocates, elected officials, and individuals who would like to apply to have their gun rights restored. Because this proposed rule is intended to create a fair and thoughtful system to evaluate applications for the restoration of firearms right, the Justice Department recommends that individuals seeking the restoration of their firearm rights review and comment on the proposed process rather than submit applications at this time.

Chaplain Steve Holden: Church safety and security, active killer response & more

(GSL) - Chaplain Steve Hold- is observed. en addressed the audience at SCHEELS in Springfield to talk about church violence in general and active shooters in particular.

He began with a salute to first responders who put themselves in harm's way to help others. "Their 'job' is a calling," he observed. The same goes for the good people who walk among us, protecting the flock.

Nutcases, criminals and terrorists attack others, particularly churches for a host of reasons, some more rational than others. Attackers prefer so-called "gun free" zones to limit resistance.

For churches, their best bet is to keep the violence outside. Watch the parking lots for trouble and secure the doors the instant trouble

Make your facility a hard

target with a church safety team, with limited access and armed responders for the worst-case scenarios. And again, monitor the parking lots for trouble.

For those inside, the "run, hide, fight" plan seems to be the most common suggestion. Although those of us with guns may change the order of those responses.

Anyone can be a leader in an "Active Killer" situation by guiding innocents to escape, to safety or to help them hunker down. The same goes for fighting back.

Holden also spoke of the recovery process for those victimized by violence (as well as their family and friends impacted by it). Prayer helps, as does professional counseling. Neither are a sign of weakness.

VA Advocate Michael Reegan: There are tons of resources and benefits available to veterans

He's become an advocate for father's rights in addition to his work in the field of helping veterans via a couple of jobs.

Michael talked about the role of art in

giving veterans with PTSD a way to communicate, through art, some of their struggles and how that's helped some avoid suicide.

In a couple of jobs, he's learned a lot about the VA and knows how to navigate their world for vets to receive help with finding jobs, resources, vocational rehab and even financial assistance, particularly for those who have service-related disabilities.

Ragan said he can also help veterans to initiate those disability claims and a whole lot more. "There are a ton of benefits available," he said. For Illinois vets, they may be eligible for 120 credit hours at a state university. Oh yeah, he also raved over Taco Tuesdays that start around 6pm at the VFW in Peoria Heights at 1505 E. Lake.

Preparing for potential attacks: Both **Islamic Terror and Homegrown Criminal**

(GSL) - David Windsor joined us at the Chicagoland GSL meeting with a wide-ranging presentation. He wears multiple caps, including working as an Air Marshall. He also serves as a Command Sergeant Major in the US Army specializing in intelligence analysis.

When he has a spare minute he also teaches defensive skill sets to regular people. He feels it's his calling to help people, and it's his passion.

We started talking about Islamic terror. That's one of the hats Mr. Windsor wears with his work in the Army. Yes, the Al-Qaeda 2.0 book is spot on in its open-source intelligence information. Yes, there are potentially Islamic training camps in the US, including more than one in Illinois. And yes, they planned to hit us this year.

What they hadn't planned was Donald Trump's round-up of illegals and his aggressive work rooting out potential terror suspects. We've likely disrupted some of those terror cells with the arrest of close to a thousand potential terror suspects early in the Trump administration. Unfortunately that leaves hundreds more we likely know nothing about.

Many, if not most of the DEI leadership has been replaced with hard-chargers who are aggressively running down leads, including plans to potentially use cargo jets instead of passenger jets to recreate

How do you prepare? Carry your damn gun, every stinkin' day. Have some first aid skills, like application of tourniquets and wound packing. Have a decent first-aid kit in your vehicle. No, not the one for scrapes and boo-boos. Instead, one with chest seals, CATT tourniquets, wound-packing gauze, Israeli Battle Dressings and that sort of stuff that will save lives before the pros arrive to provide care.

He spend a lot of time talking about life on the streets of Chicago. He explained that the hardened, career

criminals in Chicago see victimizing people as nothing more than a job. If you thwart their plans with the threat of decisive, violent resistance, don't be surprised if they just laugh and walk away nonchalantly. It's not the first time they've seen the muzzle of a gun. And it's just a game of sorts for the experienced robbers.

Windsor says these thugs ask themselves two questions when the settle on a potential victim: "Can I take them?" and "Can I get away?" The easiest way to avoid interactions with bad guys? Be aware of your surroundings. Identify potential threats before they get anywhere near you. Be ready to use deadly force and look like you mean it. Just because you have a gun doesn't mean a career criminal's going to be dissuaded. You have to look like you'll use it without a second thought. Only then will they know that they can't take you and they aren't going to "get away."

So be sure to have some sort of legal defense coverage. You carry that gun to make yourself harder to kill. You know the law and have insurance so you're harder to convict in the aftermath.

Why is the gun control industry so freaked out about more women owning guns?

(NSSF/Shooting News Weekly) - Leave it to gun control groups to suggest that half of the law-abiding population of the United States shouldn't be considered for gun ownership. And it's the half of the population that owning a firearm for self-defense benefits the most in time of need.



Sure, in the past, women were not the segment of the population that immediately popped in to mind as being firearm owners. But now in 2025, shouldn't that be different? Women already have the same rights as men – including the right to keep and bear arms. Firearms are a part of the American culture, enjoyed by everyone of any color, race and nationality. And over the past five years, industry data has shown women are the fastest-growing demographic of gun buyer. It makes sense that firearm industry businesses would pay attention to their customers and cater to their needs.

But that's not how many gun control activists and gun control groups see it and they are now aghast that lawful firearm manufacturers would cater their advertising and marketing efforts to appeal to women

Media still widely misrepresents American gun owners as old, white guys but recent trends in firearm purchasing couldn't put this caricature to rest any better. Over the past five years, the surge of new first-time buyers has made the gun-owning community the most diverse population of gun owners ever. That's a good thing – as the Second Amendment is for everyone. And that includes women.

Women are featured more prominently today in advertising because more women are buying firearms for any number of reasons – all good ones – and the industry is listening to them. Women's nights at neighborhood shooting ranges, womenonly firearm training classes and even friend groups choosing to go to the range together are all increasingly more popular activities as women choose to exercise their Second Amendment rights in any safe way they choose.

Marketing has changed over the last few decades to follow the customer. For Lickenbrock and others, that means seeing a lot more women with guns. And that's a good thing.

CHURCHES: *Know* your staffers

In this instance, this woman allegedly used physical violence against a toddler. However sex abuse runs rampant at churches as well. Why? Churches, especially smaller ones, can be desperate to find volunteers to help out. And "minor-attracted" pedophiles know this

Churches should be wary of any new members who express a desire to volunteer in the youth ministry or church daycare centers. Incidents of abuse of any kind committed against the youth in churches will have parishioners leaving in droves.



The effects of SCOTUS's Loper Bright ruling are real and they're glorious

(The Hill) - The Loper Bright ruling that ended so-called "Chevron deference" last June was described as a "return to judicial balance" — a technical correction. But its consequences are now impossible to ignore.

This decision gas hit gun regulation especially hard, stripping the Bureau of Alcohol, Tobacco and Firearms of one of its key tools for enforcing gun control. Between *Loper Bright* and the Supreme Court's striking down of the ban on bump stocks in *Garland v. Cargill*, courts across the South have begun systematically overturning rules.

Before *Loper Bright*, the ATF claimed the authority to decide what counts as a firearm — including whether modifications or added parts fell under regulation. The agency used that flexibility to slow the spread of dangerous modifications.

After the demise of *Chevron*, however, courts are no longer required to defer to agency interpretations, meaning that agencies like the ATF can no longer count on winning if they "fill in the blanks" where Congress was vague. That means every new restriction must be clearly written into law, and older rules are now being challenged in court. The ATF is left watching from the sidelines as *Loper Bright* has become a standard

reference in gun-related cases...

A judge in Texas also blocked ATF's attempts to regulate forced-reset triggers — devices that let semi-auto rifles fire almost like automatics — on the grounds that only Congress can decide what counts as a machine gun. This ruling shows how, after Chevron ended, agencies lost their ability to stretch unclear laws into gray areas.

The argument is clear and consistent: If something isn't explicitly defined as a firearm in the law, the agency cannot necessarily count on its claims of authority over it holding up in court. Without *Chevron*, regulators can't just interpret or assume provisions "in the interest of public safety" and expect their interpretations to carry the day by default.

Chevron's fall didn't just weaken the ATF—it shook the foundation of how regulation works. Now, every gun rule must be spelled out. Until that happens, loopholes remain open.

Meanwhile, Congress's continued silence has opened the door to a wave of new weapon variations and modifications. The market is drifting into chaos, making rules hard to enforce and define.



Derrick Perry hailed as hero after stopping mass knife attack at MI Walmart

A local former Marine is being hailed as a hero by the community for stepping in during the horrific stabbing at a Walmart in Traverse City, Michigan, where 11 people were injured inside the store in what is being called a "terror rampage" by local authorities.

Derrick Perry, 41, who was at the Walmart with family when the stabbing occurred, pulled out his concealed firearm and held the suspect—42-year-old Bradford James Gille—at bay outside of the store until the Grand Traverse County sheriff's deputies arrived. Perry is being credited with potentially saving the lives of additional victims with his quick and decisive actions. Viral cellphone footage of the incident outside shows Perry approaching Gille as he and others yell at him to throw down his knife.

Traverse City Police Chief Lauren Gilbert said that Perry's quick and decisive actions may have saved lives. "Had he not stepped in when he did, the situation could've turned much worse. He likely saved lives," she said.

Joliet police said officers responded to a report of a home invasion in the 7000-block of Hadrian Drive around 10:30 p.m.

Police said the woman, armed with a gun, heard someone break into her home. That's when she took her child and hid in a bedroom closet on the second floor.

Police believe that when the suspect entered that bedroom, the woman opened fire, striking him in the head. The suspect was pronounced dead on the scene.

Father of 20 commits his last armed robbery; family wants disarmed victims

(The UK Independent) - An Atlanta father of 20 was fatally shot last month while allegedly attempting an armed robbery, police say.

On July 19, D'Anthony Reaves, 44, was killed outside the Greyhound bus station on Forsyth Street around 5:30 a.m. He was shot twice in the face and once in the arm, according to police.

In a Wednesday update, Atlanta homicide detectives said their investigation determined the case should be classified as a felon killed by a private citizen. Police said Reaves was in the middle of an armed robbery when he was shot...

"We're fixing to open up the D'Anthony Reaves foundation so we'll be able to serve his kids so they'll be taken care of," Deoinetea Hightower Reaves' brother told the outlet.

Hightower added that he is pushing Greyhound to end its policy allowing guns across state lines and urging Georgia Governor Brian Kemp to tighten gun laws to keep firearms away from young people.

Home intruder stabs country music star's mother to death, father returns the favor

(Nashville Tennesseean) - It started as a random home invasion. It ended in the death of the mother of a rising country music artist.

Holly Hatcher, a former teacher, was found dead inside the family's North Valley Pike Virginia home at 11:58 p.m. Aug 3. after being stabbed by an armed intruder. Her husband, Michael Hatcher, then shot and killed the attacker.

Hatcher was the mother of Spencer Hatcher, a 28-year-old up-and-coming Nashville country singer



Deep blue city discovers enforcing laws and prosecuting criminals actually works to reduce crime dramatically

Violent crime plummets in Baltimore after voters fire Team Soros prosecutor...

(Free Beacon) - Homicides and other types of violent crime are dropping precipitously in the crime-ridden city of Baltimore. It started shortly after voters fired their progressive Soros-backed prosecutor in 2022—and experts say that's no coincidence.

Baltimore's homicide rate soared after state's attorney Marilyn Mosby took office in 2015 on a progressive platform of refusing to prosecute low-level crimes while aggressively charging police officers including those involved in the death of Freddie Gray, a black man who died from injuries sustained while in custody. Those officers were ultimately acquitted, but Mosby's policies still had a chilling effect on the Baltimore Police Department. Arrests plummeted under Mosby's watch as homicides jumped from an average of 229 per year before she took office to 333 per year during her eight years as state's attorney, according to figures compiled by the Heritage Foundation.



By July 2022, Baltimore voters had enough. Mosby lost her primary election to her Democratic challenger, Ivan Bates, who pledged to reverse her progressive non-prosecution policies and put in place harsher penalties for repeat violent offenses and illegal gun possession.

By all appearances, it worked.

In 2022, Mosby's last year in office, Baltimore saw 334 homicides across the city. The next year, under Bates's watch, that number dropped to 262. In 2024, it dropped further to 202 homicides.

And during the first half of 2025, Baltimore saw just 68 homicides, a 62 percent drop from the same time-frame in 2022. Auto thefts are also down 34 percent, robberies are down 22 percent, and arson is down 10 percent in Baltimore so far in 2025 compared to the same timeframe last year.

"The numbers don't lie," Maryland Public Policy Institute fellow Sean Kennedy told the Washington Free Beacon. "Ivan Bates's model of targeting the most violent or violence-prone offenders (gun carrying criminals) is the primary driver of Baltimore's miraculous success."


88% of college students self-censor on campus

(Washington Stand) - In today's hyper-polarized academic landscape, college students face an unspoken ultimatum: conform or be cast out.

New research by Forest Romm and Kevin Waldman, conducted between 2023 and 2025 at Northwestern University and the University of Michigan, reveals a chilling reality: students are hiding their true beliefs to navigate the social and academic minefield of ideological conformity. Based on confidential interviews with 1,452 undergraduates, the study uncovers a pervasive culture of self-censorship driven by fear of social ostracism and academic penalty...

The data says it all. When asked, "Have you ever pretended to hold more progressive views than you truly endorse to succeed socially or academically?" an overwhelming 88% of students said yes. Eighty-eight percent!...

So, within the classroom, what does this look like? According to the research, 78% self-censor on gender identity, 77% on politics, and 68% on family values. Alarmingly, 80% admit to submitting classwork that misrepresents their beliefs to align with professors' expectations — a practice so ingrained it's become "second nature" for many.

(GSL) - Sig-Sauer's P320 handgun is a fine handgun. It's easy to shoot, comfortable to shoot and has a great, crisp trigger that helps facilitate solid hits on target.

It also sometimes goes bang when dropped. What's more, sometimes it goes bang for no apparent reason in the holster - even for those not in the Bermuda Triangle.

Sig, of course, denies there's any problem and falls back to its stock talking points of rigorous testing, fancy engineering and blah-blah. Despite the fact millions of us have seen the videos of the gun going bang when struck or dropped in a particular manner, Sig asks us to ignore our lying eyes and believe them that it's a safe gun.

It *might* be a safe gun. But I'm not putting it anywhere near me or my boys. I simply don't trust it.

And I'm not alone in not trusting this particular Sig product. An increasing number of police agencies want nothing to do with them. Ditto for ranges and training schools. And it wouldn't surprise us if dealers haven't begun to shun the model as well.

In short, if you have one of these 320s it might be a fine time to sell it to someone else. Ideally someone you don't like. Give them a bargain price. Because there may be a day soon where you'll be very limited to where you can practice or train with your 320. Or worse yet, if someday you bob instead of weave, or drop it just right, it might just go bang on you in a very unintended manner.



Better to sell it now and get something out of it than be left as the bagholder when the market for the 320 goes to near zero over fears - righteous or not-so-much - that the P320 is unsafe.

Illinois legislature commits overreach. Again.

Once again, the Illinois legislature has committed an egregious act of overreachbreaching the paternal sovereignty of the home under the guise of public safety. According to Governor Pritzker's office, the newly signed "Safe Gun Storage Act" outlines "improved" storage requirements and imposes civil penalties ranging from \$500 to \$10,000 for violations, depending on the outcome of the breach.

Who granted the legislature the authority to define "reasonable risk" within one's own household? The home—a man's castle—is a sovereign domain. When the state supplants the judgment of the head of household, it transforms protection into coercion. This law does not merely regulate—it reorders moral jurisdiction, replacing paternal responsibility with bureaucratic oversight.

The legislature claims this power under the doctrine of police powers, citing public health and safety. Yet such powers must be narrowly tailored and constitutionally sound. The Supreme Court's decision in District of

Columbia v. Heller (2008) affirmed that laws rendering firearms inaccessible for self-defense in the home violate the Second Amendment. The Fourth Amendment protects against unreasonable government intrusion, and the Due Process Clause demands clarity and fairness in law. SB 0008 risks failing all three tests.

This is not a debate over safety—it is a reckoning over sovereignty. The state may claim to protect, but when it dictates the moral order of the home, it ceases to serve and begins to rule.

To punish a man for how he stewards his own hearth is not a mere infraction—it is a desecration of origin. The home, as sovereign sanctuary and moral domain, precedes all edict. Suicides with guns aren't 'gun violence' any more than hangings are 'rope violence'

STUDY: Journalists drink too much, are bad at managing emotions, and operate at a lower than average level

(Business Insider) -. Journalists' brains show a lower-than-average level of executive functioning, according to a new study, which means they have a below-average ability to regulate their emotions, suppress biases, solve complex problems, switch between tasks, and show creative and flexible thinking.

The study, led by Tara Swart, a neuroscientist and leadership coach, analysed 40 journalists

from newspapers, magazines, broadcast, and online platforms over seven months. The participants took part in tests related to their lifestyle, health, and behaviour...

Each subject completed a blood test, wore a heartrate monitor for three days, kept a food and drink diary for a week, and completed a brain profile questionnaire.

The results showed that journalists' brains were

operating at a lower level than the average population, particularly because of dehydration and the tendency of journalists to self-medicate with alcohol, caffeine, and high-sugar foods

Forty-one percent of the subjects said they drank 18 or more units of alcohol a week, which is four units above the recommended weekly allowance. Less than 5% drank the recommended amount of water.

Marvin Heemeyer and his 'Killdozer:' A 21st century Gadsden icon?

I was in a public venue recently, when I spotted a young man wearing a T-shirt "Heemeyer Muffler Shop: Granby, CO." I chuckled.



I approached the young man and shared with him that I understood the meaning behind his apparel. As I struck up a conversation with this young man, I learned that the events perpetrated by Mr. Heemeyer occurred before the young man was even born. Yet over two decades later, the events of the Killdozer rampage are gaining ground as an icon to civil disobedience.

"Sometimes reasonable men are must to do unreasonable things." This was a quote left behind by Mr. Heemeyer in his manifesto discovered postmortem to his rampage.

In the early 90's Marvin Heemeyer moved from South Dakota to start a new life in Granby, CO. There, he opened a muffler shop where business was moderately successful. About ten years later, a local businessman had approached Mr. Heemeyer about selling his property for it to be repurposed as a concrete plant. The two could not come to an agreement on the selling price. Frustratedthat the two could not come to a deal, the businessman lobbied the town council to re-zone the neighboring property and his plant was built.

This change in property status opened numerous zoning issues for Marvin. First, Marvin lost easement to his shop, making customer access difficult, costing him business. Next, the town re-zoned his property, forcing him to spend \$80,000 to connect to the city sewer system and fined for being non-compliant. Mr. Heemeyer petitioned for a new road to access his property, the town council declined.

Facing financial ruin for consequences stemming from refusing to sell his lawfully owned property, as a reasonable man, Marvin sued. He lost. He appealed; he lost.

Financially ruined, this otherwise reasonable citizen lost every civilized tolerance to government bureaucracy he had. Marvin locked himself away in his now-closed muffler shop and spent the last year of his existence uparmoring his Komatsu D355A bulldozer.

Lowering an armored shell around the cab, with remote cameras for navigation and strategically placed gun ports, there was no access in, nor escape from, his creation. On June 4, 2004, Marvin burst through the wall of his shop on a rampage to bulldoze a list of enemies.

First stop; the neighboring concrete plant. For two hours, law enforcement was powerless to stop him. They tried to block his path with earth moving equipment, he simply pushed them aside. Law enforcement opened fire with small arms; they may as well have tried to stop an aircraft carrier.

An Apache helicopter with sidewinder missiles was dispatched to destroy the Killdozer, but collateral damage considerations put a stop to this idea.



The rampage ended when Marvin took out a local hardware store owned by a member of the town council. Marvin did not know that the building had a basement. One track fell over the foundation: high-centering the dozer. When the engine finally failed due to overheating, Marvin ended his rampage of \$5M damage on his terms, taking his own life.

Only by the grace of God was no one injured or killed, except Marvin.

This story sounds like a storybook fairy tale of the little guy exacting vigilante justice upon crony politicians. However, there is a darker side to the lionization of Marvin Heemeyer.

As I said, it is only by the grace of God that Marvin did only property damage and no bodily harm. Here is a list of facts that show a darker side to his actions;

- Marvin leveled the house of the innocent widow of the deceased Mayor.
- Marvin opened small arms fire upon law enforcement. His shots did not find their mark due to the limited field of fire offered by his gun ports.
- Marvin demolished the public library where children had been present just a few hours prior.
- Marvin opened fire with 50 BMG armor piercing incendiary rounds at commercial propane storage tanks located across the street from senior apartments. Luckily, his rounds ricocheted off the ground ripper mounted on back of the dozer not allowing a clear line of fire.

Marvin's list of intended victims was extensive. Had his architectural error not stopped him, it is quite likely a victim may have actually been injured or killed.

Lessons learned? Study the blueprints of the buildings that you intend to demolish and substitute the water-cooled engine for an aircooled power plant.

Martyr or Terrorist? That is a decision to be taken by the personal interpretation of the reader. It is evident today, 21 years later, that Marvin Heemeyer and his Killdozer are gaining folklore status symbolizing defiance to government bureaucracy. A 21st century Gadsden icon.







Ham radio for emergency comms


In recent issues, our GunNews editor John Boch has done a remarkable job of looking at emergency communications. He's thoroughly covered GMRS, FRS, and MURS.

Those free unlicensed services provide a reasonably priced and simple way to stay in touch, but they are limited by power and range and can be crowded in an emergency.

Another alternative is Amateur (Ham) Radio. Ham offers virtually unlimited possibilities both as a hobby and for emergency communications. The hobby part is fun and a constant learning experience, but the emergency communications side really can't be beat. A lot

of hams like me got into it for just that reason. Preparing for emergencies and providing emergency communications is what hams do.

VHF and UHF ham repeaters cover much greater distances, in many cases hundreds of square miles. Ham repeaters have "big ears", they can hear



Ham radio repeaters can be accessed with your Baofeng HT or with larger more powerful rigs. With much higher maximum power capabilities, even simplex, radio to radio communications cover much further distances when

HF bands are often "open" and with the right conditions it's common to talk to the world. Mimicking emergency conditions, Parks on the Air (POTA) is a game that allows you to contact portable low power stations all over the world and practice making those contacts. Everyone who uses ham radio must have their own license. You no longer need to know Morse code. The FCC has simplified licenses into 3 classes, Technician, General and Extra.

Getting the tech license is easy and gives you full use of all VHF/UHF bands. If you can pass a drivers test you can pass the tech test. Craig Buck (K4IA) publishes a series of books that give you the answers to the test that you can memorize, and the American Radio Relay League publishes a myriad of study guides. Online practice tests show you when you are ready to take the exam

The cost of a license, including the test fee, license and study material is well under \$100.00.

Equipment costs can be as little \$40.00 for a cheap handheld (which many of you may already have) to thousands of dollars for a big station set up. A good mobile dual band radio runs about \$360.00 with an antenna



General and Extra class licenses are a bit more difficult but open all the bands for you to use. It's really a matter of what you want to do with ham radio. As you study for those tests, you'll learn things like how to make an antenna yourself, out of common materials and build a self-contained station in a box. Many guys build go box radios in a 30-cal ammo can.

Everything you need to know to get started can be found at www.arrl.org/licensing-education-training
