# RAMPANT CRIME

#### Rampant Blue City crime is the disease and more policing is the cure Blue Politicians just don't want to swallow

(NRA-ILA) - Is it something in National Guard to clean up the water?

Officials in Democrat-run strongholds like Chicago are unwilling to accept that their crime problems are the result of their pro-criminal, antivictim policies, including gun laws that restrict the rights of responsible citizens. Instead, their solution is some variant of "more gun control," while concurrently diminishing the consequences for the lawbreakers driving up crime

Commenting on the notion that President Donald Trump would next deploy the

Chicago's crime, Chicago Mayor Brandon Johnson released a statement that sought to redirect the focus (and responsibility) away from his administration and violent criminals and make it about housing and hungry children instead.

Notably, Mayor Johnson polled at an abysmal 6.6% approval rating earlier this year. A substantial majority (67%) of poll respondents pointed to "rampant crime" as the city's biggest issue, suggesting the mayor's failure to deal with crime is a driver of his appalling score.

Johnson, "wallowing in the worst job approval ratings of any mayor in the country,' has also challenged the portrayal of Chicago as a city in dire need of some kind of intervention. Contrary to the dystopian lawlessness suggested by the local crime reporting news site CWB Chicago, Johnson maintained that "[w]hat's being painted by the federal government is false. We love one another. We support one another. We put our arms around one another."

This is the same Mayor Johnson who recently told

#### Mike McCoy on 48 years in law enforcement in Peoria

"This..." Mike McCoy began, looking around the room. "This is THE safest place I've ever spoken." The audience roared with laughter.

McCoy gave us a thumbnail sketch of his 48-year career in law enforcement at our Peoria meeting. He started in a small town, providing all of his gear and borrowing a .357 from a relative. His firearm training? Four rounds behind a barn just outside of the town. Patrol training? A twenty-minute drive of the perimeter of the town.

From there he started working corrections at the jail and then the sheriff at the time put him out on the street as deputy. He shared the story of running out of ammo shooting at an armed robber and lessons learned (I always carried a second gun after that!). Another time his

undercover work was blown by a friend who asked him how the new job as a deputy was going.

Always an overachiever, he did solid work and was selected to attend the FBI Academy at age 28 - or not quite half the age of most there. He soon worked as Peoria Heights police chief, then dipped into corporate security and then he and a buddy ran for sheriff and they won. His friend took the sheriff's job with McCoy as chief deputy. Fast forward, the sheriff died during a minor outpatient surgery and McCoy found himself thrust into the sheriff's role.

There were plenty of other stories the dazzled the audience and we appreciate him joining us to share not only his stories but his advice to good people everywhere.

"If you're able to take a shooting class, do it!" he said rather emphatically. And practice with your gun and your gear.

He also urged everyone to make sure your church has a safety team. He's got one with 26 guys and gals at his church, and they serve one or sometimes two Sundays a month. There's too many bad things happening at churches to not have a safety team.

Asked about the Washington tornado a few years ago he said it devastated the town.

Another person asked if he would recommend policing to young people. Mike said yes. If you're honest, you can do a lot to help people and make the world a better place with the little things that make a difference.



#### We called it: Fringe Dems want blood

Anyway, if you didn't see our August 2025 edition, here's the above-the-fold front page story.



"Fringe Dems Want Blood"... 55% of left-leaning Americans think political violence is acceptable. Why? In part because the radical left has lost the debate on hot-button issues in the public square. So now, brimming with self-righteousness, they are turning to violence to suppress opposing points of view.

Clearly this needs to change.

What else? Full of hate and vitriol, those on the fringes cheered Charlie Kirk's assassination. These people are unwell, and unhinged. Remember them. Why? Because if they cheer the death of good men and women they disagree with, they'll cheer when gun owners like you and me are slaughtered too.

#### Antifa in the crosshairs

I welcome President Trump's proposal to brand "Antifa" as a terrorist organization. They've long enjoyed the protection of fellow travelers in the deep state. After all, if the FBI wanted to shut them down, they would have been locked up along with those who fund them. Instead, the deep state protected Antifa. But not any more.

**Oral arguments in gun ban coming soon!** September 22 remains our big day to argue

our case against the gun and magazine ban. The group of plaintiffs Guns Save Life is a part of have ceded our time to the Department of Justice Civil Rights Division head Harmeet Dhillon. We expect Ms. Dhillon to bring not only fire and brimstone to the three-judge panel, but also the weight and gravitas of the US Department of Justice.



And just so there's no confusion, she'll be arguing to strike the law down - and she's not from the Biden administration.

I'm optimistic either way. If they rule in our favor, Kwame Raoul will ask for an *en banc* review. That's where the entire Seventh Circuit Appeals Court panel will take a look at the three-judge panel's decision and decide whether or not they want to overturn it.

Before the US Department of Justice came along with their "Friend of the Court" brief I thought we would probably lose at the *en banc* level. Now, I think we'll win there but it will be close.

#### **Crime and Chicago**

It looks like the feckless duo of Mayor Birdbrain and Gov. Pritzker have dodged a bullet. President Trump has sent a surge of federal law enforcement to Chicago to root out criminal illegals and other really bad hombres, but Trump has not pulled the trigger on troops.

It's okay. Trump knows it's just a matter of time before something really horrible happens that will give him carte blanche to ignore the radical leftists in charge and clean things up.

Flashback JB Pritzker: "Republicans should know no peace"

#### OF COURSE: Shameless Illinois Gov. Pritzker blames Jan. 6th and Trump for Charlie Kirk assassination

(The Center Square) - Popular political activist and Illinois native Charlie Kirk was shot and killed Wednesday while at a public outdoor event in Utah...

Illinois Gov. J.B. Pritzker was asked about the shooting at an unrelated event Wednesday, before news broke that Kirk had died.



Pritzker said political violence is not acceptable. "We saw the shootings. The killings in Minnesota. We've seen other political

violence, occur in other states. And I would just say, it's got to stop," Pritzker said. "And I think there are people who are fomenting it in this country."

Pritzker said Trump's rhetoric "often fo-

State Rep. Adam Niemerg, R-Dieterich, said he is devastated at the news.

"Charlie Kirk had a young family, a wife, and it looks like they'll never see him again all because some deranged individual couldn't have a conversation with Charlie up on stage and have a political discourse and have a productive conversation," Niemerg told The Center Square.

To Pritzker's reaction that included commentary about Trump and Jan. 6 defendants being pardoned, Niemerg said he's appalled.

"Let's not forget, and this is awful, Governor Pritzker said 'Republicans should know no peace,' and look at the situation that we're in," Niemerg said.

## **POLICE LINE DO NOT CROSS**

#### Pritzker & Birdbrain Johnson call for more 'peacekeeper' funding despite many crimes committed by so-called 'peacekeepers'

(The Center Square) – As Gov. J.B. Pritzker and Chicago Mayor Brandon Johnson push for more community violence intervention funding from the federal government, two anti-violence workers have made news for alleged criminal actions.

Prosecutors say seven men are charged with murder after a crash-and-grab burglary led to a crash and killed a motorist on Michigan Avenue in downtown Chicago last week.

CWB Chicago reported that one of the men charged works as an anti-violence peacekeeper. Keller Mc-Millan, 35, also has three outof-state fugitive warrants and an in-state warrant.

CWB said another anti-violence worker was sentenced to 22 years in prison for carjacking three vehicles and shooting one of the victims in the leg. Jamari Edwards, 22, received the sentence last

CWB said Edwards worked with anti-violence groups CeaseFire and Crushers

Crusher's Club's chief program officer declined an interview request for this story, saying the group is in a "scheduled pause" for external interviews...

Retired Riverside. Illinois Police Chief Thomas Weitzel said many so-called "peacekeepers" have criminal backgrounds.

"When you see these individuals being arrested by [Chicago police] and they're also participating in violent crimes, I mean, what does that say?" Weitzel asked.

Pritzker and Johnson have repeatedly called for President Donald Trump to restore funding of anti-violence programs...

Weitzel said there is no data to reflect the performance of anti-violence interruptors.

"How about actually committing crimes while they're working, or profiting from tax dollars? Let's face it. It's a jobs creation program. That's what this is. I wouldn't even call this violence interruption or whatever legal name they use, 'the peacekeepers.' This is a job creation program by Mayor [Brandon] Johnson and Governor Pritzker to, what they feel, put people to work, get them on a steady paycheck, maybe," Weitzel told The Center Square.

Illinois, Cook County and Chicago taxpayers have spent hundreds of millions of dollars on anti-violence programs over the years. Pritzker's office announced the Illinois Office of Firearm Violence Prevention has spent more than \$375 million to "reduce violence and support Community Violence Intervention (CVI) programs."



#### This is our 'Turning Point'!

Like many other Christian
Conservatives in America
and around the world, the
shocking news this past week
of the co-founder of Turning
Point USA (TPUSA), Charlie
Kirk being publicly assassinated has been really gut
wrenching to say the least.

Watching the horrific violence take place, listening to podcasts, and reading about the events and the assassin have been just beyond surreal.

It just doesn't seem possible does it, that in the United States of America, a conservative personality could be murdered in public while holding a microphone debating freely with those he disagreed?

Charlie Kirk was just 31 years old - only one year difference in age than my youngest son.

He had started a beautiful family with his young wife, Erika. Married in 2021, they already had two children – a daughter born in August 2022 and a son born in May 2024. Then this young family's life was shattered on September 10th, 2025 in front of them.

Kirk was born in Arlington Heights and raised in Prospect Heights – both Northwest suburbs of Chicago.

He briefly attended Harper College in DuPage County before dropping out after one semester in 2012 to pursue his future as an activist for good. Kirk was supported by another local activist, Bill Montgomery from Lemont, Illinois.

Bill not only was the other co-founder of TPUSA, but he was also Charlie's mentor and served on the Board of TPUSA until 2019. Bill knew almost instantaneously after hearing Charlie speak in DuPage, that Kirk had a great future ahead of him, but it wasn't in the classroom.

Charlie needed to get out and speak to others on college campuses about conservative principles.... And so, it began.

Kirk would gain his prominence through college campus events like his "Prove Me Wrong" debate tables and initiatives such as the Professor Watchlist. He later expanded TPUSA to Turning Point Action (2019) and

Turning Point Faith (2021) to engage religious voters.

In 2020, Kirk launched his own podcast, "The Charlie Kirk Show" which amassed from 500,000 – 700,000 daily downloads by 2024. He then went on to launch "Charlie Kirk Today" on TBN in 2025.

Charlie advocated for free markets, limited government. He was in opposition to abortion, gun control, DEI and the LGBTQ+ agenda.

For that he was assassinated on the college campus of Utah Valley University speaking about these same conservative principles.

In fact, what are the odds, that someone asks Charlie a question, about transgenders and violence at the time of his murder? The question was: "Do you know how many (transgender) mass shooters there have been in America over the last 10 years?"

Hundreds of tributes and vigils across our nation and even the world have honored Charlie Kirk, a great man and martyr. These include the one I attended in Lemont, Illinois where Bill and Charlie began the journey.

But the real emotions that sparked 32,000 new requests to TPUSA were ignited by the fire coming from Charlie Kirk's widow, Erika, as she addressed the public and the "evildoers responsible."

"They killed Charlie because he preached a message of patriotism, faith and of God's merciful love. But they should all know this. If you thought that my husband's mission was powerful before, you have no idea," she said. "You have no idea what you just have unleashed across this entire country."

As Erika concluded, "I'll make Turning Point USA the biggest thing that this nation has ever seen." Adding, "I love you, baby. Rest in the arms of our Lord."

## Western Journal: Over a third of school shooters since 2020 were transgendered

(PJ Media) - The Western Journal analyzed numbers and states that data indicates 40% of school shooters since 2020 have either been transgender or "trans-suspected."

It is undoubtedly true that a disproportionate amount of violence has arisen in recent years from LGBTQ identifying people. Robert "Robin" Westman, the Minneapolis Catholic school shooter, is unfortunately one in an ever-lengthening line of transgender shooters and domestic terrorists. In fact, the very day after the Minneapolis school shooting, a transgender person in Massachusetts murdered the father of a young child. But according to Western Journal, school shooters in the last five years have particularly shown a trend of transgender violence.

My colleague Matt Margolis analyzed the statistics and determined that transgender individuals are between twice as likely and five times as likely to be mass shooters as the general population. Meanwhile, Western Journal's "deep dive" behind its paywall is titled, "Since 2020 Roughly 40% of Successful and Would-Be School Shooters Were Trans or Trans-Suspected, Data Shows." It is unclear exactly what the latter term means, if it refers to LGBTQ individuals who are not explicitly transgender or something else.

Gays Against Groomers (GAG), which focuses on protecting kids from woke sexual grooming, picked up the story on transgender school shooters. "Despite making up less than 1% of the population, trans individuals account for roughly 40% of successful and would-be school shooters since 2020, data shows," GAG cited the deep dive. 

#### Our friend Jay: A decorated American hero

Generally I hate obituaries of my friends; they remind me that I won't see that person again. But obituaries can be really important even if they make you sad.

Jay Harvey Lavinsky was a "gun guy." But not like you and me. He carried an M1 Garand, and sometimes was called upon to heft a much-heavier Browning Automatic Rifle. Jay didn't mind; he was what was termed a "scrapper" - willing to fight at the drop of a hat. Born in Philadelphia, August 21, 1924, his father Irving was a secondgeneration Russian immigrant and an antique dealer. His mother Pauline, a Jewish immigrant from Rumania who speaks Yiddish, immigrated at age nine 1906. Pauline is terrified that the Germans will capture her Jewish son. A family friend in Philly is like an uncle to Jay - Barney Lebrowitz, who boxed under the name of "Battling Levinsky" and was once light heavyweight champion of the world. Jay gets as much pugilistic guidance as possible from Uncle Barney before his Army induction March 20, 1943, some 5'9" tall and 158 pounds.

Jay arrived in Company B, 39th Infantry Regiment on October 16, 1944 in a truly miserable hellhole, the Hürtgen Forest on the German-Belgian border. Over the next several months, the American Army will suffer 33,000 casualties here. The 39th hadthe motto of AAAO (Anyplace, Anywhere, Any Time, Bar Nothing) that the soldiers stenciled on their helmets. Junior officers added their own interpretation to the motto that they could kick the ass of "Anybody, anyplace, any time bar none." Jay fit right in.

At the Hürtgen, Jay won a Bronze Star for valor. In early December, the battalion headed to Merode Castle - built in 1263 with five-story towers, and surrounded by a wide moat with 7-foot-deep, cold water. There's one entrance – a narrow bridge twelve feet wide, covered by machine gun fire. Inside the castle, paratroopers of the Luftwaffe's 3rdFallschirmjäger Division were waiting to kill anyone coming in. But they couldn't stop Jay and his buddies. Later it was the Battle of the Bulge, where Jay won another Bronze Star for valor.

Then came January 30, 1945. Jay's third platoon will attack uphill near Kalterherberg, Germany. The weather's dismal: high – 32°, low – 10°; overcast, high winds. The snow is over two feet deep.

German machineguns, nicknamed "Hitler's Buzzsaws" by the troops, cut platoon leader Lieutenant Louis Benoist almost in half and he dies in the snow, never to see his four-month-old son. Israel Reese on a BAR tries to fire, but is exposed too long, and killed by a burst of fire to his head. Kenny Seaman - from Mattoon, Illinois -Deloss Bradshaw, Gordon Vickers, Albert Harms, Meyer Christal, and John Rodrigues are wounded. Machine gun bullets break John's wrist and penetrate his chest; he'll be hospitalized until July 1945. A bullet hits Albert in the face, another to Gordon's hand, while another causes a compound fracture of Meyer's leg. Kenny's arm is mauled; he'll be in hospitals for six weeks, but then it's back to the front. Grenade shrapnel wounds Deloss in the face. Mac MacLean - from Peoria, Illinois - is hit in the head and captured. Liberated from

Stalag VI G in April, he survives dysentery and body lice, weighing 92 pounds. As the Germans have taken his boots and given him wooden shoes that provide no insulation, he also has frostbitten feet.

For Private First Class Lavinsky, February 28, 1945 is even worse. In the dark, the platoon advances through a village. Jay and foxhole buddy Harry Nodell, nick-named "Noodles," are clearing a street. Jay cautiously leads part of the squad, supported by a bazooka team, down the left side, hears German floating up from a basement window, grabs a grenade, pulls the pin, and tosses it into the dark room. On the right side, Noodles spots a German half-track and approaches the vehicle, which machine-guns him with a lethal burst. Jay runs to his fallen comrade on the hard cobblestones, holds him, and screams: "Listen you son of a bitch; you better not die on me!'

Harry looks into Jay's face, winks, smiles, and dies in his arms, never to see his two young daughters again. Jay will go several days before a change of clothes is available to swap for his blood-soaked uniform - drenched with the blood of his closest friend in the world. Meanwhile, another soldier checks out the basement room, and reports to Jay that his grenade had killed five Germans - a father, mother and their three children.

Four days later, Jay's luck runs out, as machine gun rounds strike him in the stomach, lower back, groin, pelvis, both legs, and a foot. A medic considers giving Jay enough morphine to put him out of his misery, as he obviously is dying, but instead Jay is evacuated to a series of hospitals and survives!

After the war, Jay thought about ending his life, but he didn't. He couldn't forget what had happened when he threw that grenade. As he told a young family member: "If you are in combat, that stays with you for your whole life, no matter what type of person you are, or where you push it." I met Jay in 2019; he remembered his friend - my father - in his squad. In 2023, Jay sustained a severe fall and concussion, requiring constant care to eat, bathe, climb into a wheelchair, and back into bed. Seeing his need, the Veterans Administration rode to the rescue like a modern-day cavalry, admitting Jay to their long-term hospital in West Palm Beach. Jay died there, surrounded by other veterans, at age 101 on September 4, 2025.

When I heard the news the next day, I

#### The Failure of the Defensive Mindset

When you choose defense as your only option it becomes a recipe for eventual, but certain, failure.

by Paul Markel (Shooting News Weekly) -'Never throw the first punch' and 'fire only if fired upon' are two pieces of pseudotactical advice thrown out so often that people now merely parrot the phrases without ever thinking about what they mean. Parents tell their kids "never throw the first punch" and military officers issue orders for their troops to 'fire only if fired upon.'

In both of the previous examples, the parent or the military officer, neither party is likely to be in actual

physical jeopardy when their advice is applied. Nonetheless, telling others to exercise restraint, even to the point of putting themselves in harm's way, is on its face both reasonable and civilized. You see, in a perfect world where the first punch doesn't maim you and the first incoming rounds don't kill you, exercising restraint puts one on the moral high ground. But, is that strategy valid or does it simply embolden and enable the aggressor?

The Shield and the Sword "The purpose of fighting is to

win. There is no possible victory in defense. The sword is more important than the shield and skill is more important than either. The final weapon is the brain. All else is supplemental." That's one of my favorite quotes from renowned American author John Steinbeck, Jr. and one I have related innumerable times during training courses.

In those few sentences, Steinbeck sums up the basic mental strategy of combat whether it's with a fist, a sword, or a gun. As simple and straightforward as it may seem, Steinbeck's uncomplicated advice is lost on far too many who would issue orders and or give instructions to others for dealing with conflict.

No soldier would go to war with only a shield in their hands. No matter how stout the shield, the enemy would eventually overwhelm it. With the shield defeated and no sword in hand the soldier would have no option but defeat and destruction.

There are those who would put all their faith in the seeking of shelter and cover from aggression or attack. Rather than go be aggressive, they take cover hoping that the attacker will eventually tire and go away. While the use of cover, from both theoretical and practical aspects is often prudent, it must be understood that all cover is temporary. A determined enemy will eventually overwhelm or circumnavigate your cover and defeat

We use cover as a temporary tactical device to offer protection while we strategize and prepare our attack. Hiding behind cover perpetually, as a means of avoiding the fight is naïve and from a tactical standpoint, potentially fatal.

The thought process of today's civilized Americans is that defense is acceptable and moral, but anything overt, proactive, or an action that is deemed "offensive" is unacceptable, immoral, and just "bad". Of course, this thinking flies in the face of reality.



First Punch Failure Going back to the "never throw the first punch" advice, we're assuming that the first punch thrown isn't going to knock you senseless, unconscious, or break your jaw or nose. As a fighting strategy, I would not recommend giving Chuck Liddell (or insert your favorite MMA guy here) the first punch in a fight. Professional fighters aside, neither would I recommend letting the 250 pound belligerent drunk punch you before you decide to act. That first punch might be the last and only one they need to deliver.

The idea or advice that you should never draw your gun

unless you know you are going to shoot is still floating around out there. This advice causes the person in danger to move far too slowly when dealing with a threat and also makes them pause and second guess themselves. Both of these issues can prove fatal in a fast moving violent attack.

The folly of "only fire if fired upon" is that it assumes the person(s) shooting at you is (are) incompetent or will deliberately miss you as a gesture of fair play. It only takes one, single bullet to ruin your day and life. Also, unless you are the Captain of a warship, we do not fire "warning shots".

Translated Mental Attitude While you may never be in a position to either throw the first or second punch or return fire, the mental attitude that defense is acceptable, but proactive action is wrong still pervades, even in the subconscious.

The lawful citizens, those with families and careers and reputations to uphold, will cling to the strategy of defense as their default for all matters or problems they encounter, not just physical combat. These 'civilized'

Why is an 18-time felon still on America's streets?

#### 18-time convicted felon charged with burglarizing one of the most exclusive homes in Chicago

Chicago (CWB Chicago) -An 18-time convicted felon is now accused of scaling more than 10 floors to burglarize one of Chicago's most exclusive private homes while the owners were asleep.

Prosecutors say 46-yearold Robert Berry entered a residence in the 200 block of East Lake Shore Drive GunNews Magazine - 10 - October 2025

around 3 a.m. on August 19, 2025. The block, which includes the landmark Drake Hotel and a row of early 20th-century luxury co-ops, is one of the most expensive stretches of real estate in the city. The victims' home was recently on the market for \$8.4 million.

Judge John Hook ordered Berry detained, citing what he called an "extremely lengthy criminal history." Records show Berry has been arrested in Chicago more than 25 times since 2015 and charged with felonies 18 times since 2001. His convictions include narcotics, arson, burglary, theft, and at least seven separate shoplifting cases between 2011 and 2024.

# Ignored by media, enabled by Dems: How soft-on-crime policies unleashed murder of Ukrainian refugee Iryna Zarutska.

(Just the News) - According to most legacy mainstream news outfits, the horrific murder of Ukrainian refugee Iryna Zarutska was not worthy of a headline. The attention from "MAGA influencers seeking to elevate the issue of violent urban crime and accuse mainstream media of under-covering" is instead the focal point of reporting by outlets like Axios.

On August 22, Iryna Zarutska, a 23-year-old Ukrainian refugee who escaped war to start anew in the U.S., was viciously stabbed to death with a pocket knife in what appeared to be a random attack on a Charlotte, North Carolina light rail train. The suspect, 34-year-old Decarlos Brown Jr., a homeless black man with a long history of evading serious charges due to mental health claims, was apprehended and charged with first-degree murder, fueling public outrage over lax crime policies and judicial failures.

The media blackout was shocking to many in the independent news sphere. The murder

took place two and a half weeks ago, on August 22. CNN, Reuters, The New York Times, Associated Press, NBC News, ABC News and The Washington Post took 17 days to report on it. It took North Carolina's Democrat Mayor Josh Stein the same amount of time to comment on the murder.

#### Leftists try to flush Zarutska's murder down the memory-hole

Wikipedia is under fire for trying to remove a page about the murder. Editors at the site are feuding internally after attempts to suppress the story by proposing the newly created page about Zarutska's killing be deleted, arguing it lacked sufficient notability for inclusion.

Critics, including Elon Musk, who called the murder a "hate crime," and Piers Morgan, who condemned the "senseless, unprovoked" murder, have slammed Wikipedia's deletion attempt as censorship, pointing to minimal mainstream media attention.

The radio-silence from traditional media up until Monday reflects a broader attempt to ignore crime when the victim is white and the alleged perpetrator is black.



In another instance over the weekend, beloved Auburn University veterinary sciences professor Dr. Julie Gard Schnuelle was hacked to death with a machete while walking her dog in Kiesel Park, Alabama—a location she frequented daily. The 59-year-old retired professor's red Ford F-150 truck was stolen by the attacker. The following day, a black male, 28-year-old Harold Rashad Dabney III from Montgomery, was arrested and charged with capital murder after police located the stolen vehicle nearby and linked him to the homicide.

#### Nothing to see here, move along

Schnuelle, who was white, was found murdered on Saturday, September 6... The first legacy media outfit to publish any original reporting appears to be Newsweek, which published their own story on Monday afternoon. White House Press Secretary Karoline Leavitt held a press conference Tuesday afternoon, dressing down the mainstream media for not reporting on Zarutska's murder in a timely manner.

#### The media blackout helps hide the softon-crime policies of Democrats

President Donald Trump posted a video to his Truth Social account criticizing the policies he believes contributed to the issue: "For far too long, Americans have been forced to put up with Democrat-run cities that set loose savage, bloodthirsty criminals to prey on innocent people. In every place they control radical left judges, politicians and activists have adopted a policy of catch-and-release for thugs and killers."

Charlotte is one of the most dangerous cities in America, yet does not receive as many mentions in crime conversations as cities like Chicago and San Francisco. Charlotte's total crime index is 45.99 incidents per 1,000 residents. Violent crimes, including assault and robbery, occur at a rate of 7.46 incidents per 1,000 residents, which equates to a 1 in 134 chance of victimization.

Charlotte, where Iryna Zarutska was murdered, is led by Democrat Mayor Vi Lyles. Lyles initially downplayed the murder, and showed deep compassion for the killer, who had been arrested and released 14 times before the killing. "We will never arrest our way out of issues such as homelessness and mental health," Lyles said. "Mental health disease is just that — a disease like any other that needs to be treated with the same compassion, diligence and commitment as cancer or heart disease."

Her initial comments never mentioned Iryna Zarutska.

## LARGER THAN LIFE: BILL OGLESBY

[Editor: The following was a letter written to The History Channel by an attorney from Louisiana. He saw our story on Bill Oglesby in GunNews and shared this with us. We're reprinting it because, well, it's just that good.]

by Sydney Horn, Attorney at Law (GSL) - I am one of Bill Oglesby's students. You have had Bill perform various shows on your channel, but you haven't touched on his real talent.

I have seen Bill do the following shooting feats, which are more interesting than what you have had him do for your show.

- 1. Bill is the first man who has ever done the double-tap from a single-action pistol. That is, shoot two shots so fast you only hear one bang. He does not fan the gun, as some people call it. Bill can do this with either his right or left hand. He can do it with two hands holding the pistol normally, and he can do it holding the pistol upside down.
- 2. Staging: Bill has his pistol in his holster. He also holds a deck of cards in his left hand. There is also a metal plate standing 5 yards away. Action: He announces that he will throw the cards in the air. Then he will draw his pistol and shoot the plate, and then the ace of spades while it is in the air. He also informs me that he has placed the Ace of Spades on the bottom of the deck; otherwise, he would not know which card was the Ace of Spades once he threw them in the air.

By placing the Ace on the bottom of the deck, he told me that when he throws the cards in the air, the Ace will be the bottom-most card. He then asked me if I was ready, and I said yes. He threw the cards in the air with his left hand, then he drew his pistol with his right hand and shot the plate, and then the card. I heard two bangs.

When he got through, he asked me to approach him. He said, "Hold out your hand." Which I did. He ejected "4" empty shells into the palm of my hand.

I said to Bill, "I only heard two shots."

He smiled. "Look at the plate."

There were two bullet impacts on it. Bill then told me to find the Ace of Spades. When I found it, there were *two* bullet holes in the card

I would have thought it was impossible if I had not witnessed it.

3. How about putting a black dot on a golf ball, throwing it up in the air, and then shooting a .38 caliber bullet into the dot with his Winchester 1892 rifle? Yes, he hits the black spot while the ball is spinning in the air.

I asked him how he did that, and he said, "I can see the dot." I guess he is like Ted Williams, who claimed he could read the writing on a baseball that the pitcher threw to him.



He can also play what he calls Cowboy Golf. He throws a golf ball in the air, shoots it with his rifle, and makes the ball hook to the left or slice to the right.

[Editor's note: I've seen him do this with a single-action revolver shooting from the hip. And he called it as a hook, slice and straight away before he throws the ball.]

- 4. Bill can also shoot three balloons spaced about 3 feet apart with his pistol. This is called the triple tap. In other words, he shoots all three balloons with three bullets, but you only hear ONE BANG. He does not use blanks or rat shot, and the balloons are more than 5 yards away from him. He does this with two fingers of his left hand.
- 5. Have you ever seen Bill play Russian Roulette? He can put one cartridge in the cylinder and leave the other 5 empty. He then spins the cylinder until you tell him to stop. He then pulls the trigger, and the gun goes off. Or he can put 5 rounds in the cylinder and leave one empty, spin the cylinder until you tell him to stop. He then pulls the trigger, and the gun goes click on the empty cylinder.
- 6. Bill holds the world record for speed shooting. Yes, he is faster with a single action than Jerry Miculek with a semi-auto. At the sound of a timer, he has shot 5 9" metal plates in .82 seconds. He has also shot 5 shots from his single-action pistol in less

than .45 seconds. My best time for shooting 5 shots and knocking down 5 plates is 1.03 seconds, and I have only done it one time. All of these shots, made by Bill, require a timer, including reaction time. That means the timer does not start with the first shot. The timer starts with a beep, then the shooter reacts.

- 7. Bill also shoots a 1897 shotgun with speed. How about loading two 12-gauge shotgun shells in the shotgun and shooting both so fast you only hear one bang. One of the guys who worked for him said he had done it with 3 rounds. Ask him to do that for you.
- 8. With the high-speed cameras you have, you could even show what a double-tap looks like with one bullet following another as they exit the barrel.
- 9. How about Bill taking a Ruger .44 Magnum? He wraps his shooting hand with tape on the pistol grip so he can't use his thumb. He then fires two rounds, performing a double tap using just the recoil of the 44 magnum to cock the gun and fire the second shot. Two shots and one bang. One-handed.
- 10. Fast draw: Bill can do that, also. Stand in front of Bill with your hands apart in front of you, palm to palm, and see if you can clap your hands before he draws his empty pistol. I have drawn against Bill with empty guns, facing each other. When he draws first, I never get my gun out of the holster before his hammer falls. Remember the gun is empty, but you can hear the click as the hammer falls. If I draw first, we both would die, but Bill is quick enough that his gun goes click almost at the same time my gun goes click.

These are just some of the things Bill Oglesby does that I think are much more interesting than watching him shoot a hangman's rope. Yes, that is hard to do, but not as amazing as the shots described above. Splitting a bullet, yes, that is not easy, but again, the above are more interesting. If you want to be entertained, let Bill do some talking to the audience. He is really funny and puts on a great show.



Bill often calls up members of the audience to verify what he says about the gun before or after his shots.

BILL OGLESBY IS THE BEST SINGLE-ACTION PISTOL SHOOTER THAT HAS EVER LIVED.

He once went Quail hunting at a famous ranch and hunted with a .22 rifle. The owners thought he was crazy, and they bet him he would not hit one bird. They lost the bet.

I have personally seen Bill do all of the above. I think your viewers would like to see Bill shoot. His skills need to be recorded for history.



Police believe that when the suspect entered that bedroom, the woman opened fire, striking him in the head. The suspect was pronounced dead on the scene...

The suspect was wearing gloves and had a screwdriver at the time.

## One third of college students would use violence to suppress opposing views

Almost 75% support 'Heckler's Veto'

(Just the News) - College students are growing more tolerant of using force to stop viewpoints they dislike, and less tolerant of campus visitors with viewpoints at either end of the political spectrum, according to an annual survey of nearly 70,000 students by the Foundation for Individual Rights and Expression and College Pulse.



More than a third of students would "at least

rarely" accept the use of violence to stop a campus speech (34%), 10 percentage points higher than its 2021 survey, while majorities would block other students from attending such a speech (54% versus 41% in 2021) and shout down a speaker (71% from 66%), all "record highs."

"For the first time ever" since it started the surveys, expanding from 55 campuses in 2020 to 257 in this report, most students say their schools should block speakers who hold any of six views associated with the left or right on hot-button cultural issues, FIRE said Tuesday.

The view they are most

willing to tolerate is "Children should be able to transition [identify as the opposite sex, socially or medically] without parental consent," the only one of the six to command a majority in last year's report. This year it's 49%.

The least likely to be tolerated: "Black Lives Matter is a hate group," at 24%. The others: "Transgender people have a mental disorder" (25%), "The Catholic Church is a pedophilic institution" and "The police are just as racist as the Ku Klux Klan" (both 38%), and "Abortion should be completely illegal" (40%). Each fell several points from last year.

#### Illinois needs old-fashioned 'Criminal Justice Reform'

(GSL) - The radical Democrats running Illinois government have given us plenty of bad public policy of late. Many of those poor public policies are leaving us at the mercy of criminals. Our legislative "leaders" given us gun and magazine bans that impact only the law-abiding. We have "No Cash Bail" which releases most of those arrested within hours without even pinkie swearing to behave.

Perversely, the same law allows suspects to be held until trial which, if you've used force in self-defense, you may get stuck in jail waiting months to go to trial. That will financially cripple your family.

We've got political leaders in Illinois seeking to cap prison sentences at 20 years - including retroactively slashing sentences of those already convicted and sentenced of the most heinous and horrific crimes.

There's plenty more, including decriminalizing some offenses which have given us more crime. Crime without consequences means more crime.

Instead of soft-on-crime approaches, maybe it's time to hold criminals accountable. Put them in prison for real time for serious violent crimes. Restore bail to allow people to post bond to secure their pre-trial release. And institute a three-strikes and you're out law that puts three-time violent felons in prison for at least a generation or two.

Some say we can't arrest our way out of violent crime. Tell that to El Salvador. They arrest violent gang members and incarcerate them. Within months, violent crime plummeted and kept falling. That nation's murder rate dropped 98% over ten years, making it one of the safest nations in the world today.

Here at home, Florida instituted 10-20-Life back in the late 90s. Have a gun, you got ten extra years. Shoot your gun, that'll cost you twenty extra years. And if anyone is wounded or killed, you earned an extra 25 years to Life in prison. No plea-bargains, no credit for good time and no other "discounts."

Within three to four years, firearm violent crime in the Sunshine State dropped to historic lows. Then the courts ruled the law unconstitutional, and firearm violent crime edged up again. Yet it still remains low, *especially* compared to Chicago.

Unfortunately, more policing and hard time in prison for offenders is the medicine that most Democrat politicians just don't want to swallow to reduce crime.

Until we do crack down on crime and the repeat offenders who commit the vast majority of it, we're going to get more of the same criminals victimizing the in-

Which is why each of us should carry our own defensive tools each and everyday day to make yourself harder to kill. At the same time, you must know the law of self-defense and have a legal defense coverage policy to make yourself harder to convict.

#### Minnesota spree killer: Not unique but rather a failed misfit

This is of course a reoccurring mass shooter strategy going back even before Sandy Hook.

The first unusual thing published about Robin [Redacted], was that he was apparently transgender at the time of the shooting. He was born a male, Robert [Redacted], and changed his name legally at age 17 to the female name "Robin" in court in 2020 and identified as a female.

This identity thing may be the only exceptional thing about this killer. In fact, one thing which sticks to a lot of mass shooters is their lack of notable traits or life successes. They are not special. Unfortunately, he can be viewed was just another failed human being who turned to mass murder of children to express himself.

There are a lot of social media posts today hyping about the number of transgender mass shooters (more than 4 victims), like it is a trend, but researching the identified events finds several of those suspects were not transgender, just labeled so in faulty media reports. Apparently Robin [Redacted] was transgender, but ultimately he was just another deranged shooter of defenseless people, not "special" or "unusual" because he/she was identifying themselves as "transgender.'

School killers are not successful at life, and do not have extensive love or friendships. They progressively lose connection to the world around them. Combined with mental health issues, and grievances against many people/institutions, they come to a point where they realize they will not be rich, or famous or highly sought after like people they see on TV and social media (All images forced on young people via social media). Their anger and perceived slights pile up to the point they just decide to reject trying to fit in and instead plan to go out in a blaze of self-perceived glory as their only stamp on

Moreover, they routinely suffer mental health issues too, along with trouble in school and with the police while growing up.

When planning for their day in the sun, these misfits become increasingly focused on "the plan" and have declining human contacts. They have anger issues and suffer perceived grievances towards the end of their lives.

Following many of these shooting instances people around the shooter will report how they knew the person had anger issues and was "not right."

#### MINNEAPOLIS SCHOOL SHOOTING



"Getting even with the world" against innocent targets, especially kids, is insanity. Notoriety through terror.

This shooting thing is not spontaneousthese losers study other famous shootings and make elaborate plans and gather guns, ammo and materials like a smoke bomb found at the Minnesota scene. Shooters hope for a video game-like high score when they commit their murders for their burst of fame. [Redacted] wrote the names of other mass murderers on his gear and gun. The guns appear to have been legally purchased over time- another well-known trait for school shooters.

They usually have taken drugs for mental health issues during their troubled past. There is no word yet about [Redacted]'s psychotropic drug use or psychological treatment, but it's still early.

These shooters collect and horde perceived grievances like a squirrel collecting nuts, and also leak clues like sieves before the shooting event. [Redacted] left video and written comments and a rambling manifesto (again typical behavior for a mass killer.)

The list of things [Redacted] hated included Catholics, Jewish people, children - he "loved when kids get shot" and "wanted to watch children suffer." He hated Donald Trump with a passion (wrote "Kill Donald Trump" on his weapons) and fantasized about assassinating Trump. He wasn't keen on Elon Musk and other public figures like a big executives and would kill them for a "final act" of "societal significance." Add in some Christians (He scrawled "Where is your God?" on ammo magazines.)

There is also no word yet about any past suicide attempts by [Redacted], but some studies cite the difficult Trans lifestyle has an extremely large suicide/attempted suicide rate up to 40% so they may show up in the background investigation into this heinous shooter.

[Redacted] shot himself to end the spree. This is also a very common trait of these shooters. They routinely have no life plans beyond their big moment and shoot themselves to end it, or alternately, if they are opposed by police or civilians will shoot themselves instead of being captured.

Parts of [Redacted]'s handwritten manifesto expressed regret about becoming transgendered stating "I am tired of being trans, I wish I never brain-washed myself."

Well he also brainwashed himself into believing murdering children would be a good thing to do, too.



## Los Angeles police pulls Kamala Harris' elite 24/7 protection after outcry from regular folks

(MSN) - The LAPD has dropped its around-the-clock protection for former Vice President Kamala Harris following outrage... and pressure from the city's police union.

The move comes after President Donald Trump revoked Harris's Secret Service protection earlier this year, cutting short an extension granted by former President Joe Biden that would have lasted until July 2026.

In response, Los Angeles Mayor Karen Bass had directed LAPD resources to continue safeguarding Harris, according to The Los Angeles Times.

But the decision drew criticism from the Los Angeles Police Protective League, the union representing rank-and-file officers. The union argued that officers were being diverted from crime suppression duties to provide security for a wealthy political figure who, in their view, could afford private protection.

'Pulling police officers from protecting everyday Angelenos to protect a failed presidential candidate who also happens to be a multi-millionaire with multiple homes and who can easily afford to pay for her own security is nuts,' the union's board said in a statement.

According to FOX 11, those officers were drawn from elite LAPD units typically assigned to investigative and suppression tasks

According to a White House official, a recent Secret Service threat assessment found no credible or ongoing threats to Harris, leading the administration to determine that extended protection was not necessary.








his constituents that his administration has "moved past" the country's "addiction to jails and incarceration," and that it is "racist, immoral and unholy" to put criminals in prison. What he needed and wanted from the federal government was more resources "to address gun violence in our city."

The mayor, though, failed to explain how reducing violent crime could be accomplished without the "unholy" and "immoral" expedient of prosecuting and incarcerating the violent perpetrators responsible. Johnson has also been clear that the additional resources he's asking for don't include enabling a bigger police presence on Chicago's streets.

Appearing on MSNBC's Morning Joe show last week, Johnson pointedly refused to give a direct answer to Joe Scarborough's persistent questions on whether more uniformed police officers would reduce crime, and instead doubled down on poverty and more gun control. "While Scarborough wanted a yes or no response from the mayor, Johnson evaded the question five times ... Johnson went back to his default response, telling Scarborough: 'I don't believe that just simply putting out an arbitrary number around police officers is the answer," and concluded with "the federal government could work stronger to coordinate with my police department to get guns off the street of Chicago."

The response is strangely reminiscent of Johnson's predecessor, former Chicago Mayor Lori Lightfoot. Lightfoot, another progressive who swept into office in 2019 on a landslide vote, was ousted in an election where public safety – specifically, runaway crime – was the dominant issue. Throughout her tenure, Lightfoot conflated the city's crime problem with a gun problem, and spoke of firearms as if they were divorced from the criminals who used them. Because Illinois already has some of the most restrictive gun control laws in America, Lightfoot's preferred talking point was the need for more "sweeping and aggressive gun control" at the

federal level. Blaming the federal government for Chicago's violent crime conveniently absolved her city government from accountability.

Another official, former Cook County State's Attorney Kim Foxx, has gone beyond the rejection of incarceration with her own wacky ideas on "non-punitive justice." Foxx, who as Chicago's chief prosecutor embraced "de-prosecution" strategies like dropping felony cases and declining to prosecute misdemeanors, aired her latest musings on the criminal justice system. As reported by CWB Chicago, her progressive vision includes "reimaging[ing] institutions, where we build systems of accountability that are not punitive," moving "from justice to impact," and normalizing the acceptance of crime as a collective benefit for society at large. "What if we became willing - strategically and morally to absorb some harm in service of a greater good?" Arguably, the only thing even more bizarre was Illinois Governor J.B. Pritzker's August 22 pronouncement on X listing three "Things People are Begging for," with no. 3 being the "release of the Epstein files" and no mention of less crime or safer streets.

#### **On-Brand for Anti-Gun Democrats**

All of this is on-brand for anti-gun Democrats. Ostensibly decrying crime while advocating the defunding of police, non-incarceration and other "non-punitive" justice, and a hellish vision of the "greater good" is all of a piece with demanding more federal resources and rejecting those resources (law enforcement support through federal policing) as "uncalled for, and unsound," to quote Mayor Johnson. Another Illinois Democrat reformer of the criminal legal system and Giffords-endorsed gun-grabber, Lt. Gov. Juliana Stratton, had the gall to describe the potential federal crime-fighting deployment as a showdown over fundamental freedoms, assuring citizens that she would "stand for your rights, your freedoms, and will protect you against whatever storms of hate and fear come our way."

This kind of empty, performative political maneuvering is likely the reason why the approval rating of the Democrat Party has tanked to a historic low: 63 percent of voters now hold an unfavorable view of the party, seeing it as disconnected from and uninterested in the needs of ordinary citizens and working people. Instead of recognizing these viewpoints are a political liability that has cost the party voters and seats, leftist politicians remain committed to the delusion that undermining the criminal justice system and championing gun control is the route to political success.

## Dehumanization: How the left justifies attacking and killing conservatives

(PJ Media) - While it is impossible at this point to understand everything, there has been a clear pathway to this point. Working backwards, Charlie was shot for what he believed, for his speech. The shooter's motives haven't been detailed yet, but given the reaction among the assassination's celebrants collectively, a disturbing number of people felt Charlie deserved to be killed for his beliefs.

Civilized and otherwise normal people can't come to this juncture unless someone convinced them that certain beliefs and certain speech are dangerous enough to cause individual and mass harm. In other words, if I can convince you that people will die because of the kind of things Charlie has said, then I can lead you to conclude that something had to happen to stop that "dangerous" and "harmful" speech.

But that alone isn't enough. Normal people don't advocate for the killing of non-violent people just for the things they say. That's why some of the most evil and shrewd operatives walking on this planet know that to win acceptance of murder as an activist tool, they must first dehumanize their targets.

This has been building for years, and it has been particularly strong since Donald Trump became president. As early as 2016, it was largely accepted that anyone wearing a MAGA hat in public was subjecting himself or herself to physical and verbal harassment and assault

Turning Point USA volunteers learned to expect that their detractors on college campuses would get into their events and cause scenes, and not infrequently attack them and vandalize their tables, tents, and displays.

Trump has been called "Hitler" and a "fascist" so routinely that, in the leftist bubbles on social media and in the legacy media, those words are branded to him and the MAGA movement at large.

Since it seems the only period of history that matters to the left is Germany in the 1940s, let's look at this through the prism of what the Nazis did to dehumanize the Jews, which ultimately convinced regular Germans to tacitly

condone the atrocities that followed.

Propaganda framed the Jews as subhuman and parasitic. Newspapers and movies branded the Jews as rats. Powerful posters and language from speeches contained messaging that these "subhuman" Jews were the enemies of humanity and deserved extermination.

The Nazi Party conducted a sustained campaign. It wasn't spontaneous or sporadic. It was concerted, focused, and used to achieve a larger objective. One fueled by hate and a desire for complete dominance over society.

Even someone schooled in America's public education system in the 2010s knows that World War II happened and there was this fascist named Hitler. What they most likely don't realize is that the kind of psychological manipulation used on the Germans 85 years ago is now happening to them. They don't realize that in this case, they are on the side of those who would dehumanize others.

All a conservative needs to do today to be dehumanized by this movement is to speak out for Christianity, or for Donald Trump, or against DEI, or for conservative values, or for Israel and the Jews.

Do that and you've made yourself less than human in the eyes of screen-addicted, SSRI-addled, post-COVID leftists who can no longer distinguish between reality and fiction.

That's how we got to this point, where young liberal women who are not the kind of people you'd find at an MMA match can, at the same time, find themselves posting social media videos of themselves that revel in the spilling of blood among anyone who doesn't confirm their worldview.

Dehumanization. Conditioning. It's real, and it's intentional. PJ Media's Jamie K. Wilson dug into this in her own report on how the left is now revealing itself for who it is and what it is. But behind all of it are the messengers, the strategists, the ones who give the politicians and the news media their lines. They are the masterminds of the systemic dehumanization of conservatives. This can no longer be ignored.

## Escalating leftist political violence a danger to us all

Spot on. The shocking shooting of Charlie Kirk at a Turning Point USA event at Utah Valley University is not an isolated incident but part of a deeply troubling pattern of escalating leftist political violence. It follows at least two, possibly three, documented assassination attempts on Donald Trump during the recent election period, each carried out by leftist radicals. Taken together, these events reveal a dangerous trend where ideological extremism is moving from online outrage to real-world attacks. Charlie Kirk, as the face of Turning Point USA and a leading advocate for free speech, has long been a target of left-wing hostility. Similar dynamics were at play in the murder of Iryna Zarutska in Charlotte, where racial animosity and ideological narratives combined with deadly consequences. In this environment, platforms like Elon Musk's X play a vital role in preserving transparency and open debate. Under the Biden administration, stories that contradicted official narratives were routinely buried, shaping perception while hiding uncomfortable truths. Without X, the public would have little insight into the growing wave of violence tied to political radicalization.

The shooting of Charlie Kirk is a sobering reminder that ideological extremism has real-world consequences. Prayers are with his family and supporters, but sympathy alone is insufficient. Unless the normalization of hatred is confronted and reversed, suppression and dehumanization will continue to spiral into violence, eroding the foundations of a free and civil society.



Militant Anarchists: A growing militant wing trains in weapons and self-defense, including groups such as Antifa, the Socialist Rifle Association, Armed Queers, Behind Enemy Lines, Code Pink, the ANSWER Coalition, The People's Forum, BT News, and Unity of Fields.

Climate Activism: Billions have flowed into climateactivist organizations, many of which increasingly employ anarchists.

Social & Racial Justice Groups: Since the rise of BLM, billions—public funds included—have supported the social and racial justice groups that regularly advocate for burning down the country.

Civil-Rights & Legal Orgs: Legacy anti-Western activists ("movement lawyers") staff these groups, suing governments, police, and schools while training allies to push limits without triggering terrorism charges.

**Foreign Interest Groups:** Beyond the Neville Roy Singham network, other foreign powers, including the CCP, maintain domestic footholds.

Funding: Much of the money for this revolutionary activity comes from the progressive NGO ecosystem—Open Society Foundations, Tides, Ford, Rockefeller Brothers, Arabella Advisors, and the broader dark-money network.

"We cannot be led by those who wish for America to be like it once was; instead, we must assert that America must be no more," Armed Queers wrote in a Substack post.

Armed Queers is affiliated with La Mecha. I have blogged about those assholes before- in 2007, in fact. I noted then that they had local chapters on many college campuses

Here is one of the first lines of the group's manifesto:

Chicano and Chicana students of Aztlan must take upon themselves the responsibilities to promote Chicanismo within the community, politicizing our Raza with an emphasis on indigenous consciousness to continue the struggle for the self-determination of the Chicano people for the purpose of liberating Aztlan.

There won't just be two sides in the upcoming CW. There will be all sorts of factions fighting it out. That's why I am opposed to the war that is coming- it will be a blood-



#### Stats show shocking surge in attacks on churches in America

The incidents spanned a wide range of hostile actions across 43 states. Vandalism was the most prevalent,
