'SHOOT ON SIGHT'

'Shoot on Sight' in Chicago: The price of the Left's war on law enforcement

(Red State) - Federal agents in Chicago are facing a nightmare most of us can't imagine: a violent street gang has literally issued a "shoot-on-sight" order against them. According to Customs and Border Protection (CBP), the Latin Kings have targeted immigration enforcement officers working in the city, leading the agency to warn its teams to use "extreme caution."

Shots were fired. Agents' vehicles were rammed. Bricks and paint cans were thrown at Border Patrol trucks in the Little Village neighborhood during ongoing immigration operations. This isn't happening in some failed foreign state. It's happening on American streets.

These attacks come amid Operation Midway Blitz, a federal crackdown led by the Trump administration to restore order and remove criminal aliens in Chicago. The mission is clear: enforce the law, protect

communities, and dismantle violent networks that thrive under decades of neglect from local politi-

In September 2023, the Land of Lincoln Honor Flight (LOLHF) flew of who slew of Guns Save Life referred veterans out to Washington on one of their Honor Flights. It was a tremendous opportunity for everyone involved and made for a lifetime of great memories.

We've referred a handful of additional veterans to the program since then and they too have had a great time.

LOLHF completed this year's flights and sent us the numbers. In 2025, they took four flights

of veterans and guardians. Among the veterans, 23 served in the Korean War era, and 351 Vietnam era vets took the trip. 337 guardians also paid for their own trip to escort the vets.

To date, LOLHF has flown 6223 vets on 76 flights. That's pretty good for a plucky group of self-less volunteers who not only work the logistics, but raise the money to make this happen.

If Dems want to bring male voters back, maybe stop with blaming them for crimes they aren't committing

(CCRKBA) - Recent stories at Reuters and MSNBC reveal Democrats are lamenting the loss of male voters, especially younger ones, in recent election cycles, and they are considering different strategies to bring them back. The Citizens Committee for the Right to Keep and Bear Arms has a suggestion for these Democrats. Stop pushing legislation aimed at eroding their Second Amendment rights.

"A large percentage of male voters are gun owners," noted CCRKBA Chairman Alan Gottlieb, "and they are tired of being penalized for crimes they didn't commit, and being threatened with even more restrictions simply because they choose to exercise their Second Amendment rights.

"Male voters are not going to give up their rights just to make Democrats feel good about themselves," Gottlieb continued. "They are not going to make friends with

"Democrats seem to forget that exercising the right to own a gun does not require getting permission from the government," he observed. "Rights are not subject to expensive training requirements, waiting periods or other nonsensical restrictions, including limits on the number of guns someone may purchase during a single month. These are restrictions which turn a right into a government-regulated privilege, and if you want to attract men back to the party, stop treating them like second-class citizens.

"Young male voters don't respond well to complaints about their so-called 'toxic masculinity,' either," Gottlieb noted. "They won't support a party which treats them and their rights with contempt and hostility, and let's face it, in its shift farther to the political left, the Democrat party has been doing all of these things with a degree of arrogance

and disrespect that seems deliberately designed to alienate, rather than invite, the very people the party wants to attract.

"Male voters will not support a political party which does not wholeheartedly support their rights," Gottlieb stated, "and that especially applies to their Second Amendment rights. If Democrats want to make male voters feel welcome, stop making them feel like criminals."



Executive Director's Report

Crime falls when criminals are removed from the population

Arguing with basic facts, or denying their existence might make you feel better, but it won't change reality. The sun will still rise in the East and a walnut will hurt if it falls upon your noggin from a tree thanks to gravity.

The same applies to criminals. A handful commit the overwhelming majority of crime.

If you think you can change behavior by coddling them with "no cash bail," "restorative justice" and sealing their criminal records, it won't work. They aren't going to change their ways because you're nice to them. Without real consequences, they're not going to play by the rules. And why should they? If they can commit crime without consequences, why change?

The opposite is also true. Take El Salvador, where people don't enjoy America's "innocent until proven guilty" jurisprudence. In El Salvador, they don't coddle accused criminals. They lock them up. They send the really bad ones, especially criminal gang members to CECOT prison for life. Crime there dropped precipitously. Murders dropped almost 98%. It's now easily the safest country in the Western world.

One way we can reduce crime in America is to removed illegal aliens. They came illegally, are here illegally and many are committing crimes - some horrific. They need to go.

Yet most state and federal Democrat elected officials - and even a minority of Democrat voters - oppose sending these foreign invaders home.

President Donald Trump's administration is aggressively pursuing illegal alien criminals and removing them from our streets. The results have been stunning. Homicides are down sharply, as are robberies and carjackings. We're interrupting human trafficking and child trafficking rings. 
Most normal Americans support locking up native-born violent criminals, especially career bad guys. We all want safe neighborhoods and safe streets to raise our families.

NRA 2.0: Big changes underway at NRA

this I will have completed my visits to all ten GSL chapters. I appreciate the warm welcome I received at all locations and hope my presentations gave you insight into the huge changes under-

way in the America's oldest civil rights organization, the National Rifle Association.

As of November 1st, we announced some additional changes that will improve the financial stability of the NRA. A \$24M budget cut this year will put the organization in position to finish 2025 in the black for the first time in several years. Many of the recent losses had to do with the attorney's fees in the legal battle in New York State. That legal firm has now been fired.

As many of you know, The

NRA was organized in New York State in 1871 and must live under New York's laws related to not-for-profit organizations. New York's Attorney General, Letitia James (the same one who

tried to destroy President
Trump financially) attempted to put the National Rifle
Association out of business

The mismanagement and outright corruption of former NRA Executive Vice President Wayne LaPierre was exposed and stopped. The NY court banned LaPierre from associating with the NRA for 10 years and forced him to repay \$4.4 Million dollars. With that court battle over, the NRA can stabilize our budget. Re-

More obvious changes
The most noticeable change
members will see in the fu-

ture will be a change in the group's publications. NRA is eliminating Shooting Illustrated and America's First Freedom. Much of their material appear in the American Rifleman and the American Hunter. Those magazines will

appear monthly in digital format for members, and printed copies will arrive by mail on a quarterly basis. This change will save us \$16M per year.

You will also be seeing an expanded digital footprint at the NRA, to include phone apps and increased social media presence. Younger folks prefer this sort of media and this expansion will help us reach young people.

Political messaging, media driving Illinois Democrats to radical extremes

(WirePoints) - M3 Strategies surveyed 459 likely 2026 Democratic primary election voters in Illinois from October 23rd – October 25th.

Among the key findings:

Damaging federal vehicle by scratching 'PIG' into vehicle's paint

Dem Congressional candidate Kat Abughazaleh, others indicted over violent 'protest' outside Broadview ICE facility

Chicago (CBS News) - Illinois congressional candidate Kat Abughazaleh and five other protesters have been indicted on federal charges, accused of damaging an ICE agent's vehicle while trying to block it from driving into the immigration processing facility in Broadview, Illinois, last month.

Abughazaleh and five others were indicted on two counts each: conspiracy to impede or injure a federal law enforcement officer; and forcibly impeding, intimidating, or interfering with a federal law enforcement officer while engaged in official duties.

The other defendants include Catherine Sharp, who is running for a seat on the Cook County Board of Commissioners; Michael Rabbitt, who is the Democratic committeeman in the 45th Ward in Chicago; Brian Straw, who is running for Oak Park village trustee; Andre Martin; and Joselyn Walsh. According to the indictment,

Martin worked for Abughazaleh. In addition to running for Cook County Board, Sharp is the chief of staff for Chicago Ald. Andre Vasquez (40th).

The charges accuse the defendants of blocking the path of an ICE agent's vehicle as he was reporting to work at the Broadview facility on the morning of Sept. 26.

According to the indictment, they "banged aggressively" on the vehicle's windows and hood, and "pushed against the vehicle to hinder and impede its movement." They also allegedly scratched the word "PIG" into the body of the vehicle, and broke one of its side mirrors and rear windshield wiper.

If convicted, they could face up to six years in prison for the conspiracy charges, and up to eight years in prison for the intimidation charges.

How many second and third chances do we give criminals?

General Assembly approves measure to automatically seal some criminal records

(The Center Square) – The Illinois House has approved a Senate bill that modifies the Clean Slate Act to seal certain criminal convictions

In the Senate Wednesday evening, state Sen. Elgie Sims, D-Chicago, said House Bill 1836 takes crimes that currently can be sealed by petition to allow them to be sealed automatically.

"This does not extend beyond crimes that are currently able to be sealed by petition," Sims said. "So it allows for us to deal with the backlog of cases..."

State Rep. Patrick Windhorst, R-Metropolis, who voted against the bill, questioned why it removes a provision on subsequent convictions and other changes.

"We are also removing, this bill would remove the provision requiring a petitioner to attach a negative drug test to a petition for sealing," Windhorst said.





US Attorney hammering Chicago gang violence perps with federal time

Chicago (CWB Chicago) - Federal prosecutors in Chicago have sharply increased their pursuit of violent offenders and gun crimes, with the number of firearm indictments nearly tripling under U.S. Attorney Andrew S. Boutros' leadership, officials announced. Boutros, joined by leaders from the FBI, ATF, DEA, and U.S. Marshals Service, said the Northern District has experienced a dramatic rise in both firearm and overall criminal prosecutions in 2025.

Through October 31, 2025, federal firearm indictments filed under the Project Safe Neighborhoods (PSN) initiative increased 292 percent, from 26 cases in 2024 to 102 this year, the officials said. The number of defendants charged in those cases rose from 30 to 116—a 287 percent increase. Overall, federal criminal indictments across all program areas jumped 45 percent, from 252 last year to 366 this year, while the number of defendants charged rose 52 percent, from 325 to 494, according to Boutros.

Violence is NOT acceptable. Neither is violent rhetoric.

by Nancy Hayes President Trump recently stated that violent crime in Chicago has fallen sharply since the start of a federal crackdown known as "Operation Midway Blitz".

He credited the Department of Homeland Security with driving down crime and reported that shootings are down 35%, robberies are down 41% and carjackings were down nearly 50% since the operation began several weeks ago.

Trump went on to state, "This has been achieved DESPITE the extraordinary resistance from Chicago and Illinois Radical Democrat leader-

In fact, in reality the ICE agents have faced multiple assaults, gunfire and vehicle rammings during raids in the Chicagoland area.

"Operation Midway Blitz" was launched back in September as a part of a broader Department of Homeland Security (DHS) Initiative aimed at "criminal illegal aliens terrorizing Americans in sanctuary Illinois".

We all know Gov. Pritzker and Mayor Johnson, along with many other Democrats in Illinois did NOT and do NOT support "Operation Midway Blitz".

Both Governor Pritzker and Mayor Johnson oppose large-scale immigration raids In fact, not only do they oppose the raids, but they have even been known to tacitly encourage violent resistance against ICE officers.

That's probably why it wasn't a surprise when a couple days ago anti-ICE protesters turned violent once again outside a Chicago facility. In fact, chaos erupted near the immigration processing center where agitators clashed with law enforcement ending in a dozen plus arrests and injured officers including two Broadview police officers, a Cook County Deputy and an Illinois State Trooper.

Sadly, this seems to be no surprise to most of us normal people, especially when you look upon a recent poll which showed a near majority of Illinois Democrat primary voters believe that "violence" was

acceptable to stop ICE.

The poll, conducted by M3 Strategies, surveyed 459 likely 2026 Democratic primary election voters in Illinois from October 23rd - October

Rather than uniting and showing support for America and law and order, their solution is more akin to resist Donald Trump "by any means necessary."

Furthermore, calling Trump supporters Nazis - I'm sorry that's over the top and that rhetoric needs to end. This crazy talk must stop.

As for Mayor Johnson's executive order creating ICE-FREE zones in the city, White House spokeswoman Abigail Jackson commented on these to Fox News Digital. "If Chicago Democrats spent as much time targeting criminals as they did demonizing and criticizing federal law enforcement, Chicagoans would be a lot safer. The only people who will be 'safe' in an ICE Free Zone are violent criminal illegal aliens who prey on innocent American citizens."

In closing may I remind you of what Sergeant Phil Esterhaus (Hill Street Blues) use to tell his officers at the end of every roll-call briefing: "Let's be careful out there."

Politically violent ISU teaching assistant arrested AGAIN, this time by FBI for threat to kill President Trump

Normal, IL (NY Post) - An Illinois State University teaching assistant fired for violently flipping a Turning Point USA table on campus [Editor's note: Twice!] has now been arrested for allegedly threatening to kill President Trump.

Derek Lopez, 27, was nabbed after he allegedly spewed a slew of vile threats on social media earlier this week — including one where he boldly declared, "I'm gonna kill Donald Trump," according to the feds.

In one post over the weekend, Lopez allegedly posted a video of a man pointing a gun at a graphic of Trump with a target on his head, the criminal complaint states.

According to a criminal complaint unsealed this week in the Northern District of Indiana, 35-year-old Alexander

Frances Jakeway of Valparaiso was arrested after Homeland Security Investigations' Chicago office traced a series of allegedly threatening social media posts to him.

You carry a gun to make yourself harder to kill. Know the law so you're harder to convict!

The 2/2 Rule

I recently came across some articles describing self-defense advice that centered not on shooting skills, but how to avoid serious repercussions if you do defend yourself with a firearm. While many points are covered in better Concealed Carry classes in Illinois such as the excellent ones conducted at The Bullet Trap in Macon - a few tips are ones I had never thought through as well as I should

Quite simply: there are two things to do before a self-defense incident occurs, and two things to do afterward. Think of it as a little checklist you can actually remember under stress, when powerful adrenaline is shrieking through your system, emotions are high, and you have to get everything right. In fact, write it down and keep it with you so you don't forget in the "heat of the moment."

Before: Point 1 **Know When Force Is Justified**

Think through the situations for using force and where you would use deadly force – in the context of your state's law. In our case Illinois, but if you travel, you need to brush up on what these states do not allow. In either case, if what you do does not line up with the statutes, you could easily be found legally wrong, even if you feel that you were justified and morally correct.

Visualize, say, five common scenarios, where you might have to use deadly force; tailor each to your own personal lifestyle. Maybe a vicious dog approaches while you are walking your own dog at night. Or sitting in your car at a parking lot, a stranger tries to get into your vehicle. Maybe a person confronts you at a gas station pump and he has his hands in his pockets – or a pistol in his hand. Maybe a road-rage incident. Or you are at home, or in a motel room, and you start to hear noises indicating a break-in.

Don't make this list generic; tailor it to your own life. For example, we have a little Shih Tzu and when he wants to go outside to water the neighborhood, he's getting his way - even if that is at 3:09 A.M.! Stray dogs happen; some might even be feral, as we live fairly close to the Sangamon River bottom land, so for me, that's a likely scenario.

These scenarios may change over time. With every year, I walk slower and my reaction time also seems to slow down a bit. Or maybe you job changes and you now have to pump gas at 10:00 P.M. instead of midday, so your risk profile has changed for the worse.

Put each scenario on their own small card. Add in the name and contact information of your lawyer that you will call after an event on each card. Ensure now that this lawyer knows you, knows you carry a firearm, and knows that you will be calling when you really need timely help. By thinking through potential situations, your brain develops a template concerning imminence of attack, proportionality of your response, to make it less likely that you will make a snap, panic decision you and your lawyer - cannot legally defend later.

Before: Point 2

Avoidance. Avoidance. Avoidance

Your best situational defense and your best legal defense is not being there when violence happens! Prosecutors don't like to lose; they want a slam dunk, and if it looks like you did everything to avoid using your firearm, their case suddenly doesn't look so strong. If they do take it to trial, jurors love seeing that you tried not to fight. They understand that you were innocently going about your day (like they do), a threat cornered you, there was no escape route, or other safe alternative, you were afraid for your life (like they would be), and you acted only as a last resort (like they think they would).

Several lawyers noted that in almost every successful prosecution of someone who used force to defend themselves, there was at least one moment where the defender helped escalate rather than de-escalate the situation. Don't respond to insults; disengage from road-rage chasers. The individual who avoided, de-escalated, and only used deadly force when there was no other option stacks the odds in their favor with officers on scene, prosecutors deciding to, or not to, file charges, and with jurors deciding whether to believe you.

After: Point 1 Don't Talk; Call A Lawyer



When you believe you are right, your instinct is to explain to justify why you acted, fill in details, rationalize all your actions. That's normal, but also dangerous, because your ears are ringing from the gunshots, you are experiencing tunnel-vision, and your adrenaline overload will make you a terrible narrator. Instead, identify yourself to authorities; ask for medical help if needed and request your attorney. Then stop. Your lawyer will tell you what to do next.

After: Point 2 Live Like Everything Is An Exhibit

This may be the key point, and you can control this... and must. Police body-cam video will capture your demeanor. Your tone during routine questions will be scrutinized. Your phone or email texts, posts on social media, photos, comments in news stories, remarks to anyone other than your Catholic priest, can all wind up in a prosecutor's binder.

Remember: there is no statute of limitations on murder. A future State Attorney wanting to make a political name for himself may want to reopen the case. And we haven't addressed any lawsuits that the family of the "saint" you killed in self-defense may try to sue you for every penny. My take: go dark. No electronic communications concerning the event. No comments in public. But later, some people might assume that not talking means you did something bad. Follow the Mind Over Matter Rule. You don't mind, because those people don't matter. For how long? Forever!



Personal Defense Tip:

Don't insert yourself into stupid situations or you may win stupid prizes

TAYLOR, Mich. (WKRC) - A woman allegedly stabbed a teenage customer at a Kids Foot Locker after someone called her a "broke bitch" when her card declined at checkout.

Suniya Jenkins, 19, told local outlet Fox 2 that she was walking around the Southland Mall in Taylor, Michigan when she heard a commotion inside of a Kids Foot Locker. She said she peeked in to see what was going on, and heard yelling at the register about a 40-year-old customer's card being declined.

Jenkins said that as soon as she looked inside the store, the woman turned her ire toward her and started screaming.

"As the argument got verbal, she put her hand in her purse and proceeded to tell me she was going to shoot me," Jenkins said.

The customer allegedly pulled a kitchen knife out of her purse and stabbed Jenkins twice in the neck, once in the stomach, and once in the thigh.

"I did not see or even know I was stabbed until after the physical altercation," the victim said.

The altercation reportedly started when someone called the suspect a "broke botch" after her card declined, but Jenkins claimed she was not the one who made the comment.

"I would love to press charges," the 19year-old said from her hospital bed. "I am going to press charges, but it does sadden me because I don't want her to be taken away from her children, I truly

Party of Beto: Analysis shows Democrats' anti-gun positions are costing them votes

The authors of *Deciding to Win* don't mince words about the damage this has done. They say "highly educated, affluent Democrat elites" are driving the party's priorities — not voters. Those elites have replaced lunch-pail common sense with the gospel of gun control.

They've spent a decade shouting about "assault weapons bans," "universal background checks," and "gun violence prevention" while ignoring the constitutional truth that the Second Amendment is not a suggestion. It's a right

Every time Democrats double down on gun bans and registration schemes, they're not just attacking firearms — they're attacking the independence, dignity, and self-reliance that built this country. And every time they do it, they lose more of the working-class voters who used to believe the party stood for them.

Even their own strategists are begging them to stop

What's WelcomePAC's solution? In their words, Democrats must "focus more on issues voters do not think our party prioritizes highly enough (the economy, cost of living, border security, public safety) and focus less on issues voters think we place too much emphasis on."

Translated: stop talking about taking away people's guns and start talking about putting food on the table. That's not a revelation — that's common sense. But the fact that it has to be spelled out in a 59-page memo shows how detached the modern Democrat Party has become from reality outside of Washington, D.C. and San Francisco.

Chris McNutt, president of Texas Gun Rights, welcomed the report's admission. "It's refreshing to see even Democrat strategists admitting that their relentless push for gun control has been a political disaster," McNutt said. "Texas Gun Rights welcomes the return of the pro-gun Democrat — a species that's been extinct for far too long. The Second Amendment isn't a partisan issue; it's an American one."

McNutt added that Texas Gun Rights is nonpartisan and will continue to hold all elected officials accountable — Republican, Democrat, or Independent — when they betray their oath to defend the Constitution.

The Bottom Line

WelcomePAC's report doesn't suddenly make Democrats pro-gun.

But it does prove that their own numbers are turning against them. The party's fixation on "assault weapons bans" and other anti-freedom crusades has alienated the very voters it needs most — blue-collar Americans who value their rights, their safety, and their independence.

If Democrats really want to "decide to win," they can start by deciding to stop attacking the right of the people to keep and bear arms. Until then, gun owners will keep voting — and fighting — like their freedom depends on it. Because it does.






Glock: Judge's OK of Chicago's anti-gun lawsuit questionable, at best

(The Center Square) - Firearms maker Glock is asking for permission to appeal a Cook County judge's ruling allowing the city of Chicago to continue its lawsuit against Glock for "deceptive practices" in the sale and marketing of their popular semiautomatic pistols, as the gunmaker argues the judge's take on the legal permissibility of the city's lawsuit rests on shaky and unproven legal ground.



Glock filed the motion in mid-October in Cook County Circuit Court, asking Cook County Judge Allen P. Walker to allow the company to request an appeals court to review Walker's September ruling declaring that neither the city's lawsuit nor the state consumer fraud law on which it rests don't violate the Second Amendment, federal law or a recent U.S. Supreme Court decision concerning legal actions seeking to make gunmakers pay for the acts of criminals using their weapons.

DHS arrests illegal alien in relation to shots fired at ICE agents

Chicago (NBC5 Chicago) - Immigration enforcement tensions rose across the Chicago area over the weekend.

A Department of Homeland Security spokesperson said agents were shot at on Saturday during an operation near 26th Street and Kedzie Avenue in the Little Village neighborhood.

On Monday, DHS told NBC Chicago they arrested an undocumented man from Mexico in relation to the shooting. Authorities said he has a prior conviction for unlawful use of a weapon, although they hadn't released his identity as of Monday evening.

As if they had a disagreement over whose girlfriend makes better lasagna.

Here's what really happened. Ask yourself if the media report was anything close to what really happened. Was the discrepancy laziness, incompetence or malicious misrepresentation of a righteous defensive gun use?

US LawShield's primary Illinois defense attorney Michael Johnson shared this narrative with us now that the dust has settled...

In the early morning hours
I received a call on the US
LawShield emergency hotline
that a member was being
held at the Chicago PD station at Belmont and Western.

A man named Nicholas called while in police custody, asking for help. He wasn't exactly clear as to why he was being held, but it had something to do with a shooting that happened on the near west side of Chicago.

I headed to the police station and while en route I called the detectives to let them know I represented Nicholas.



When I arrived, I learned that there was a shooting and one person died. After I spoke to Nicholas, I started to piece together the facts of what transpired just a few hours earlier. The facts as related to me by Nicholas were as follows:

Nicholas and his friend were leaving the downtown Chicago area around 2:00am after a night of drinking. The friend was driving and Nicholas sat in the front passenger seat.

(As he knew he was going to be drinking,) Nicholas had left his gun in the glove box and the driver had his gun on his person. Both of them had carry licenses.

At a stoplight, and individual approached the driver's side of the car and yelled obscenities at Nicholas and the driver.

The belligerent individual became increasingly aggressive and violent to the point he attempted to get into the car to attack the driver and Nicholas. Nicholas attempted to push him away and the driver fired several shots in the direction of the assailant. One of the shots grazed

Nicholas in the leg and one the other rounds proved fatal for the aggressor.

The driver took Nicholas to the nearest hospital without delay. As soon as they arrived, the police also showed up.

Nicholas was treated and both of them were taken to the police station for questioning. I arrived before either of them could say much regarding the shooting.

Both guns were recovered and the police were not even sure who fired the shots. The fact that Nicholas had been wounded, kind of left the police assuming the driver fired the shots.

I spent the next 24 hours talking with the detectives and then the States Attorney, attempting to convince them that based on the lack of evidence and any witnesses, it would be all but impossible to get any charges to stick, let alone convict.

As the clock ran close to the 48 hour mark, police released Nicholas without charges. Subsequently, even though I wasn't officially representing the driver, he too was also released

BREW YOUR OWN HOLLOW-POINTS

(GSL) - Reloading ammunition not only provides a very productive way to pass time, you can also make it fun and enjoyable too!

I've been reloading since the early 80s, starting with single-stage presses that take forever but teach the basics. At first I told myself that I reload to save money, but that's just wishful thinking. It doesn't factor in cost of the equipment or your time in "good times."

But at other times, when panic buying has infected the marketplace, having the knowledge, equipment and reloading skills allowed me to produce my own ammo when none was to be found in stores.

Right now is a good time to stock up on ammo. Prices have stabilized and I attribute that in large part to the current administration. Keep buying in bulk when opportunities present themselves, especially for .223/5.56 and 9mm.

If you're shooting calibers that require more material to manufacture (.44s, .45s) or are less popular (.32, .380, .38) you might want to consider reloading as there is some limited cost savings in reloading them.

With my ammo fort coming together, I decided to investigate reloading .380s for sport, fun and self-defense.

In addition to reloading, I also started to cast my own bullets a number of years ago after I had trouble acquiring projectiles. I'll save you that story for another time but needless to say I acquired a few bullet molds.

Hollow Point Bullet Mold Services modifies bullet molds to produce, well, you guessed it: hollow point bullets



I powder coat and size them to .357 diameter. How handy is that?

Lubed bullets work well also but the lube cause a lot of smoke when fired and can become annoying in short order.

Now I know many are saying "Why cast hollow point bullets?" and many more are talking about "You shouldn't use reloaded ammo for self defense." Why? Because it's fun and it's options if I can't buy hollow points at the store. And then there's the "Cool" factor.

Loading with Winchester 231, I got 1041fps out of a Makarov and 986fps out of my old Ruger LCP. The extra .7" of barrel in the Mak makes a difference. As for exact loads, you're going to have to find your own load data for magical fire dust from various load books.



Accuracy at 9 yards was minute of bad guy face and then some, even with a difficult-to-shoot-well pocket pistol.

I also tested some 98 grain truncated nose bullets and got velocities about 100fps slower.

To test for expansion, your Greek god didn't have any ballistic gelatin handy, so I went with the poor-man's test for expansion (water jugs). Both pistols delivered similar results, gutting the first jug. Each time I recovered the slugs from the second jug.



Expansion was .654-.660 and recovered weight was nearly identical to their cast weight - 88 to 89 grain.

Overall reloading your own ammunition can be an enjoyable and great pastime. Even more important: shooting is always fun!

Peoria County Sheriff pays GSL a visit

Peoria County Sheriff Chris Watkins joined us in Peoria for his second or third visit in the last year or two. He came with an update from his perspective on a wide range of topics, and taking questions on plenty of additional issues.

First, he mentioned the gun control bills under consideration. "Those are pretty much all political," he said. Basically the more radical Dems are tossing some red meat to the radical leftists in their districts, probably trying to fend off primary challengers from the fringes.

As far as the immigration fight goes, he says his agency is never going to prevent ICE from conducting enforcement in Peoria County. The feds are rounding up some really bad people, including hu-

man and child traffickers.

Locally, Sheriff Watkins sees organized retail thefts as a big problem for local merchants. So too property crimes involving young kids targeting cars warming up before people need to leave for work. "You would be surprised how many people leave their keys or key fobs in running vehicles," he

Thanks to the end of cash bail in Illinois, it's sometimes a struggle to hold truly violent offenders until trial. Yes, even those arrested, often gang members, for shooting at others.

Lunatic drivers are also a local concern, in part to reduced traffic enforcement by municipal police. "Traffic is kind of like the Wild West around here."

NRA 2.0: New NRA Director Dick Fairburn on changes he's seeing with NRA leadership

NRA 2.0. That's what folks are calling the NRA now that Wayne LaPierre and a bunch of his cronies are gone from leadership. GSL member Dick Fairburn joined us at a number of GSL meetings to explain what he's seen personally - and it's glorious.

Who is Dick Fairburn? He's written for national publications for forty-plus years. His public safety career has spanned about as long. Mr. Fairburn started in the fire service, and then became a cop and a police (and fire) chief. He also spent a couple decades teaching for the Illinois State Police. Thanks to two years of getting reformers elected to the Board, the reformers now have a solid majority of board members. The Wayne LaPierre cabal who had run the NRA into the ground for so long were very vocal at the April Board meeting, according to Fairburn. "They thought they still ran the place."

But then the reformers flexed their muscles and unseated the sitting president Bob Barr and replaced him with a reformer named Bill Bachenberg. "Suddenly, you could feel a change in the room," he said as the LaPierre folks realized they were no longer in charge.

Some of the scarce few of LaPierre's pals on the board have since resigned. As a result of one of those resignations, GSL's own Todd Vandermyde is now an NRA Board member! Congrats Todd!

Should the reformers continue with their winning streak, this next year's voting should put them in the super-majority.

Reformers now control pretty much the entire leadership of the National Rifle Association, including key committees, top leadership posts and they are instituting huge reforms to treat it like a business.

Bachenberg has set about building a foundation to carry the organization for the next

150 years, in part by running it like a real business. He's investing in social media outreach to bring in more younger members. Board committees like the membership committee are meeting regularly. For instance the membership committee has met monthly when they didn't meet at all in the seven vears before Bachenberg's election. Moreover, the committees are seeing subject matter experts appointed to them, and these include some of the most influential and powerful names in shooting, industry and government. For example: the hunting and conservation committee have powerful nonboard members on them who have spent a career in those roles. Competition committees have champion competitors on them. And the list goes on and on. LaPierre's "old boys club" is a thing of the past.

The Brewer law firm that soaked the NRA for over a hundred mil in legal fees has been fired. Ditto for the public relations firm. The new marketing firm is doing the work for half of the price and they're one of the top shops for non-profits like the NRA.

Fairburn talked about some of the stuff the NRA does that scarce few people even know about. As a former cop, he noted that active duty police can join for a mere \$20 per year and with that comes a \$35,000 life insurance policy covering line-of-duty death. Tragically, that's paid out over \$4.4 million since 2000.



At the most recent meeting, it was announced that thanks to some cuts and restructuring, the NRA would finish the year in the black for the first time in many years. Some things members will notice is that NRA publications will be cut to two: *The American Rifleman* and *The American Hunter*. Monthly issues will be available digitally, and hard copies will be mailed quarterly. That alone will save the organization \$16M annually.

There have also been some layoffs at headquarters as the org becomes leaner and more efficient at its core mission but again, it will finish this year and next year in the black for a change.

They are looking to increase spending on litigation. They've consistently been involved with about 100 lawsuits in recent years, but LaPierre's legal firm gagged the NRA's leaders from touting this litigation to members and the public. Of course, now that Wayne and his Brewer law firm buddies are gone, it's a new day in more ways than one.

Did you think NRA-ILA backed off lawsuits? They certainly have not!

LaPierre's legal team muzzled them from talking about ongoing litigation

The Armed Awakening of America's Radical Left

(American Spectator) - Unless you live under a rock — or teach gender studies — you won't be surprised to find that people with strong left-leaning political attitudes score far higher on traits like neuroticism and psychopathy than many of their conservative counterparts. These psychological signatures — emotional volatility, heightened threat sensitivity, and explosive aggression — are more pronounced the further left you go. Add to that the recent murder of Charlie Kirk, the attempts on Donald Trump's life, and a surge in gun purchases by self-styled progressive activists, and the picture turns even darker.

The same movement that once mocked the Second Amendment is now shopping for suppressors. From trans shooters to queer collectives and "rainbow rifle clubs," the left's new hobby isn't mindfulness and manifesting — it's marksmanship. Conservatives tend to buy guns to defend their families; leftists

now seem to buy them to prove they can. The mood has shifted, from preachy to predatory.

It wasn't always like this. During the George Floyd riots of 2020, the radical left burned cities and, yes, cracked a few skulls along the way. Innocent shopkeepers were beaten, officers ambushed, and neighborhoods torched. Yet for all the carnage, most of the movement's foot soldiers weren't locked and loaded. They fought with fists, bricks, and stupid slogans. But times have changed. What began as "defund the police" has metastasized into "arm the resistance. The irony writes itself: the same people who argued that no one should own a firearm now brag about their "community arsenals..."

The left has discovered that it likes the smell of gunpowder.



And why not? The rhetoric has been primed for years. "Punch a Nazi." "Burn it down." "No justice, no peace." It was only a matter of time before soundbites became strategies. While conservatives debate calibers and carry laws, progressives are turning their causes into armed crusades. The so-called "John Brown Gun Club" trains members to prepare for civil conflict. What was once fringe is now fashionable.

Again, to be very clear, the modern left is not just angry — it's unwell. Anxiety and depression rates among self-described progressives have skyrocketed, especially among the young. To those on the far left, Trump and his supporters aren't political opponents but existential threats. They are embodiments

of evil to be eradicated, not engaged. When politics becomes pathology, violence stops feeling like a crime and starts feeling like self-defense. We are entering uncharted territory. The United States has seen political assassinations, riots, and radical groups before — but never with this cultural reach. The internet ensures that every grievance finds both a trigger and a target. Fury is now networked, outrage algorithmic. And unlike the extremists of old, today's radicals don't hide in compounds. They scroll beside you, shop beside you, share your workspace, and sleep next door.

You can't mix apocalyptic language with live ammunition and expect harmony. A society can survive hypocrisy. It cannot survive hysteria with high-capacity magazines. Every revolution begins with the belief that violence will heal what politics can't. It never does. It only creates new tyrants with a taste for blood



Perhaps, in some dark corner of their minds, the new progressives believe they're the heroes in history's next great moral war. They forget that history has a habit of eating its heroes. It also has an excellent memory. It remembers every bullet, every boast, every cause that mistook fury for faith. And it will remember who called it justice when they started killing the innocent.

Sangamon County Sheriff Paula Crouch & Karina's Law implementation

(GSL) - Sangamon County Sheriff Paula Crouch joined us at our November meeting. She's running for re-election after her appointment to fill Sheriff Jack Campbell's seat after he retired mid-term in the aftermath of the deputy-involved homicide of a older woman. Crouch came following a 24-year career with Springfield PD.

She came onto our radar when asked at an early press conference if she would enforce the so-called Protect Illinois Communities Act against the 98.x% of FOID holders who refused to register their regulated guns. "I'll enforce the law," she said which was her stock answer for questions she wasn't expecting. Her "I'll enforce the law" was touted by gun control proponents as welcome news, and by us as betrayal.

At our meeting, Sheriff Crouch admitted she wasn't really prepared for questions like that. "I hadn't even been sworn in yet," she said. "Yes, that was maybe a bad thing to say. Especially as the PICA law doesn't align with the Constitution." To date, she's unaware of any PICA charges in Sangamon County - or at least any that don't accompany a bevy of other charges against a suspect.

"We don't knock on people's door to ask them about their guns," she assured folks. Yes, even if FOID cards are expired, suspended or revoked - even when they're labelled by the Illinois State Police as "high-priority revocations." "We've declined grant money to do that."

Karina's Law & Other Warrants

Her Chief Deputy John Hayes talked about the sorts of work the department does do when it comes to orders of protection, so-called "Red Flag" petitions and the new "Karina's Law" warrants. Those Karina's Law court orders require law enforcement to seize a gun owner's guns pending a formal hearing, based upon statements made by a plaintiff seeking that particular order of protection.

Yes, those are the warrants where law enforcement shows up, knocks on the door and seizes guns.

Prior to executing those warrants/orders, Hayes said they do preliminary investigative work to uncover evidence that either supports or rebuts the alleged facts, as well as confirming the address and other particulars. If they find problems or aspects to be "nonfactual," they'll take their findings back to the judge and ask for him to review it. In those cases the judges often quash the warrants.

What's more, it's not a license to search a premises from top to bottom. It has to be specific locations, limited in nature, looking for firearm(s).

The audience had a ton of very good questions and Hayes' explanations were informative and well-received.

We didn't hear a lot about her plans to beef up the department in manpower or salaries to make the deputy jobs more competitive with neighboring agencies. In fairness though, the audience had a lot of questions about the gun confiscation procedures.

Sheriff Crouch does have a primary opponent in David Timm, a retired deputy running a strong campaign. Timm's already appeared a couple of times at the GSL meeting and will likely return. So too will the sheriff.

Preliminary report released on Bailey family helicopter crash

Springfield, IL (Fox2) – Nearly one month after the deadly crash in Montana that claimed the lives of Illinois Gubernatorial candidate Darren Bailey's son, daughterin-law, and grandchildren, the National Transportation Safety Board (NTSB) has released a preliminary report in its investigation.

The crash happened on Oct. 22, when Darren Bailey's son, Zach Bailey, daughter-in-law, Kelsey, and their children, Vada Rose and Samuel, left from a private ranch on a Robinson R44 helicopter. The couple's 10-year-old son, Finn, was not on the flight.

According to the NTSB, the helicopter, accompanied by a plane, was en route to Ekalaka Airport, located in southeastern Montana. The pilot of the plane that was traveling with the R44 reported that he lost sight of the helicopter.



During the time the pilot lost sight of the R44, an eyewitness who was on the ground said she saw something fall from the chopper as it descended, then attempted to climb.

Officials say debris was scattered across an open field in a large area. The NTSB also reported that there was no fire or explosion.

In their preliminary findings, the NTSB report points to an in-flight structural or component failure at low altitude as a potential key factor.

HERO: 79-year-old U.S. Marine defends young female tenant from naked home invader

Los Angeles (NY Post) - A 79-year-old Vietnam veteran is being hailed as a hero after he shot and killed a naked intruder who allegedly broke into his female tenant's Los Angeles home last week.

George Karkoc is now recovering in the hospital with two broken legs and a shattered hip after confronting the bare prowler outside the Studio City home when he heard the young woman screaming for help around 7 a.m. last Friday, according to the Los Angeles Police Department, multiple outlets reported.

"I knew that if I didn't take care of him, I had no clue what he was gonna do or was capable of doing," the quick-thinking vet told FOX 11 Los Angeles from his bed at Holy Cross Hospital in Mission Hills.



Seattle urban thugs tried to carjack a Corvette. They got lead instead...

(Corvette Blogger) - The owner of a Red Mist C8 Corvette opened fire in selfdefense after four men wearing facemasks tried to steal his car early Sunday morning.

The incident happened around 3:30 a.m. near 1st Avenue and Blanchard Avenue in downtown Seattle, Washington.

Police say the Corvette driver had parked his car when he was approached by four masked men in a white sedan, two of whom got out, held him at gunpoint, and tried to steal the C8.

Fearing for his safety, the Corvette driver fired off several rounds, hitting two of the suspects, with police finding one of them still at the scene suffering from multiple gunshot wounds. He was taken under armed guard to Harborview Medical Center, where the other three suspects later dropped off another victim before fleeing the scene

Police now say that the two victims are a 14-year-old boy and a 20-year-old man, both of whom are listed in serious condition and will be charged after being released from the hospital. The other two suspects remain at large.



Democrats' favorite talking point about children and 'gun deaths' is a lie

Gun control advocates often claim that guns are the leading cause of death among children — but that is quite false.

by John Lott (The Federalist) - Gun control advocates often claim that guns are the leading cause of death among children — but that is false.

Earlier this year, Virginia's new governor-elect, Democrat Abigail Spanberger, demanded new gun control laws, calling guns "the number one killer of kids in our country." Other Democrats such as North Carolina's Democrat Gov. Josh Stein also mentioned it. In June, the Ad Council launched a \$10 million campaign touting the "alarming statistic - gun injuries at the number one killer of children and teens in this country." And, of course, there were parting shots from Biden's Council of Economic Advisers. literally days before they left office earlier this year, pushing the claim.

Over the last couple of years, the media has continually pushed the assertion regarding children being at risk. The Washington Post's headline warned: "Why guns are America's number one killer of children." An NPR headline wrote: "Firearms overtook auto accidents as the leading cause of death

in children" and the BBC noted: "Gun deaths were the leading killer of US children in 2020." Fact-checkers from Newsweek to Snopes also push these claims.



What defines a child? For those under 18, vehicle deaths consistently outnumber firearm deaths. But in 2023 they were essentially tied. The combined total of unintentional deaths, homicides, and suicides reached 2,580 for vehicles and 2,581 for firearms. Yet those firearm numbers make the two causes seem closer than they are, because they include "justifiable homicides" — cases in which civilians or police shot young offenders who posed deadly threats.

When we exclude those justified killings and use the FBI's count of murders instead, the firearm total

drops by more than four hundred, from 2,581 to 2.166 deaths.

About 72 percent of firearm homicides involving minors occur among 15-, 16-, and 17-year-olds. Sixteen- and 17-year-olds alone make up about 57 percent of those cases. These killings overwhelmingly stem from gang activity, and even a total gun ban would do little to stop gangs from obtaining weapons to protect their highly valuable drug supplies.

So even if we classify 17year-old gang members as "children," the gun control claim doesn't hold up. In 2019 and 2020, more minors died from suffocation than from firearms, and the two causes were nearly equal in 2022 and 2023.

If we define children as those under 15, motor vehicle deaths far exceed firearm deaths. From 2019 through 2023, motor vehicle deaths were 64 percent to 153 percent higher than firearm deaths (excluding justified homicides), while suffocation deaths were more frequent in 2019 and 2020, and similar in later years.

Mississippi mom blasts aggressive, virus-infected monkey running loose in her backyard after semi crash

(PBS) - One of the [43] virus-infected monkeys that escaped last week after a truck overturned on a Mississippi roadway was shot and killed early Sunday by a mother who feared for the safety of her children.



Monkeys infected with hepatitis and herpes escaped after a transport crashed.

Jessica Bond Ferguson said her 16-yearold son thought he had seen a monkey running in the yard outside their home near Heidelberg, Mississippi. She got out bed, grabbed her firearm and her cellphone and stepped outside where she saw the monkey about 60 feet away. Bond said she and other residents had been warned about the diseases that the escaped monkeys carried so she fired her gun.

"I did what any other mother would do to protect her children," Bond, who has five children ranging in age from 4 to 16.

"I shot at it and it just stood there, and I shot again, and he backed up and that's when he fell. If it attacked somebody's kid, and I couldn't have stopped it, that would be a lot on me. It's kind of scary and dangerous that they are running around, and people have kids playing in their yards."

Luck alone saved us from loss of life on Saturday. Gunfire during the fight between protesters and ICE sounded yet another frightening warning of the consequence of reckless incitement by Gov. J.B. Pritzker and Mayor Brandon Johnson and their refusal to enforce immigration law.

The suspected shooter, now in custody, is an illegal alien from Mexico who was previously convicted of aggravated, unlawful use of a weapon/vehicle, felony possession of a weapon and illegal entry.

That man should not be here. Yet Pritzker hasn't said a word condemning either the shooting or the presence of such an individual on our streets. Astonishingly, Johnson even blamed ICE for provoking the shooting.

Pritzker and Johnson have gone far beyond sanctuary laws that limit local law enforcement from cooperating with ICE. Their relentless attacks on all federal immigration enforcement using the most extreme language available have poisoned the culture and tossed the rule of law to the wind, endanger-

ing protesters and law enforcement alike.

Words have consequences. When public officials stoke violence, people listen — especially lawbreakers. It's therefore no surprise that Latin Kings street gang leaders have now issued a "shoot-on-sight" order targeting immigration personnel. That, too, has been met with silence from Pritzker and Johnson.

Only reliance on the rule of law will eliminate the need for aggressive action by ICE. Only enforcement of the rule of federal immigration law will undo the calamity that resulted from an open border. Pritzker, Johnson and their allies must pledge all efforts to restore the rule of law and reject the mob rule that they've effectively embraced. Without that, have no doubt that our luck will run out in a worsening spiral of chaos and bloodshed.

But don't hold your breath waiting for Pritzker and Johnson to restore law and order.

Product review

Rossi Rio Bravo lever-action .22



By Damon Williams GSL Member I'm probably dating myself, but back in the late '90s, Walmart offered an introductory price on a lever action 22 manufactured by an up-and-coming new firearms manufacturer by the name of Henry Repeating Arms. This introductory price was around \$150. As the popularity of this rifle and the name of its manufacturer grew, so did the price.

My only real complaint about this new little rifle was that when I went to clean it with Gun Scrubber brand solvent, the paint on the aluminum receiver bubbled off. Oops. Eventually, I just went ahead and removed the rest of the paint and polished the receiver to a mirror finish

Fast forward about a decade and a half, I traded my shiny silver rifle to a friend. While not displeased with my new acquisition, I kinda missed not having a lever .22 around.

Recently, YouTube suggested a video on the Rossi Gallery gun, a pump action 22. I was intrigued. When I spotted one in my local Vandalia Rural King, I was seriously considering it. When I told the salesman, John, that I needed to set aside another \$100 to purchase it, John asked, "Are you familiar with the Rio Bravo?" as he pulled it down from the rack. "It's about \$100 cheaper than the Gallery gun"

I walked away skeptical. It was a lever action 22 with plastic furniture, but it sure seemed to handle nicely in the store, and I did like the fiber-optic sights. After returning home and completing my research on reviews for the Rio Bravo, I was sold. I made the purchase several days later.

Of the five maybe six of you readers who follow me in this publication, you can quote me that in the past I have stated that it is my opinion that tacticool accessories on a lever action is like wearing a tuxedo to a square dance. Considering that the plastic furniture of this Rio Bravo is about \$80 cheaper than wooden furniture on the same model, and you get fiber-optic sights, I am willing to swallow my pride and look like a hypocrite.

The plastic fore end has slots at the 3, 6, and 9 o'clock positions. These look to be mounting points for accessories such as pic-rails. I have not tried to mount anything, but I am considering a pic rail for a flashlight next summer to dispatch some pesky raccoons. I imagine that longer screws will be necessary due to the thickness of the plastic furniture.

Like the Henry, the Rio Bravo is a side discharge, this design has a 22-dovetail rail at the top of the receiver allowing for optics.

The lighter plastic butt stock makes the rifle front heavy, but not unwieldy. The receiver is similar in size to the Rossi '92, so an

adult can wrap his hand around the receiver forward of the lever and carry it comfortably in one hand. While it does come with sling swivel studs on the forward barrel band and the butt stock, I cannot see any practicality in hanging a sling on such a small light-weight rifle.


I have never been a fan of manual safeties on a lever action; call me a traditionalist. Carry afield with an empty chamber, and lever in a round as you shoulder the weapon. The Rio Bravo has a cross-bolt push-button safety directly above the trigger. This feature allows the rifle to be carried cocked and locked like a semi-auto. I admit, that I am warming up to this feature as it is just that little bit faster than racking the lever. Regardless, you still have the option of carrying old-school.



With the butt stock planted into the shoulder, the forward weight allows for a steadier sight picture as the shooter manipulates the lever. This allows for faster follow-up shots. The action is smooth; just as smooth as a Henry. But speaking of manipulating the lever, if a 357 magnum has an overall length of 1.7 inches and a 22 long rifle 0.98 inches, why does the Rio Bravo have a lever throw the same distance as the model 92 of the same manufacturer? (Same question applies to the Henry 22 and the Henry Big Boy.)

Rossi is owned by Taurus. Taurus has a lifetime guarantee. This guarantee extends to the Rossi name as well.

If I have one complaint about the Rio Bravo, it would be the 6lb trigger pull. This is about twice the weight that I believe a lever action should have. But for \$250 out the door including tax, and ISP telephone call, I am not about to invest another \$125 in a trigger job. Of course, even with the extra \$80 for wood furniture, the Rio Bravo still comes in at about \$75 cheaper (\$150 cheaper with plastic furniture) than its Henry counterpart. I'll live with the stiff trigger.

The Duck Hunt

by Ken Frey (GSL) - The alarm went off at 3:45 a.m. My brain, however, hadn't gotten the memo, and my eyes were still glued shut. Today would be our first time out for duck hunting season.

By 4:15, Danny and Alvin (not of Chipmunk fame) had arrived at my house. We quickly busied ourselves attaching the boat to Alvin's truck, since mine was in the shop again with a failing water pump. I guess it beats buying a new truck.

In the darkness we loaded the boat. Danny was tossing things in, and the sound of gear clanging against the aluminum hull probably echoed between the houses like an unholy, broken bell, helping our neighbors wake up to share our excitement. Then Alvin stumbled over the decoy bags and started cursing like

The dog seemed to be the only one excited. He knew exactly where we were going and was constantly underfoot. It's a wonder someone didn't step on him. Duck hunting for a dog is akin to Disney World for kids.

Once we were finally underway, we needed to make one more stop at the gas station. The boat needed fuel. There's nothing like rushing around to do things that should have been done ahead of a trip, right?

At the boat ramp, we contributed to the entertainment of those who watch boat ramps for rip-roaring comedy. It only took Alvin four tries to back the boat into the water - and he was sober! He really is getting better with a trailer. And at least he didn't sink the boat.

By the time we shoved off, the fog was so thick the bow vanished into it. That's our story and we're sticking to it. Danny swore he knew the way to the blind and was giving me directions. Initially we didn't find the blind, but he did navigate us to a mudflat and we ran aground.

Nothing says "stealthy waterfowlers" like three grown men grunting and cussing in knee-deep muck with a dog barking at us to hurry up.



We finally found the blind and quickly set the decoys. Our spread looked less like a flock of ducks and more like a yard sale in a windstorm. More than a few were upside down or on their sides. Another was tangled in the anchor line. Clearly we never got the memo on proper decoy arrangement considered essential for a successful hunt. Then there was one that floated off into the fog for the freedom and sane government in Indiana.

And wouldn't you know it, the batteries in the Mojos (motorized decoys) were dead. I had forgotten to recharge them the night before.

Once the decoys were better set, we pulled

up to the blind and unloaded. We set up the kitchen in the back room and got started on breakfast. There's nothing like a hot meal in the duck blind. Biscuits and gravy, egg sandwiches, and a good strong cup of Irish coffee. (Only one though.) It's our tradition.

With breakfast finished and the cleanup done, it was time. 6:45 a.m., thirty minutes before sunrise, the start time for today. We loaded our guns and set them in the rack out front.

Anticipation built as we sat in the blind, waiting. The fog was lifting as the sun rose. At this point, the lake was calm as a mirror. It was a picturesque morning, just perfect.

After fifteen minutes we started whispering about wind direction and migration patterns as if we were seasoned biologists. The dog, unimpressed, dozed on my boots. Poor boy.

As the fog lifted a bit more, we saw dark clouds rolling in which quickly covered the bright orange disc that had just risen above the horizon. Another few minutes in and the wind picked up, creating a light chop on the lake. At least the decoys looked sort of alive instead of passed out drunk, rolling with the wind-driven waves. Well, at least the ones that remained upright.

As the front came in we could feel the temperature drop. Then the mist started. It was a cold mist that clung to everything, including us and our guns.

We thought we lost them, but they turned again, dropping altitude as they came in.

Our hearts pounded as we clicked the safeties off. The first few started to cup, preparing to land when Danny gave the command "TAKE 'EM!" We rose in unison - or almost.

The ducks heard Danny too. They flared, breaking off to our right. Shots rang out. Alvin's 10 gauge sounded like a howitzer going off next to me, no doubt beating him like a red-headed step-child with its recoil. It sounded like a war zone as we threw everything we had at the flock.

After the smoke cleared, we searched the lake for our prizes as the ducks vanished into the mist... entirely unharmed.

Our stunned silence was broken by Alvin muttering, "Well, at least we scared them." Meanwhile our dog gave us a look that said, "I could've done better with a slingshot.'

By 10 a.m., we were soaked as the mist turned to a steady rain. Wet, cold, and out of regular coffee, we packed up, leaving the blind and lake exactly as we found it. Except for the one decoy still drifting toward Indiana.

JUNK SCIENCE TAKES A BIG HIT: Trump admin cuts flow of tax dollars funneled to leftist gun control orgs and NGOs

(UK Guardian) - The Trump administration has released solicitations for a grant program meant to stop gun violence in underserved communities. But this year, the non-profits the grant was built around are disqualified from applying, according to an application notice released by the Department of Justice (DoJ) in September.


The Community Based Violence Intervention and Prevention Initiative (CVIPI), was created in 2022, to support groups working in rural and urban communities struggling to address violence and fund research studying the programs' efficacy.

The pioneering program was born out of a recognition by the Biden administration that such community-centered programs were among the most successful tools in combating the US' deep-rooted gun violence problem, and had played a crucial role in helping reduce homicides in major US cities.

Before Trump's inauguration, communitybased organizations, non-profits and local and state governments were eligible to apply for the grant. Now, only city, county and tribal governments are allowed. And the stated goal of the program has been changed from "comprehensive, community-based prevention" to "supports law enforcement efforts to reduce violent crime and improve police-community relations".

Since 2022, the federal government has

awarded more than \$300m to over 120 non-profits, city and county governments and research institutions through the initiative, according to an archived list of grant recipients.



The department of justice, which oversees CVIPI, did not respond to a request for

The changes at CVIPI are the latest in the Trump administration's heel-turn from the Biden administration's approach to gun violence prevention, which positioned Black and Latino-led groups working to address violence as legitimate solutions to crime in the nation's hardest hit locales. Shortly after his inauguration, Trump dismantled the White House office of gun violence prevention, and in March his administration removed the former surgeon general Vivek Murthy's advisory on gun violence as a public health issue from the US Department of Health and Human Services' website.

But instead of standing with law enforcement, Chicago's progressive leadership is doing what it always does, making their job harder. Judge Sara Ellis just slapped federal officers with a sweeping injunction limiting their ability to use force, even after a Border Patrol official reported agents were being shot at and assaulted. Fortunately, the 7th Circuit Court of Appeals granted the Trump administration's petition for writ of mandamus, as reported here on RedState by Susie Moore. Ellis justified her ruling by saying the official had "misrepresented" the level of threat posed by protesters.

Tell that to the agents who just dodged bullets

Chicago officials love to virtue-signal about "community safety," but it's their failed policies that made the city a sanctuary for organized chaos. They protect criminals, defund police, and then act shocked when gangs run the show. Now, even federal agents are being hunted in their own country, and city leaders are more concerned about optics than survival.

The Trump administration's DHS is doing what any competent government should do: restoring law and order where local authorities won't. Homeland Security reports an 8,000 percent spike in death threats against its officers. Every day these agents step into neighborhoods ruled by gangs, they're risking their lives to defend laws that Chicago politicians openly despise.



While the city's leaders host press conferences and talk about "equity," federal agents are dodging gunfire from men who have no respect for law, country, or life. The Latin Kings have turned parts of Chicago into a battlefield. And instead of rallying behind the people trying to stop it, the city's leadership attacks the very operation that's working to clean it up.

It's the same story we've seen for years: Democratic strongholds reject enforcement, embrace anarchy, and then blame Washington when their cities collapse. Only this time, it's not civilians paying the price, it's the men and women wearing the badge.

Trump's DHS deserves credit for not backing down. They're doing the hard work the city won't. They're targeting the "worst of the worst," pulling violent offenders off the streets, and reminding the rest of the country what leadership looks like.



The tragedy is that Chicago's political class seems more offended by federal agents defending themselves than by gang members issuing assassination orders. You'd think a city with thousands of unsolved murders would welcome some help. But to them, it's not about safety, it's about control. I've spent enough time around law enforcement to know these agents aren't out there looking for a fight. They're out there doing the job that too many others have walked away from: protecting families, enforcing laws, and trying to keep the peace in a place that's forgotten what peace looks like.

If the Latin Kings think they can intimidate the federal government, they're in for a rude awakening. But the real question is whether Chicago's leaders will finally wake up too, or keep standing in the way while their city burns. Because if a "shoot-on-sight" order against federal agents doesn't shake them out of their political delusion, nothing will.

Chicago declares War on the Federal Government

The shots that rang out last week resemble those fired on Fort Sumter which started the Civil War

by George Shay (Chicago Contrarian) - The shooting has started.

A federal law enforcement source has now confirmed that a Chicagoan opened fire on federal officers. Whether this is the first volley or merely the latest escalation, it follows an obvious trajectory: When city leaders wink at lawlessness and when newspapers sanctify defiance, blood is the next headline.

Our local press corps has abandoned skepticism for sermonizing. They've become propagandists — much like the newspapers of the South in the years before the Civil War — stirring emotion, arousing grievance, and normalizing rebellion against our own federal government. They no longer cover the news; they choreograph it.

How Chicago media is praising a rebellion

You don't have to take my word for it. Just read what they print.

Over the past several weeks, Chicago's newspapers have waxed rhapsodic about what is, in plain English, a treasonous insurrection — one incited and encouraged by our mayor and applauded by our governor. Their coverage could be mistaken for a romance novel about "resistance."

They lionize protesters for blocking and attacking federal agents, portraying the offenders as victims of political persecution rather than the obstructors of justice they are, rightly accused of violating federal law. Editorials frame their indictments and prosecutions as assaults on "dissent" and "free speech," as if storming a secure facility were the same as writing a letter to the editor.

They glorify clashes between demonstrators and federal agents, waxing rhapsodic over images of tear gas, chanting crowds, and the "courage" of those who rush police lines, like the polemicists who fueled the flames of the French and Russian revolutions.

When federal judges — many appointed by Obama and Biden — issue restrictions on the use of force, the papers celebrate it as a "civil rights victory," never mind that such rulings make it harder to protect the very communities they claim to champion.

They present Chicago as a city united in moral defiance of Washington. To them, federal agents are invaders; activists are patriots; the

mayor is a folk hero. The coverage invokes the Haymarket.

They hold riots and the 1968 Democratic Convention as sacred precedents, as if today's mobs were heirs to some noble revolutionary tradition.

Grassroots "Whistlemania" events, student walkouts, and neighborhood tip lines are treated as courageous civic acts — never as interference with law enforcement, and the breathless features about frightened restaurant owners and parents hiding from ICE raids always stop short of asking the obvious: Why are these raids happening in the first place?

It's propaganda with a local accent — an elegy for law-and-order masquerading as journalism.

Inciters in high office

At the center of this performative defiance stands Mayor Brandon Johnson, the city's self-styled revolutionary-in-chief. Every press conference, every slogan, every wink toward "sanctuary" is like putting out a fire with gasoline.

Beside him stands Governor Jelly Billy Pritzker, the state's most enthusiastic enabler of dysfunction — who seems to believe the path to the White House runs through open borders, lawless streets, and theatrical indignation.

The inevitable outcome of their combined incitement to riot is already visible: federal agents under fire, neighborhoods paralyzed by fear, and public confidence collapsing faster than the city's bond rating.

People are getting hurt. People are getting killed. More will be. If this spiral of madness and violent obstruction of justice continues, Washington will have no choice but to restore order — perhaps through federal injunctions, perhaps through the National Guard, perhaps through martial law. The only question is how long our state and city officials will pretend this is some grand moral crusade rather than a reckless dereliction of duty.

The sad fact is these cynical charlatans, blinded by ambition and hate, welcome this chaotic confrontation. They want to make Chicago the ultimate victim.

A rebel city

Let's not kid ourselves: Chicago today is behaving less like a municipality and more like a rogue state. This is the municipal equivalent of firing on Fort Sumter — symbolic now, but fraught with peril. Those of us who still believe in the Union, who pay our taxes and obey the law, are left living behind enemy lines in a city that treats the federal government as a foreign power.

Meanwhile, the local elite — boss Toni Preckwinkle, the governor, and Chicago's six percent approval mayor — continue to posture as if their rebellion were popular.

It isn't. The patience of ordinary citizens, who see their safety and federal subsidies sacrificed for ideology and blind political ambition, has worn thin.

The political reckoning ahead

The Democrat victories in last week's byelections have emboldened them. They think they're on the right side of history.

They couldn't be more wrong. The same electorate that can hand them illusory victories can just as easily deal them historic defeats once voters grasp the scale of the betrayal.

This governor presides over a state hemorrhaging residents and revenue, yet imagines himself a national figure. This mayor presides over a city bleeding jobs, tourists, solvency, and credibility, yet calls it progress. They represent criminals over victims, illegal immigrants over citizens, and ideology over governance.

The people of Chicago are not fools. Even in this bluest of states, the margin for Ka-

mala Harris was no landslide, and Brandon Johnson's numbers now scrape the floor. When a mayor's approval rating asymptotically approaches zero, it's time to start writing political obituaries...

A city worth saving

Leaving should be the last resort. Chicago is our home. The sensible center must reclaim it — not with bullets, but with ballots and relentless civic engagement. We can still restore law and order without surrendering our humanity.

The federal government will do what it must to protect its officers and enforce its laws. But the moral duty to rebuild our civic culture belongs to us. Chicago can be saved — but only if enough of us decide to stay, speak out, and vote the scoundrels who would defile and destroy her out on their ears.

That's the challenge before us. For those of us who still believe in reason over rage, it's almost a sacred calling.

This city is not America anymore. Those of us who remain loyal to our country must steer our civic ship back toward the course of common sense before it runs aground on the shoals of socialist secession, toward the sensible center, guided by the North Star of truth as best we can discern it. And right now, that starlight shines on one thing loud and clear: Enough is enough.

Those of us who remain sane must put the inmates who are running amok on the streets and in the halls of power of the madhouse that Chicago has become back where they belong — in political exile.

Pro-tip: You can't shoot someone trespassing on your property

Indiana man charged after shooting cleaning woman at wrong address

Whitestown, IN (ABC News) - An Indiana man has been charged with voluntary manslaughter for fatally shooting a cleaning woman who mistakenly went to the wrong home, prosecutors announced Monday, nearly two weeks after the mother of four was killed.

The suspect, Curt Andersen, has been booked into the Boone County jail on a no bond hold and will appear in court sometime this week, prosecutors said.



That was a nice how you had, Mr. Andersen. He's hired an excellent attorney in Guy Relford, but that costs big bucks.

The Boone County prosecutor, Kent Eastwood, said the decision to file the charge follows a "comprehensive examination," in which his office determined Andersen's actions did not fall under the legal protections provided by the Indiana Stand Your Ground law.

"It's our contention that the person did not have a reasonable belief that that type of force was necessary, given all the facts that he had at that time," Eastwood said during a press briefing on Monday.

The shooting occurred the morning of Nov. 5 in a subdivision of Whitestown, located approximately 20 miles northwest of India-

napolis, police said.

Officers responding to a 911 call reporting a possible home invasion shortly before 7 a.m. found the woman dead on the front porch of the residence with a gunshot wound, Whitestown police said.

The gun had been fired from inside by a resident of the home, police said. A responding police officer saw a bullet hole in the front door of the residence, according to the probable cause affidavit.

Police later determined the woman was part of a cleaning crew that had mistakenly arrived at the wrong address, and that "the facts gathered do not support" that a home invasion occurred.

The Boone County Coroner's Office identified the shooting victim as 32-year-old Maria Florinda Rios Perez de Velasquez of Indianapolis. She died from a gunshot wound to the head, the coroner's office said.

[Editor's Note: Until and unless an intruder opens or breaks through a door or window, you probably cannot justify the use of deadly force. In fact, even if they enter without using force and don't pose an imminent threat of death or great bodily injury, you still can't justifiably shoot.

Put another way: just because they're in your house without your permission doesn't mean they're "bought and paid for" under the law. I know and like Guy Relford, but this case will be a very difficult one to win for him absent some big, unreported evidence of criminal conduct by the cleaning crew.]
