Narrative:

IT WAS DISCOVERED THAT A VERBAL ARGUEMENT HAD TAKEN PLACE BETWEEN ANDY SR. AND ANDY JR. ANDY MIZSAK SR, 63 OF AGE STATES HIS SON ANDREW 29 YRS BECAME UPSET WHEN HE WAS TOLD TO CLEAN HIS ROOM. ANDREW STATED HE DIDN'T HAVE TIME AND BECAME ENRAGED, HE THREW A PLATE OF FOOD ACROSS THE KITCHEN TABLE AND BALLED UP HIS FIST AT HIS FATHER. WHEN ASKED IF HE WISHED TO PRESS CHARGES HE STATED NO, NOT AT THIS TIME"

HE STATES ANDREW IS 270LBS AND HE CAN'T FIGHT HIM, THAT THEY DO EVERYTHING FOR ANDREW AND HE DOESN'T EVEN PAY RENT.

ANDREW WAS SENT TO HIS ROOM TO CLEAN IT. HE WAS CRYING UNCONTROLLABLY AND STATED HE WOULD COMPLY WITH THE ORDER.

ANDREW JR. WAS ADVISED SHOULD WE EVER RETURN AND THERE IS THE SLIGHTEST HINT THAT HE THREATENED HIS PARENTS THAT HE WOULD BE ARRESTED FOR DOMESTIC VIOLENCE.
