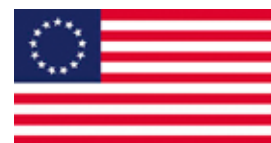

## THE BEST COURT MONEY CAN BUY

(GSL) - The Illinois Supreme Court has spoken on two high-profile, highly-political cases in the past few weeks. First, in July, the state's high court ruled the "No Cash Bail" law constitutional using some dubious reasoning. Then, in early August, the court vacated a lower court decision striking down Gov. Pritzker's so-called "Protect Illinois Communities Act."

Both cases featured the same four defendants: Gov. JB Pritzker, Senate President Don Harmon, House Speaker Chris Welch in addition to Attorney General Kwame Raoul.

Months earlier, Gov. Pritzker had donated a million dollars to the campaigns of each of the two new Illinois Supreme Court Justices: Elizabeth Rochford and Mary Kay O'Brien. What's more, Harmon and Welch each donated hundreds of thousands of dollars to each of the candidates as well.

Yet despite accepting donations approaching a quarter of their total campaign funds, these two justices failed to recuse themselves in either case involving those donors.



Not only that, but in the gun ban case, Justice Rochford not only refused to recuse herself, she actually wrote the majority opinion upholding the law.

Indeed, State Rep. Dan Caulkins told *The Center Square* that the decision was "the best justice money can buy."

Caulkins also said that he wasn't sure if he'll pursue the case in federal court.

In the meantime, we're saddled with the best court Gov. Pritzker and friends could "buy."

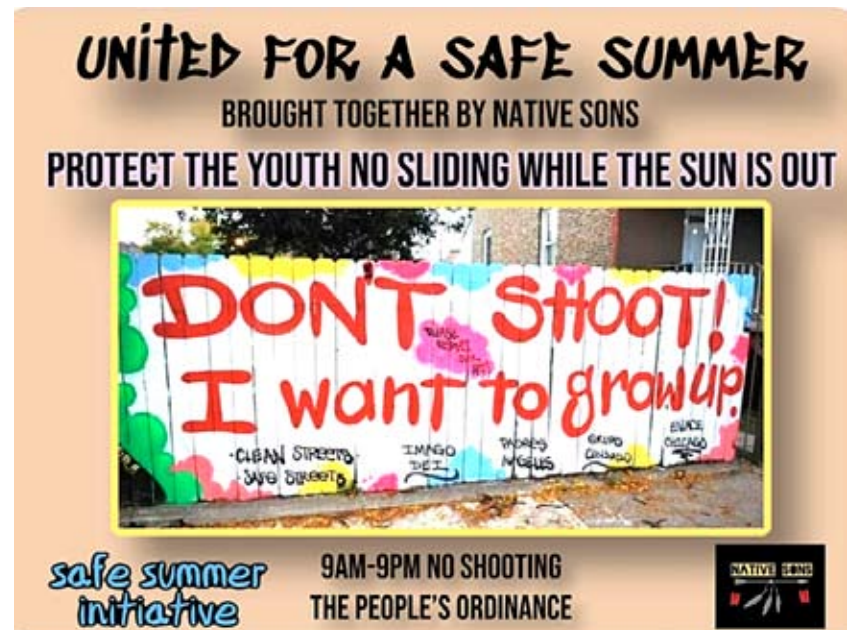

## Meeting Highlights

**Pontiac:** For a presentation, **Mr. Boch** brought some of the latest generation in tactical lights. The world has changed a lot from the 1980s. Today, you can carry a pocket-sized light that will sear a bad guy's retinas and signal the space station. At the same time the batteries have gotten bigger and the lights have more features.



Lithium batteries are growing in size along with the brightness of today's high-performance flashlights.

Boch likes the Fenix TK20 (or TK16) as the best "full-size" tactical light present day. Olights earn the runner-up status. All are close to \$100. The deciding difference? The Fenix has a dedicated button to the strobe function (which may disorient a bad guy) and the larger switch really is momentary no matter how briefly to touch it. While the Olights are very nice and super easy to use and charge, if you don't hold that momentary switch on long enough, the light will remain on. In a defensive use, that become a liability as lights tend to become bullet magnets.

**Decatur.** Dan Cooley brought the latest numbers from ISP: 2,415,000 FOID holders and 435,000 carry licenses are active. 26,780 of those FOID cards are out of Macon County (Decatur).



**John Drummond** joined us and talked about information dissemination. He's a former Marine MP and Mixed Martial Arts guy who did lots of cool training stuff - both taking and giving while in the service.

He brought that training out into the civilian world and worked at two or three departments and did a lot of SWAT stuff there. After kids and a second marriage, he's stepped away from fighting bad guys for a living for something a little safer with saner hours.

Today, in his spare time, he and his wife do shows and he's big on social media (**Wayward Son Custom** YouTube, Instagram and other social media platforms) both promoting pro-gun messaging as well as his own custom gun work.

"Old Ammo" was the BYO topic of the month and Jeff Olson put everyone to shame with a host of cartridges from the early 1800s including paper and combustible cartridges (google it) along with some pin- and cupfire specimens. And a volleygun cartridge.

**Peoria. Rep. Travis Weaver** noted how we need more pro-gun members of the General Assembly if we're going to see anything change when it comes to guns. In questions, he addressed the whole "illegals as cops" story that's been in the news of late. He clarified that illegals - including DACA recipients - cannot possess firearms under federal law and as such cannot be cops.

Mr. Parks then introduced our Tech Time speaker **Kevin Moody** to talk about red-dot sights (see inset box). Richard also noted that we'll have a Taurus GX4 with a red-dot for our September drawing gun, so it seemed timely.

### Sangamon County.

**Col. French MacLean** (ret.), a retired War College professor, shared a great presentation on his dad's unit from the Second World War.

**Company B** of the 39th Infantry Regiment in the 9th Infantry Division saw a lot of combat. 93% of the original members in 1941 perished, but they didn't go quietly into the night. They fought bravely and gallantly in North Africa (1942-43), Sicily (1943), Normandy (1944), the Hürtgen Forest (1944), Battle of the Bulge (1944), and ran across the Remagen bridge under enemy fire in 1945.

In just the last eleven months of the war, the soldiers in Company B earned 26 Silver Stars for Gallantry in Action and received 453 Purple Hearts. Led in 1943-44 by the legendary Colonel Harry "Paddy" Flint, who was a close friend of General George Patton and General Omar Bradley, the 39th Infantry coined the motto "Anything, Anytime, Anywhere, Bar Nothing," which the troops shortened to that they could kick the ass of anyone, anyplace and anytime, and they painted the symbol representing this, **AAAO**, on the side of their helmets and on the bumpers of their vehicles.

The Ninth US Infantry Division as a whole saw 304 days of combat; had 37,525 total losses - the second heaviest of any United States Army division in the war.

## Kevin Moody: A primer on 'Red Dot' handgun sights

At the August Peoria meeting, Kevin Moody gave us the quick and dirty of holographic handgun sights. These continue to grow in popularity, but they absolutely take some training and practice to use well. This goes double for those with a life-time of iron sight usage. Once mastered, they can be very fast and effective.

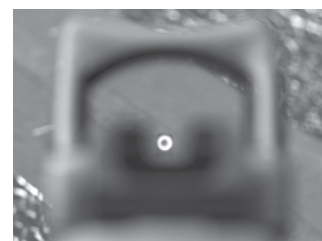

Moody, the owner of KAM Shooting Sports in Morton, knows what he's talking about from many years as an instructor and from someone in the industry. He recommended a 4-6 minute-of-angle dot for faster acquisition for defensive use. Save the smaller dots for distance shooting.

He also advised retaining iron sights in case of battery or electronic failure on defensive pistols.

First and foremost, he urged folks considering them to try them on a rental gun at a range, or a borrowed gun from a friend before pulling out your wallet. See if you like them and then pick the flavor of one that works best for you. They come in different sizes, reticle colors, how they turn on and so forth.



For defensive use, make sure you have an iron-sight backup.

He admitted that they don't work for everyone. They also don't work if you don't properly secure them to your gun. At his range, they see one or two a month go flying down range after an unplanned rapid disassembly. "Have someone else mount it & sight it in for you," he recommended. He also said nail polish works better than Lock-Tite because of the tiny threads.

The recommended distance for sighting in: 21 feet.

Whether you go with these new sights or stick with iron sights, Kevin noted that you have to practice and train to keep your edge.

## Executive Director's Report



### Double plus ungood - but don't lose hope

First and foremost, Guns Save Life's website has returned! We had fallen victim to malicious hackers who used and abused our server. For those who signed up online, banking and other personal information was not handled on our server, so no worries there.

I wish I had more good news to share.

At least if you know what's coming (or rumored to be coming) this allows you more time to consider

what's the better course of action for you. So pour your favorite beverage, have a seat and fasten your seatbelt because here we go.

**Our lawsuit challenging the FOIA Act was rejected by the circuit court.** We will soon be at the state's appellate court. Regardless who wins at the appellate court, we'll be at the Illinois Supreme Court. If they try something cute, we'll take it on up to the US Supreme Court and let SCOTUS put the IL high court in its place.

I think it's fair to say that Pritzker and his buddies know deep down that the FOIA Act is a dead man walking. We suspect they plan on running against the courts in the next couple of election cycles.

We're still waiting for the 7th Circuit Court of Appeals to rule on **our lawsuit challenging the gun and magazine ban**. Folks, they're gonna rule against us. Just expect it. We'll ask for an en banc review, but given the narrow split among justices for and against gun rights, I'm not optimistic we'll get it. Without going all geeky, suffice it to say we're going to be stuck with this new law and playing defense until 2024 best case, and probably 2025.

Oh, we'll win, eventually. But those advocating for racist, classist and sexist gun control aren't going to give up and roll over.



Racists were wrong in the 1950s and they're wrong today.

They're going to fight to the bitter end, just like the racists who advocated for keeping schools segregated in the 1950s.

**What's this mean for us?** I see no hope that we'll have this blocked before the registration component of this new law kicks in. In fact, I don't see us gaining relief until well after the registration period has closed.

You have about five months to sort out your collection and decide what you're going to do with it. Are you going to register your guns? Move them out of state? Boating accident or burial? You must wrestle with the pros and cons to find what works for you. At least you have a few months to weigh your options.



An Illinois State Police memo from January suggested the ISP intended to take a hard-line approach to the law, but that was then. We'll see what they're saying in October or November.

Something else to think about: Will Rep. Bob Morgan introduce a new bill in January to **"close the existing owner loophole"** and demand owners surrender all registered guns, mags & parts?

**Sources inside the Pritzker administration** have hinted that the governor will advocate for just such a "close the existing owner loophole" law immediately after the first mass casualty event after registration closes. Especially if it happens in IL.

#### **Suing to stop the registration?**

Yes, that was our first inclination, too. Then we consulted legal experts. We learned that no gun registration scheme has ever been rejected by any court in America. If that wasn't enough, we could easily end up in front of the very same three-judge panel at the Seventh Circuit Court of Appeals after spending \$100k on a new lawsuit. So we're taking a pass.

Thomas Maag from Southern Illinois might challenge it under 5th Amendment grounds, but I haven't seen a filing. Don't underestimate Mr. Maag though.

Of course **the Illinois high court ruled against Dan Caulkins** in his lawsuit challenging the state's new gun and magazine ban in state court. Frankly, it's like they listened to attorney Tom DeVore in writing their decision. I'm pretty sure the Illinois Supreme Court will decline to take DeVore's case. Like the US Supreme Court, the IL Supreme Court picks and chooses which cases it accepts.

I'm not going to point fingers at Mr. Caulkins as some have done. Instead, I'm going to focus my energy on attacking the "bought and paid for" justices on the IL Supreme Court along with Pritzker & crew. I'd recommend the rest of us do the same. Eating our own isn't going to get us where we want to go.

**Don't lose hope. Don't give up.** It seems like we've got more than our fair

### Biden regime set to reclassify 'gun dealer' as 'anyone' who makes profit from selling guns

*(Breitbart)* - Breitbart News reported on August 1 that Sen. Richard Blumenthal (D-CT) urged the Biden administration to seize on the Bipartisan Safer Communities Act as a means by which to enact further gun controls executively. Under the terms of the Act, the Biden Administration is expected to take action to expand background checks.

*The New York Times* reported that the Bipartisan Safer Communities Act contained a provision that allows an expansion of background checks via a reclassification of what constitutes a firearms dealer. This provision would shift the definition of firearms dealer so as to include not only those who make their livelihood selling guns, but "anyone who earns a profit from selling firearms" as well.

### 'SAFE-T' FALLOUT: Local police warn that 'vicious cycle' of trespassing homeless will 'get worse'

*(The Center Square)* - As Illinois cities grapple with people experiencing homelessness, some law enforcement agencies are concerned with how the state's SAFE-T act will impact their ability to address trespassers.

During Tuesday's Springfield City Council meeting, alderman discussed the issue of addressing the growing problem of homelessness. One question raised was how to deal with some of the homeless

population trespassing in abandoned buildings.

Springfield Police Chief Ken Scarlette warned that police can only do so much when someone trespasses.

*SPOILER: It means enforcement begins now...*

### What the Illinois Supreme Court ruling on gun & mag ban law means to you

(GSL) - The Illinois Supreme Court upheld Gov. Pritzker's gun and magazine ban. Their case in Rep. Dan Caulkins' case didn't involve Second Amendment considerations, but rather it was argued on "equal protection" grounds.

The outcome matters to gun owners as the earlier decision striking down the law as unconstitutional has now been vacated. As such, the State Police are now free to begin enforcement of the law.

#### Keeping you out of trouble for now until the law is struck down by the courts...

- Do you have any standard capacity magazines, or "banned" guns in your car? With only very limited exceptions, standard cap rifle mags over 10 rounds or handgun mags over 15 rounds must now remain on your property. They can be used on a public shooting range but they must be transported unloaded and encased to remain legal.
- Like magazines, banned guns (either by features or by magazine capacity) must remain on your property or they can be used on a range. You can transport them to and from the range or a gunsmith.
- All private gun sales must now be reported to (and registered with) the state, and the transfer must either take place at a gun dealer that's willing to keep those records or reported to one of those dealers. Many dealers don't want the hassle for a mere \$25 fee. Failure to run them through the FFL now is a potential felony for both the buyer and seller sides of the sale.
- Registration begins October 1st or shortly thereafter. You've got a few months to decide if you're going to register banned firearms and accessories, move them out of state or if you're going to have one or more boating accidents or rent a post-hole digger. We'll have more on creative alternatives to registering guns with the state in a coming issue.



*Barely half of IL police agencies report local crime to FBI*

### What crime problem?

(The Marshall Project) - In Illinois, only 52% of law enforcement agencies reported crime data to the FBI, and 33% reported a full year of crime data in 2022.

464 out of 885 law enforcement agencies in Illinois successfully submitted data to the FBI through the National

Incident-Based Reporting System in 2022. The agencies that reported any crime stats represent roughly 7 in 10 people in the state.

42 states and the District of Columbia had higher reporting rates than Illinois.

*'Militants' like Guns Save Life?*

### Illinois set to ban firearm 'marketing' to kids, militants, and others who might use guns illegally

(NBC5 Chicago) - Illinois will soon outlaw advertising for firearms that officials determine produces a public safety threat or appeals to children, militants or others who might later use the weapons illegally, as the state continues its quest to curb mass shootings.

Gun-rights advocates say the plan, which Democratic Gov. J.B. Pritzker has pledged to sign into law, is an unreasonably vague decree that violates not only the constitutionally protected right to own guns, but also free speech...

"They're infringing on your Second Amendment rights by taking away your First Amendment rights," foundation spokesperson Mark Oliva said...

To the suggestion that advertising is geared toward kids or the militia-minded, Oliva, of the shooting sports group, pointed out that no one under 18 may own a gun and a minor's access to one must be controlled by a parent. Advertising a gun's suitability for use in combat makes sense because serious gun owners want the most rugged available, he said.

Oliva and other critics mocked the proposal's "reasonable controls" standard, defined as "reasonable procedures, safeguards and business practices." Democrats who have a poor track record winning legislation to stop gun violence are simply asking the courts for help, said Todd Vandermyde, a former lobbyist in Springfield for gun-rights groups.



"They're coming in the back door, attempting to bankrupt the industry by running up their legal bills while they're playing with free money," Vandermyde said.

*[Editor's note: This is just a thinly-veiled attempt to allow states like Illinois to bankrupt gun makers and sellers... and as an added bonus, if they can use the new law to go after those who don't share their world view of civilian disarmament, that's all the better.]*

### The Remington 870: Now BANNED in Illinois

The Remington 870: Simple, dependable, effective, versatile, plentiful and reasonably priced. Perhaps even venerable.

As such, the 870 has become America's favorite shotgun. With production beginning in 1950, and proceeding into the millions, it has been handed down from generation to generation – many given as a shotgun for the young hunter.

Thanks in part to television and movies, the sound of the racking shotgun to draw the listener's attention is known world-wide. It is a sound that says, "Don't twitch a whisker...or anything else".

The likelihood of surviving a blast from the business end of a shotgun loaded with buckshot or slugs is minimal at best, thus making it an excellent form of protection without being discharged.

We are now told that the 870 and hundreds of other popular "personal protection devices" used for self-defense are now banned in Illinois.

The 870 is not a semi-automatic firearm, yet is on

the banned list because its magazine is "readily convertible" to hold over ten rounds.

What kind of horsepuckey is that? Everything can be modified. Ever watch *MacGyver*?

As most of us already know, the 870 and its kin are not the weapons of choice of mass murderers. So what gives?

As I'm forced to consider the reasoning behind this law, I can only think of one thing this law can accomplish: disarming the Illinois citizen, a provision necessary to control the Illinois citizen should the government desire to mistreat the citizens.

According to the law, those of us who possess "banned weapons" are now forced to register them by December 31, 2023 or move them out of state which then deprives the owner of said firearms, of the protection and usefulness which they can provide.

## Forged in Fire

The 2nd Amendment: we mostly think about it as firearms, but in the American Revolution, swords were also important weapons. American cavalymen carried long sabers, frequently as shock troops who charged at great speeds. Infantrymen were often armed with a short sword measuring around 25 inches in length, known as a "hanger" that served as a secondary weapon to the musket. **As a result, swords were plentiful when the Constitution was written.**

Today, probably no one would choose a sword over a firearm for most self-defense situations they might face, but it is incumbent that we force the opponents of our God-given right of self-defense to defend their entire foolish and naïve would-be bans or limitations on our right. We must demand to own other self-defense weapons, including swords.



You may not have contemplated swords since you were a wee tike running around with a small wooden one playing pirate, so let's quickly look at some characteristics of today's long blades. Swords changed over the last several millennia, primarily because the character and conduct of warfare (the type of enemy – such as mounted versus dismounted and what formations they used; tactics; metallurgy; the armor worn by your opponent, and so forth) constantly changes.

Today, the character and conduct of your fight could be combat inside your home, or outside. The guy probably trying to kill you will likely have neither a sword of his own, nor wearing armor, most-likely be a single opponent, or at most a small group, but not part of a large, packed formation such as a Greek phalanx! If outside your domicile, if he has a gun and you don't, you have a problem – unless you can strike first, while inside the house, you know the terrain which is a huge advantage. But again, this is not an argument to trade in your Browning 12 gauge for a Renaissance-era Zweihänder (two-handed) long sword – not that a blow from the latter won't disable an attacker, but swinging that bad boy inside and you'll find out what collateral damage is!

So here are some general types of swords you could own, and you aren't limited to just one! Just like with firearms, you have to

practice, practice, practice: you and two other buddies just can't saunter out in the back yard one afternoon, swinging your swords expecting to become the Three Musketeers. And these are not wood or dull; they can will cut you if you don't know what you're doing.

**Slasher.** The Japanese Katana (sometimes called a Samurai sword in modern culture) is one of the best, if not the best, slashing swords available due to the stability, flexibility, and precision provided by the handle and soft curvature of its single-edge blade. The downside? You're looking at years to get good with it – which is true for many swords! – and it's pretty long for inside-the-house use!



**Cutter/Chopper.** Cutting strikes are different from slashing, as they look to sever body parts (sword-fighting is bloody; get used to it). The best cutter/choppers have broad, sturdy, blades with a forward center of gravity that focus all of their power on the single-edge blade. A Chinese Dadao is a good choice.

**Thruster.** While it can slash, the whole point of the thruster is to bury the blade's point deep into the chest/guts of the other guy. Nothing did that better, for a longer period of time, than the Roman Gladius, the sword of the Roman legion. Blade length is about 20 inches; inside the house is doable, because you aren't swinging it, you're stabbing. Remember! Since the blade can be 2.6" in width, the wounds are often fatal.

**Jack of All Trades.** The above three types were designed for fighting, but a machete can serve many other purposes, cutting bushes, small trees, ropes, and even digging the ground when necessary, and be a slasher if need be. They love getting dirty.



**Stealth.** Cane Swords provide you with that crucial two seconds of getting it into the fight – because your attacker has probably never encountered one before. But laws concerning them are so nebulous, so often misquoted, that while I feel confident that used inside your house you might be OK, outside – well, we must push lawmakers allow them for self-defense anywhere. Cold Steel makes several economic models, while Burger

## Michigan's new 'hate crime' law opens door to felony arrests of armed persons causing others to 'feel intimidated'

(GSL) - Michigan's charming Governor Gretchen Whitmer signed into law a new "hate crime" law weeks ago. The new law makes it a felony offense to "intimidate" another based upon the perceived feelings of the victim.

While the law supposedly protects transgendered individuals against malicious "mis-gendering," it could very easily be levelled against others. For example, gun owners and gun rights activists open carrying could easily cause someone who fears guns to "feel" intimidated at the sight of a firearm, especially at a political rally.

## Pritzker concedes gun ban will likely be struck down

(The Center Square) - Illinois Gov. J.B. Pritzker appeared to concede that his and Democratic lawmakers' ban on a wide variety of semi-automatic handguns and rifles has a less than 50-50 chance of surviving in the federal court system.

## Gun rights group files federal lawsuit against firearm manufacturer liability measure signed by Gov. J.B. Pritzker over weekend

(Chicago Tribune) - A federal lawsuit filed Monday aims to stop the enforcement of a measure signed into law by Gov. J.B. Pritzker two days ago that makes gun retailers or manufacturers subject to civil liabilities if they're found to have engaged in marketing ploys that endanger the public.

The suit was filed on behalf of the National Shooting Sports Foundation, which also is one of the main groups behind a federal lawsuit alleging that Illinois' ban on certain high-powered guns and high-capacity ammunition magazines violates the Second Amendment of the U.S. Constitution.

## Some say complying with Illinois' gun, attachments and parts registration 'impossible'

(The Center Square) - With challenges of Illinois' gun and magazine ban pending in state and federal courts, more litigation is possible, especially with the requirement certain gun parts will need to be registered.

Gun rights advocate Todd Vandermyde said registering parts is unworkable.

"For certain people, it's going to be impossible to comply," Vandermyde told WMAY. "I was cleaning off a table the other day and I started finding all kinds of parts that I forgot I had; hammers, triggers, springs."

A memo circulating online confirmed to The Center Square by Illinois State Police said additional requirements of Illinois' Protect Illinois Communities Act, the state's ban on certain semi-automatic firearms and magazines, require people with not just the banned firearms, but "assault weapons attachments," to "have provided an endorsement affidavit signed under oath to the ISP no later than Jan. 1, 2024." Noncompliance could lead to criminal penalties.

## Securing YOUR kid's school

(GSL) - For those of you with kids or grand-kids in school, the school year begins now. Here's *your* homework: evaluate your kid's school for safety and security. Sometimes school administrators aren't up to speed on best practices or aren't aware of their own security shortcomings. You can help them with that. After all, it's your kid who will benefit.

Visit the school. If you as a layperson see obvious security weak points like unlocked or propped open exterior doors during school hours, reach out and let them know about it. Locked doors are inconvenient to staff, but they save lives by slowing down attackers and buy time for a lockdown protocol's implementation.



Pay attention to the little things before school or at dismissal time, too. Aside from unsecured doors, other obvious security failings including allowing random people free access into service entrances or onto school property/playgrounds (especially if they're carrying things like backpacks, or containers that a long gun would fit inside). If you see that, contact the school administration right away to remedy these issues. Ditto if you observe any sort of suspicious behavior. Be polite and courteous, but make that call.

If the school administration isn't responsive to identified shortcomings, contact the superintendent and if that fails, visit the school board.

School shootings and mass casualty incidents are on everyone's mind. No sane school district is going to risk the negative publicity and potential liability of ignored requests for security problems to be remedied.

What's more, there may be other issues that you didn't notice. Ask questions about security and "grade" officials' responses. If they don't have a plan or haven't revisited it in years, that needs fixing. We as parents can help nudge school officials towards improving safety if it's lacking.

If your local schools don't have a school resource officer (SRO) - especially high schools and even junior highs in larger communities, take some time to advocate for one to the administrators, the school board and local city government.

By the same token, if your kid's school does have a school resource officer who isn't professional or proactive, or has one foot out the door awaiting retirement, contact the police chief and have a meeting to share your concerns.

## Posturing and double-talk from both sides on authorization for illegals to become police

(WirePoints) - One immigrant group expressly included for eligibility to become police officers under Illinois' new law are DACAs — immigrants who are here under the Deferred Action for Childhood Arrivals program.

However, the law also expressly requires applicants to be authorized under federal law to obtain, carry, purchase or otherwise possess a firearm.

But DACAs cannot possess firearms or ammunition. Federal law prohibits it. Colorado is facing the same obstacle with a law similar to Illinois' so it's trying to get a waiver or amendment to the federal law.

So, what the law gave with one hand it took away with another. It's political posturing through double-talk, stoking political and racial division.

One supposed workaround to the gun obstacle has been reported in Blue Island, where a DACA is a police recruit who would not be allowed to take his gun home, but it's hard to see how that can work out. The federal prohibition includes no exemption for police work and off-duty cops need guns.

Gov. JB Pritzker bristled this week about claims that the law allows "illegal" immigrants to become police. He said the law's "right wing" critics are "saying that we're allowing illegal, illegal immigrants is the word that they would use.... I am tired of the right wing twisting these things. They put it out on Facebook, they tell lies."

In fact, however, DACAs are illegal immigrants. They are protected from deportation for now under a deferred immigration action program, but "the program does not grant them official legal status," as Newsweek explained in a fact check. "Deferred action does not confer any lawful immigration status," according to U.S. Citizenship and Immigration Services.

And the whole deferred action program is in legal limbo. As Newsweek explained, a U.S. appellate court in October 2022 declared the program "unlawful."



DACAs are those who entered the country as minors. Perhaps you feel they deserve particular compassion and help, as I do, and think what you want about the merits of the new law, but that doesn't change the fact that DACAs are here illegally under immigration law...

It should be noted that some immigrants who clearly are not illegal are covered by the bill. Most importantly, that includes green card holders, who have permanent residency status. There are over 12 million of them in America.

It should also be noted that the new law passed with significant bipartisan support in both the House and the Senate.

## Chicago Mayor Brandon Johnson surrounds himself with 149 police bodyguards while 'Defunding the Police' for the little people

*Chicago (GSL)* - Chicago's new Mayor Brandon "Big Brain" Johnson has long advocated for defunding the police along with more gun control for law-abiding citizens. With almost two-thousand police officer positions remaining unfilled at the Chicago PD, the department is shrinking *except* for the mayor's protective detail unit.



Johnson's predecessor, Lori Lightfoot, became famous for her failed, feckless leadership that resulted in fewer police and more violent crime.

While advocating for gun control for the little people, she also gained fame for her 90-officer armed bodyguard detail.

Meanwhile, average Chicagoans had to make do with up to 29% fewer cops patrolling their neighborhoods (miraculously, Lightfoot's neighborhood saw an increase of 4%). On average, though, during Lightfoot's miserable tenure, CPD shrank by an average of 19%.

Seeing the staggering reduction in law enforcement and increased crime under Lightfoot, Mayor Johnson seems to be saying, "Hold my beer and watch this."

With crime growing in Chicago, apparently 90 cops apparently aren't enough to keep the new mayor feeling safe and secure, so Johnson has upped the protective detail by 65% to 149 officers. That's more cops than all but about ten biggest entire police agencies in the state.

In fact Big Brain Brandon's protective detail is about five times larger than the governor's.

## Armored truck robberies on the rise across Chicago area

*Chicago (WGNTV)* - Assistant Special Agent in charge of violent crimes Denaris Coleman, who has been with the FBI for nearly 20 years, says armored truck robberies are on the rise.



"It's a crime of opportunity," he said. "(It can happen) really fast. So if there is a large amount of money taken it is a quick payoff for a short amount of time."

## ATF agent robbed in Chicago on the Mag Mile

*Chicago (CWB Chicago)* — An off-duty federal agent is among the latest victims of Chicago's ubiquitous street robbery crews...

On the Mag Mile, a 33-year-old man who identified himself as a Bureau of Alcohol, Tobacco, Firearms, and Explosives (ATF) agent was robbed at gunpoint in the 900 block of North Michigan around 2:22 a.m.

He told police that two men got out of a dark SUV with handguns and took his valuables. They tossed his badge on the ground before fleeing westbound on Delaware, the man reported.

"The teen takeover on Roosevelt Road was not a teen takeover. It was looting. It was mob action. It is in the ordinance, Mr. Mayor. Look it up. It's also in the state statute. I would hope you'd be familiar with that," Catanzara said.

# The Atlantic: Eureka! We found a gun control law from 1619!

(GSL) - The Atlantic squealed with delight at finding what might have been the very first gun control law in the American colonies, from all the way back in 1619. Writing about it in "America's Original Gun Control" on their website, they can barely contain their glee.

The reason for their giddiness is that under the Bruen Supreme Court decision last summer, the only gun control laws permitted today are analogues of those commonly in place in Colonial times - specifically 1791 and before.

## America's Original Gun Control

In the summer of 1619, the leaders of the fledgling Jamestown colony came together as the first general assembly to enact "just Laws for the happy guiding and governing of the people there inhabiting." Consisting of the governor, Sir George Yeardley; his four councillors; and 22 elected "burgesses," or representatives, the group approved more than 30 measures. Among them was the nation's first gun law:

*That no man do sell or give any Indians any piece, shot, or powder, or any other arms offensive or defensive, upon pain of being held a traitor to the colony and of being hanged as soon as the fact is proved, without all redemption.*

After that early example of gun control came many more laws placing restrictions on the ownership and use of firearms. If guns have always been part of American society, so have gun laws.

So there you have it. The Atlantic proudly points to what may be the first Colonial period law placed on the books. A law that kept Native Americans disarmed based upon their

race. While the first racist gun control law may have been aimed at keeping Indians disarmed, no doubt plenty more soon followed targeting blacks.

Once more, demonstrating gun control's racist roots. The Atlantic simply turns a blind eye at the racist roots of gun control.

And racist gun control has flowed all the way through history to modern times. The FOID cards Illinoisans carry today came about as a direct result of Mayor Richard Daley's bid to keep guns away from blacks in Chicago during the unrest in 1968.

The original purpose of gun control: to protect the Klansmen from their victims.

# America loses a treasure RIP Vince Speranza (1925-2023)

Vince Speranza, a World War II American hero and a national treasure, passed away August 2nd. He served with great honor and came home to teach history to some very lucky kids in Central Illinois before retiring. Among his favorite things to do was to speak of America's greatness to audiences young and old.

He spoke at least three times at GSL meetings, dazzling audiences each time with presentations easily among our very best. What an amazing man.

**Vincent Speranza's legacy**  
(Legacy.com) - Vincent Speranza was a paratrooper during World War II who carried beer in his helmet for a wounded friend during the Battle of the Bulge.

Born in the Hell's Kitchen neighborhood of New York City to a large Italian family who suffered through the Great Depression, Speranza enlisted in the Army right out of high school. He became part of the then-new Parachute Infantry and was assigned to the 101st Airborne Division. Speranza first saw combat in one of the most notable campaigns of the European Theater: the siege of Bastogne and the Battle of the Bulge.

During the battle, while checking on wounded comrades, one soldier asked him for a drink. Speranza searched the rubble of nearby buildings, many bombed beyond recognition, and found a working beer tap. Without anything else to use, he filled his helmet with beer and brought it back. His friend was grateful, as were others around him, so Speranza went back for more. Before long, the story became legend.

Speranza would go on to be a history

teacher and was largely oblivious to his fame. However, his story lived on in Bastogne, leading to a local brewery creating Airborne Beer in his honor, served in small ceramic helmets. In later years, he would participate in many events in Europe honoring war anniversaries, and he even made one last parachute jump at the age of 98.

We should learn from the experiences of others and who better to ask about such lessons than retired county sheriff Jim Wilson, who saw and resolved countless instructive situations during his career when called to investigate after homes were broken into. With summer heat tempting folks to open windows and doors to cool down their homes, I thought members would benefit from a reminder that it's a lot better to prevent a break-in

than it is to have a midnight encounter with a burglar, so I asked Wilson for tips on how to increase safety at home.

**eJournal:** I appreciate the chance to pick your brain about ways to avoid being victims of crime inside our own homes.

**Wilson:** I think there are two real important things people need to realize. The first is how very dynamic home invasions can be; how quickly they occur. If a person is not prepared, has not done any home improvement or any planning, the door flies open, and those people are in their face immediately and they only have a matter of seconds to react in any manner.

The second thing I think is really important and that people don't realize is that prevention of a home inva-

sion is a layered thing. We can't point at any one thing and say, "If only you had better locks..." It is lighting; it is locks; it is security video; it is having a little dog that will bark to let you know that something is going on. A lot of people don't realize the importance of having a combination of prevention...

# Wanted poster shared for man suspected in Emma Shafer's murder in Springfield

Springfield, IL (WAND) - The US Marshals Service has released a wanted poster for the man suspected of killing Emma Shafer.

Shafer, 24, of Springfield, was stabbed to death July 11.

Police said, Sangamon County Dispatch took a call from a woman in Bethalto, Illinois around 11:30 p.m. She said her brother had possibly injured his girlfriend who lives in Springfield.

Officers responded to the 1000 block of S. 8th Street to check on the welfare of the female resident.



Upon arrival, police found Shafer dead with multiple stab wounds.

On July 12, Sangamon County State's Attorney Dan Wright issued an arrest warrant for Gabriel P. Calixto, 25, for three counts of first-degree murder and aggravated domestic battery with a bond amount of \$3,000,000.

## Prepping for the Worst 2.0

(Legal Insurrection) - It's that time of year. Summer. When I have too much time on my hands and my mind wanders to thinking about what could go wrong. I am, by nature, a 'worst case scenario' person, so time to think is not a good thing.

Thus, it was early August 2021, when I first wrote Prepping for the Worst:

*I don't mean to alarm anyone, and I'm not panicked. I'm just concerned, and thinking the unthinkable....*

*The pandemic made clear we live on a thin line that can be disrupted. It's not unthinkable that our key systems — the electric grid, natural gas supply, gasoline — could fail or be taken down by hacking.*

*Add to it a federal government bent on weakening the nation as a matter of ideology, and the once-unthinkable is thinkable.*

*So all in all, I no longer view "preppers" as crazy. Maybe they were right, just early. Better early than late.*

*I don't plan to be late.*

My prepping really hasn't been for the "worst case scenario" — it's been for the most likely bad scenario, mostly focused on energy grids on which we depend, and food. (I know, readers always tell me to focus on home defense, but that's not something we talk about...)

I'm not alone. An estimated 74 million Americans are preparing for some level of disaster:

*Prepping is big business, with roughly a third (29%) of the adult population in the US dropping a collective \$11 billion in the last 12 months on emergency preparedness, according to a Finder survey.*

*The most commonly bought survivalist items are literally the basics: food and water. About one in five (21%) Americans says they bought staples...*

Of course, there's the other non-natural disaster to worry about — government and 'woke' corporations. Prepping for that needs to be part of a plan — what if like in Canada your access to your bank accounts and all your financial resources were cut off?

## International expert: Likely Chinese saboteurs flowing across America's borders

(Gatestone Institute via Epoch Times) - There is now a Chinese invasion of the U.S. homeland.

"The jungle is filled with Chinese marching to America," said war correspondent Michael Yon to Gatestone.



There is no question that China's PLA is inserting saboteurs through Mexico. "At the Darien Gap, I have seen countless packs of Chinese males of military age, unattached to family groups, and pretending not to understand English," said Yon, the war correspondent. "They were all headed to the American border."

"Normally in groups of five to fifteen, they typically emerge from the Darien Gap and spend one night in the U.S.-funded San Vicente Camp, or next door in the Tonosi Hotel, before boarding luxury buses for the trip up Highway 1 toward Costa Rica," Yon reports...

How many of the PLA fighters have slipped into the United States this way? Some estimate 5,000, others 10,000. Those numbers sound high, but whatever the actual figure, more are coming.

These are China's shock troops. The concern is that, on the first day of war in Asia they will take down America's power lines, poison water reservoirs, assassinate officials, start wildfires, spread pathogens, and create terror by bombing shopping malls and supermarkets.

The saboteurs will almost certainly attack American military bases. China has already been probing sensitive installations. Chinese agents posing as tourists have, for instance, intruded into bases, including the Army's Fort Wainwright in Fairbanks, Alaska. There, the suspected Chinese agents drove past a base gate and were later apprehended with a drone inside their car.

Texas - My wife and I were getting the kiddos ready for bed when we heard a bunch of banging on our front door. I handed the baby off to her and ran downstairs to see what was going on.

When I popped my head outside, one of our local police officers was yelling about a big fire. Glancing over, I saw my neighbor's house fully involved.

I immediately turned around and yelled, "Get the kids in the van and get out of the house, now!"

From there, I ran into the garage and turned on the van and opened all the doors for her. Next, I grabbed the garden house and ran it to the west corner of my house. There I saw my house starting to smoke and the paint bubbling from the radiant heat.

I put the water hose on it and started covering my house as best as one can from a raging inferno 40 feet away. Maybe 45 seconds had elapsed and I saw my wife pull the van out with my children and waved at her to leave with them. A neighbor came and asked what he could do. Told him there was another hose in the back yard and to go get it on the fence line. He did.

That was the hottest thing I've ever felt. I had to keep spraying myself down to stay in the fight. It took at least three more minutes for the fire department to show up and get a line in my side.

By this point the neighbor's



place was a total loss. I stayed on that corner as long as I could stand it. Got a few 1st degree burns here and there before I pulled out and went to my fence line in the back yard. There, I relieved the neighbor and that's where I stayed for the next two hours.

I will be forever grateful for the work my local PD/FD put into saving my house.

We will be replacing all the siding and windows on the western side and repainting. No smoke or water intrusion.

We are incredibly fortunate.

frame lost its integrity.

We had a generalized plan and it worked. I'm sharing all of this to encourage all of you to make sure that you have a plan.

The whole incident happened very fast and didn't give a damn about us. Fortunately a good plan mitigates disaster. We will be refining ours in several places. As it was, my wife got our four children ages 6 and under, as well as our dog and cat out of the house in 45 seconds. She did a great job under a lot of stress.

Have a plan folks. Know it. Refine it. But most importantly have one.

Hope isn't a plan and panic only compounds disaster.

## Black bear intruder shot dead in man's living room

Luther, MT (AP) — A Montana couple got a late-night wakeup call from a barking dog alerting them that a black bear had broken into their living room before the man shot and killed the animal with a handgun.

The confrontation with the large bruin happened in the rural community of Luther at the base of the rugged Beartooth Mountains, where Thomas Bolkcom and fiancée Seeley Oblander live with their two dogs.

After staying up late the night before — the couple was scheduled to fly that morning to Arizona for their bachelor and bachelorette parties — they awakened about 3 a.m. to their dog Maizey barking furiously upstairs from the house's main floor, Oblander said.

Bolkcom, 27, a commercial painter and elk hunter, went to investigate and tried to coax the lab-pit bull mix downstairs when he turned around "and there's this black bear standing in the living room five feet away," Oblander said.

Wearing only a t-shirt and underwear, Bolkcom ran back downstairs, got a handgun and returned to the living room where he shot the bear. It ran into another room so he shot the bear several more times.

The animal had broken in through a screened window. Oblander, 26, said it had no other way out and was between Bolkcom and the door.

"I never thought there would be a bear in our house, so that was quite the wakeup

call at three in the morning," she said. "I just stayed downstairs with the dogs, trying to help keep them out of the way and let Tom handle it. He did a great job..."



Last month near West Yellowstone, Montana, a grizzly bear killed a 48-year-old Kansas woman while she was running or hiking on a trail west of Yellowstone National Park.

## Biden regime defunding schools offering hunting and archery programs

(Forbes) - As America faces a storm of geopolitical threats, endures a flood of fentanyl streaming across a largely open southern border—now killing some 100,000 Americans annually, wrestles with soaring inflation, and experiences unmitigated crime in many of our largest cities, the Biden Administration's recent move to defund schools that offer hunter safety and archery programs has many ques-

tioning President Biden's priorities. The administration seems to be misfiring on many cylinders and, not surprisingly, Joe Biden's approval rating continues to plummet. "It's right up there with jock itch," recently quipped Senator John Kennedy.

## Tennessee kook arrested after school massacre thwarted

Memphis (The Reload) - An assailant has been charged, and a coordinated safety plan has been credited with saving students' lives at a Jewish school in Memphis, Tennessee.

Local law enforcement announced charges on Wednesday night against a suspect over an attempted shooting at the Margolin Hebrew Academy. The Tennessee Bureau of Investigation said they have charged a 33-year-old man from Stanton, Tennessee, with five different charges related to the attack on the school and later shootout with

police that left him hospitalized. Memphis Police and the Secure Community Network (SCN), which helped stop the attack and catch the suspect, touted the security measures at the school for effectively stopping whatever the gunman had planned.

"The suspect did try to enter the building armed with a gun," Memphis Police Assistant Chief Don Crowe said during a Monday press conference. "When he could not gain entry, he fired shots outside the school. Thankfully that school had a great safety procedure and process in place and avoided anyone being harmed or injured at the scene."

"We are grateful that everyone is safe and the offender is no longer a threat to the community," Amanda Braswell, SCN's Regional Security Director, said in a statement on Wednesday. "This resolution was not an accident or luck, but the result of a highly coordinated, comprehensive, best practice security effort that we have been working toward since the Memphis Jewish Federation and Secure Community Network (SCN) first partnered in 2018."

Officers said two armed men forced their way into a home and began searching. The elderly resident was the only one at the home when the intruders broke in.

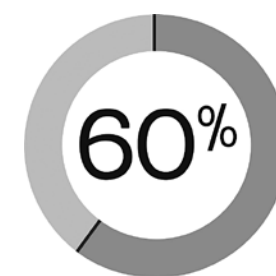

## Man exonerated after shooting bully who attacked him

(GSL) - On our website, we reported on a January 2023 defensive gun use from West Pueblo, Colorado. The "victim" in the incident contacted us after seeing our post and sent more information about what happened, and he even shared more video. We shared all that on our website. While we can't bring you the video here in *GunNews*, we can share some details from the incident.



Jack H. (pictured above on the receiving end of a throat strike) was riding in the passenger seat of a "crappy little Honda" with \$4,000 rims on it. A very large man (pictured, left) walked by grinning at the rims.

An innocent comment asking the big guy if he liked the rims set the man off as if Jack had questioned the moral character of the big guy's mother. An incensed Mr. Big Guy got into the face of Jack, trying to bait him to fight. Jack found himself effectively trapped in the open door.

Jack stood his ground, not saying a word. When he didn't cower in the face of the larger man's threats and taunts, that seemed to set off the bully even more. He then struck Jack in the throat.

Jack responded by accessing his firearm from appendix carry. Seeing that, the big guy tried to grab for the gun but he was unsuccessful. He did successfully soak up multiple rounds AND he managed to master the art of unassisted human flight, briefly, while running away in a really big hurry before collapsing.

Jack tells us he is a big fan of the Active Self Protection *YouTube* page and practices some of the techniques he's seen there. One, firing from compressed high ready (in this case while laying on his back across the console inside the car) allowed him to retain the gun and shoot his attacker.

The slide struck him in the chest for those first couple of shots before he could extend. "I had bruises on my chest for a month," Jack wrote in his email.

Fortunately the cops responded quickly because the dead man's brother showed up about five minutes later with an AR-15. About five deputies convinced the brother not to do anything stupid.

In the end, the local prosecutor ruled the case self-defense.

### New challenges will make us all stronger

That which doesn't kill us makes us stronger.

As I mentioned at our meetings, there's no scenario I see where the courts give us relief to Governor Pritzker's new Gun Ban before the registration component kicks in on October 1st. Yes, we will ultimately win, but probably not before 2024 at the soonest.

We're likely not going to challenge it in court for two huge reasons: First, no gun registration scheme has been successfully challenged in any court in America before. Secondly, we would as likely as not end up in front of the same three-judge panel at the Seventh Circuit Court of Appeals.

What should do you do?

A continuum of options exist for each of us, just as there's a continuum of options for how to handle an armed robbery you notice as you emerge from the restroom of a convenience store. No options are particularly good, and everyone's going to handle it a little differently.

What *can* you do? First, inform your friends, neighbors and family about the new law and

its provisions. Let them know about how private gun sales must be registered. Advise them to determine if their guns are covered by the ban and as such must be registered in order to keep them. At the same time, you might also coax them to make sure they vote in 2024, too.

Probably between a quarter and a half of Illinois gun owners are utterly unaware of this new law's onerous provisions and may become felons unwittingly. That's a million or more gun owners out of the 2.4M FOID holders in our state.

Figure out what you're going to do with your impacted firearms. Are you going to move them out of state, store them with an FFL as part of them providing gunsmithing services, or maybe sell them (to an out-of-stater)? Maybe you'll take them out on a boating adventure. Or maybe you'll rent a post-hole digger. Others will opt for the "Molon Labe" option.

No need to decide prematurely. You've got five months to weigh your options. Regardless of which you choose, help educate your fellow Land of Lincoln residents on this new law and its provisions.

### Illinois vs. Florida

So we just returned from some time in Florida, specifically Ft. Walton Beach. We saw the sights and had a great time on the Emerald Coast, named for its beautiful green water and white sand.

Some call it the Redneck Riviera. No doubt some in "civilized" Chicago look down their nose at the rednecks on the Emerald Coast. At the same time these cultured Chicago residents don't think twice of the complimentary sound of gunfire in the distance and intrusive police checkpoints at the entrances of *their* beaches.

not only felt safe but we were safe. Nobody got shot, stabbed or killed in Ft. Walton Beach or the bucolic redneck communities near us during our week-plus vacation. Meanwhile on just one of those days, the cosmopolitan and worldly folks in Chicago reported 30 people shot, four fatally.

Serious crime in most of Florida is low. No robbery crews roaring up in stolen cars sticking guns in your face or mobs of hooligans looting stores and trashing private property. People weren't getting shot or killed in road rage incidents outside of famous landmarks - or anywhere else for that matter.

Then again, in Florida, they put violent people behind bars. They don't release people with "affordable" bails and ankle bracelets. Not only that but an average of one in five Floridians packs heat and shoots back at criminals. We surely had ours.

The difference between Florida and Illinois - specifically Chicago - remains as stark as night and day. Remember the woman who stabbed a Chicago Transit Authority employee in the throat a couple of years ago and got charged with a misdemeanor? The same woman later moved to Florida and stabbed another person. Maybe the stabby former Chicago resident thought she would catch another misdemeanor charge. Now she's a long-term guest of Florida and won't be poking anyone else.

Ron DeSantis didn't bring violent crime rates down to 50-year lows in the Sunshine State all by himself. But unlike Illinois' governor and Chicago's mayor, Florida's Gov. DeSantis saves most of his compassion for the law-abiding as opposed to the criminals.

### Police body cams save lives just like body armor

The Illinois Newsroom [Editor: Government-funded media] has a story captioned: "*Marchers protest killings of two black men in Rantoul*". The focus of the story is a July 29th protest condemning police for the recent shooting deaths of two black men.

## Should I stay... or Should I go now?

(GSL) - Lyrics from a *Clash* tune might seem out of place in a journal like *Gun-News*, but if you have experienced depression, suicidal thoughts, or other mental health breakdowns please continue reading a little longer.

19.86% of adults in America experience mental illness of one form or another, or roughly 50 million people. About a quarter of those folks experience severe mental illness. It's not a lot of fun, I'll tell you.

So what's that mean? It means if you suffer from mental illness you're not alone.

However in the Land of Lincoln, seeking out treatment for anything except mild depression carries the risk of the loss of your FOID card and your carry license. That's a big deal for those of us who rely on our firearms to defend ourselves and our families from the threat of the ever-growing criminal element.

I can also confirm first-hand that getting them back (as I've done more than once) has become more and more frustrating, expensive and time-consuming. Today, I've been told that the appeals process is clogged with thousands of applicants for each staffer handling them at ISP headquarters.

Some folks like me have experienced debilitating depression in a cyclical pattern. At times I've needed the help of profes-

sionals and I've experienced "treatment" at all different levels. With that knowledge, I'll share some strategies to help readers navigate the minefield of mental health treatment. And I'll cut to the core of the decision-making process that many of us eventually face.



Hence, "Should I stay (at home) or should I go (seek treatment)?"

First, make a plan. For those with a spouse, an honest discussion of a "best plan" may or may not be all-inclusive.

**Should you seek out help of a good friend (who can keep his/her mouth shut)?** YES! Talking with one or more friends who understand what you're dealing

with or going through can help a lot.

**Should you see your family doctor?** YES! They can help you understand the best way to treat your illness.

**Should you see a psychiatrist for a consultation?** WHY NOT? They are specifically trained relative to the best use of medications to treat your particular mental illness / depression. Your primary care physician can help with a referral.

**Should you see a therapist?** YES. I've done this with mixed results but it may be worth a try, especially as they have better availability than psychiatrists. Bear in mind that a therapist can't prescribe medication.

Seeing your doctor, a psychiatrist or a therapist on an out-patient basis will probably not trigger a loss of your FOID card with one exception: as "mandated reporters," they are mandated to report when they see someone as a "clear and present danger" to themselves (self-harm) or others.

Those reports will get you branded with the "mentally ill" label and your FOID revoked. In today's world, that means you can pretty much kiss your guns goodbye for years, thousands of dollars in expenses and a whole new helping of frustration.

**Should you call a suicide hotline?** DEPENDS. Most of these will come with a FOID revocation as the people taking the calls are mandated reporters. You might try the VA's crisis line (988, then press '1') as they may not be state mandated reporters as federal employees.

**Should you go to the hospital?** NO,

not unless you feel you are an immediate danger to yourself or others. You *will* lose your FOID card on this one. Even worse, in my experience I wasn't impressed by the treatment. I only felt better after I returned home. Then the ISP revocation letter came two days later.

**Serious, chronic depression issues...** If your depression or other mental health issue is negatively affecting your quality of life then it is not the time to drag your feet. Particularly if it's chronic as opposed to intermittent or acute. Seek help and implement your plan.

It took me 25 years to seek out medication before I finally did it. I now wish I'd acted sooner. Don't let the possibility of seeing you doctor (and/or a psychiatrist) feel like a compromise. You are facing a condition that's treatable. The sooner you act, the sooner you will recover.


At the same time, if you're in a very dark place where you're seriously contemplating giving up and checking out, reach out to a friend.

If you're ready to take your life to stop the pain, seek help. Talk to a friend until you can talk with your doctor or a therapist. Reach out and make that call. **At the same time if you have a friend who is in crisis mode** and they have guns, ask if you can hold onto those guns for a few days or weeks until they're better.


In most cases, suicide is a permanent solution to a very temporary problem. There are treatments for depression. If it's negatively impacting your life, talk with your doctor.

Champaign County. Jeremiah Brandon and his 14-year-old son Hunter discussed their South African safari from this past June, and they brought photos, too!

Safari trips to Africa are surprisingly affordable relatively speaking. In fact, they are cheaper than trips out west domestically. And unlike American hunting trips out west, hunting in Africa isn't "if" you harvest animals but "how many."

It was an experience they'll each treasure for a lifetime and they shared it with the audience.

The raved about the trip and after taking all the trophy animals they wanted, they spent a couple of hundred bucks to go deep sea fishing one day. Another day they enjoyed a local festival. They likened it to small town America. It was very different in Johannesburg though.

Danville. Joe Sharp dazzled the audience and showed what decades of Martial Arts training will get you.

Sharp, a retired police officer with three deadly force incidents in his career, advised using situational awareness and conflict avoidance. It makes life a lot easier. "If they're just going to take your money, let them have it."

If they want more, like your body, then it's time to fight. Don't be afraid to use violence.

He showed a couple of simple techniques to the audience, starting with strategies to counter grabs from bad guys. They involved helping the bad guy hyper-extend his elbow the wrong direction.



Right hand grabs top of slide and pulls down and right. The left hand goes under the barrel and lifts and pushes left.

The fun really started when Joe showed some basic pistol disarms which aren't for novices or the faint of heart. They will result in bad things for you on the business end of the gun if you don't move off the bore's axis as your first part of disarming. Then, if all goes well, you'll either have the bad guy shooting himself or removing his trigger finger. Either way you'll have control of the gun.

Joe also showed some counter-knife strategies against a lunging attack which involved catching the inside of the wrist with one hand and vigorously striking the back of the hand with your other hand. That will cause the bad guy's grip to involuntarily open, sending the knife flying.

share of rogue judges in our state. However, don't lose hope as gun rights folks have struck down more gun control schemes nationwide in the last year (citing *Bruen*, in particular) than the total number of laws tossed out by the courts in the 40+ years before it.



**What else is on the radar?** I'm no fan of the new law that criminalizes "marketing" of firearms to youth, "militants" or those inclined to break the law. I just don't trust the Pritzker administration not to use the law against political adversaries like Guns Save Life.

"Marketing" can mean a lot of things and no doubt they consider us "militants" in their fragile minds. With that in mind, I signed up for iDrive to ensure continuity of GSL should Pritzker's goons show up at my house and take all of my computer gear. (I started with Dropbox but bailed on their lousy user interface.)

**Radar 2.0:** The "No Cash Bail" law was upheld by the state's high court and they set September 18th as the date for implementation. Folks, two things you should do before then: 1) get concealed carry "insurance" of some sort and 2) clean and inspect your guns.

County jails will be releasing 50-75% of those held on pre-trial detention on that date. Protect yourself and your family. It's your duty. After all, people love you and are counting on you.

For those sheriffs trying to figure out what to do with them, I stand by my earlier suggestion to rent a bus and drop them off out front of the home of the nearest politician who voted for the SAFE-T Act.

## New York's 'Raise the Age' law helping drive chaos, mayhem and violent crime

*New York City (PJ Media)* - New York State was inspired to raise the age for a person to be criminally liable under the law to age 18 back in 2018. It's all the rage in progressive jurisdictions to treat violent, juvenile offenders like Father Flanagan's kids ("There's no such thing as a bad boy").

"The purpose of the Raise the Age law," according to a juvenile justice advocacy website, "was to ensure that more youth would benefit from the Family Court's rehabilitative focus and sealed records policies. The law also barred all minors from adult correctional settings, with few exceptions."

More than "a few," says Albany District Attorney David Soares. He's been calling on Gov. Kathy Hochul and the state legislature to repeal the "Raise the Age" law because of the chaos and mayhem it has caused.

Soares knows that those violent man-children are totally aware that they can commit

almost any kind of violent crime and be tried in juvenile court. Where a young offender may have gotten 7 years for a convenience store holdup if tried as an adult, Family Court would be far more lenient and may not even send the offender to prison.

And because the threat of prison has been all but removed, the recidivism rate among these kids is astronomical.



Family Court wasn't designed to "deal with violent, super, super, violent youth," Soares explains. These are not "children" in any way except age. They are grown-up violent predators who are smart enough to figure out the angles of the Raise the Age law and avoid serious consequences for their actions.

Hot Air's Jazz Shaw nails it: "This falls under the same rule that we've discussed here so many times but liberal Democrats remain deaf to. If you remove the negative incentive for committing crimes, the result will be more of those types of crimes. It applies to retail looting and it applies to attempted homicide."

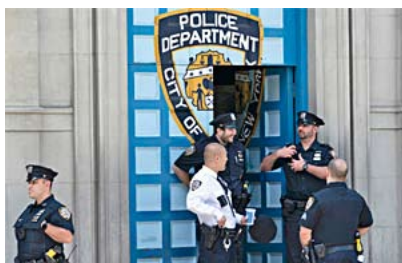
